### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of THL Management Holdings, LP 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### (1) Description of the Plan

The following description of the THL Management Holdings, LP 401(k) Plan (the Plan) provides only general information. Participants of the Plan should refer to the plan document for a more complete description of the Plan's provisions.

##### **(a) General**

The Plan is a defined contribution retirement and savings plan covering substantially all employees of Thomas H. Lee Management Company, LLC (the Company and Plan Sponsor). Employees are eligible to participate in the Plan upon employment and attaining age 21 years. Summer interns are excluded from participation in the Plan. The Plan is subject to the provisions of the Internal Revenue Code of 1986 (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA), both as amended. The Plan is administered by the 401(k) Committee of the Plan. The 401(k) Committee (the Committee) is responsible for oversight of the Plan. In addition, the Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### **(b) Contributions**

The Plan provides that eligible employees electing to become participants can contribute to the Plan through payroll deferrals on up to 90% of their base compensation (as defined in the Plan), subject to the Code limitations which was \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 in 2024. In certain cases, up to 100% of compensation may be deferred, including cash bonus compensation. The Plan also allows after tax (Roth) deferrals by participants. Participants may also contribute amounts representing distributions from other qualified plans subject to certain limitations, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for discretionary matching contributions. The total amount of any matching contribution (Employer Contribution) is determined annually by the Company. For the 2024 Plan year, the Company made a matching contribution of 100% of eligible participant contributions with a maximum annual matching contribution of \$3,000. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### **(c) Participant Accounts**

Each participant's account is credited with the participant's contribution, and an allocation of the Company's matching contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **(d) Investment Alternatives**

Each participant is responsible for determining how his or her individual account balance is invested. Participants may change their investment options at any time throughout the year via direct phone or online access to Fidelity Management Trust Company, the trustee and third-party administrator of the Plan.

##### **(e) Vesting**

All Contributions and earnings thereon are fully vested at all times.

##### *(f) Benefits*

On termination of employment due to death, disability, retirement, or attainment of age 59½, a participant or participant's beneficiary may elect to receive either a lump sum amount equal to the value of the participant's account balance, or partial withdrawals. In certain circumstances, participants may also make hardship withdrawals. A participant who terminates employment with a vested account balance of less than \$1,000 receives a lump sum distribution.

##### *(g) Notes Receivable From Participants*

Notes receivable consist of loans to participants who may borrow up to the lesser of \$50,000 or one half of their vested interest in the Plan. The notes are generally repaid within five years in equal installments of principal and interest each pay period. Loans related to the purchase of the participant's primary residence may be repaid within a period of up to 10 years in equal installments of principal and interest. The interest rate on loans to participants is set at the prime lending rate as published by The Wall Street Journal on the date the loan is approved. The notes receivable balances of \$109,832 and \$115,261 as of December 31, 2024 and 2023, respectively, are recorded at amortized cost, which is unpaid principal plus accrued interest.

##### *(h) Termination*

The Company anticipates that the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

##### *(i) Administrative Expenses*

For the year ended December 31, 2024, the Company paid substantially all administrative expenses incurred by the Plan. Certain transaction fees, such as loan set up fees and overnight check fees, are charged directly to participant accounts and are reported on the statement of changes in net assets available for benefits as administrative expenses.

#### (2) Summary of Significant Accounting Policies

##### *(a) Basis of Accounting*

The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (U.S. GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to U.S. GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (ASC). The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *(b) Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

***(b) Investment Valuation and Income Recognition (Continued)***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***(c) Payment of Benefits***

Benefits are recorded when paid.

***(d) Expenses***

Administrative expenses of the Plan are generally paid by the Company.

***(e) Income Taxes***

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

***(f) Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***(g) Other Income***

The Plan received a total of \$0 in the year ended December 31, 2024, through Fidelity Management Trust Company's Revenue Credit Program (RCP), which may be used to pay for Plan expenses or allocated to participant accounts. For the year ended December 31, 2024, \$0 was used to pay for Plan expenses. In addition, the Plan saw an increase in the account of \$6,655 due to dividend reinvestment and market activity. The balance of the RCP account and ERISA credit account at December 31, 2024 and 2023 was \$137,298 and \$130,643, respectively.

The trustee also certified to the completeness and accuracy of \$5,861,737 in net appreciation in fair value of investments, \$1,943,035 of interest and dividend income, and \$11,332 of interest income related to notes receivable from participants for the year ended December 31, 2024.

#### (4) Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies:** Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end. Registered investment companies are made up of mutual funds and money market funds whose fair values are based on quoted prices and are therefore classified in Level 1 of the fair value hierarchy.

**Common/collective trusts:** Investments in the stable value portfolio are stated at NAV as reported by the investment advisor. The collective trusts' underlying assets consist of fully benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed-income securities and money market funds.

**Self-directed brokerage option:** Comprised of exchange traded funds, common stock, money market funds and mutual funds. Valued at the closing quoted price reported on the active market on which the individual securities are traded and are therefore classified as Level 1.

#### (5) Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees relating to the administration of notes receivable from participants are charged directly to the participant's account. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a taxable benefit payment is recorded. At December 31, 2024 and 2023, there were \$109,832 and \$115,261, respectively, in notes receivable from participants. The amount of loans outstanding to a participant is restricted by the participant's vested interest or dollar amount under IRS rules.

#### (6) Collective Trusts

Plan participants can invest in a collective trust of the Fidelity Group Trust for Employee Benefit Plans, the Managed Income Portfolio Class II (the collective trust). The collective trust is not a mutual fund. It invests primarily in investment contracts issued by insurance companies and other financial institutions, fixed income securities and money market funds and are credited with earnings on the underlying investments. It is also charged for participant withdrawals and administrative expenses.

#### (7) Tax Status

The Plan Sponsor has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 issued to Fidelity Management Trust Company, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Code.

#### (8) Party-in-Interest Transactions

Certain plan investments such as shares of registered investment companies in the Fidelity fund family and the Fidelity Advisor Stable Value common/collective trusts are managed by affiliates of Fidelity Management Trust Company, the trustee of the Plan. The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity Management Trust Company for the investment management services, loan administration and other recordkeeping services were \$27,929.

#### (9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### (10) Prohibited Transactions

During the 2023 and 2022 plan years, the Plan Sponsor inadvertently failed to deposit \$683,724 and \$491,548, respectively, of participant contributions and loan repayments within the required timeframe as stated by the Department of Labor's regulations. The Plan Sponsor has fully corrected these transactions under the Voluntary Fiduciary Correction Program during the year ended December 31, 2024. The correction was made from the Plan Sponsor's assets and not from the assets of the Plan.
