INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Commission on Economic Opportunity for the Greater Capital Region, Inc. Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, as listed in the accompanying index as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

December 31, 2024 and 2023

NOTE A--DESCRIPTION OF THE PLAN

The following description of The Commission on Economic Opportunity for the Greater Capital Region, Inc. (the "Organization") Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document and adoption agreement for more complete details of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of the Company who have one year of service, 1,000 hours in the year, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Company Contributions

The contribution amount is discretionary and is determined by the Company's Board of Directors each year. The contributions are based on the participants' gross earnings for the twelve-month period ending each December 31. Participants are not allowed to contribute to the Plan. Contributions are subject to applicable Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant's account is credited with allocations of (a) the Company's contribution, (b) Plan earnings and (c) administrative expenses. Allocations in the Company's contributions are based on participant compensation, as defined. Allocations in Plan earnings and administrative expenses are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Vesting for employees occurs ratably over five years (years two through six) for all employees.

Investment Options

Upon enrollment in the Plan, a participant may direct company contributions to be invested in any of the investment choices available under the Plan. The investment fund choices include mutual funds, collective trust funds, and money market funds. Participants may change the mix of investments from one fund to another on a daily basis. All investments are participant directed.

NOTE A--DESCRIPTION OF THE PLAN--Continued

Payment of Benefits

On termination of service for any reason (death, disability, termination or retirement), a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the account balance is greater than \$5,000, the participant may choose to defer receiving payments until age 70 ½. Benefits are recorded when paid. The Plan also provides for in-service distributions for participants who have attained age 59 ½ and are fully vested in their account.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at rates equal to the current prime rate plus two percentage points. The interest rate on the outstanding loan was 9.50% for the year ended December 31, 2024. Principal and interest is paid ratably through monthly payroll deductions.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures will be allocated as an employer discretionary contribution each year to eligible participants. As of December 31, 2024 and 2023, the Plan had unallocated forfeitures of \$46,595 and \$13,119, respectively.

Administrative Expenses

The Plan's administrative expenses may be paid out of the Plan assets unless paid by the Company as provided for in the Plan document.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Investment Valuation and Income Recognition--Continued

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments which includes the realized gains or losses (computed using average cost) and the unrealized depreciation on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. Related fees are recorded as administrative expenses and are recorded when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

In accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the Plan has evaluated for subsequent events between the statement of net assets available for benefits date of December 31, 2024 and October 13, 2025, the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair value of mutual funds and money market funds is based on the closing price reported in the active market where the individual securities are traded, when available.

Level 2 Fair Value Measurements

Level 2 investments are fair values primarily obtained from third party pricing services for identical or comparable assets. There were no Level 2 investments.

Level 3 Fair Value Measurements

The collective trust funds are not actively traded and significant other observable inputs are not available. Thus, the fair value of the collective trust funds is determined on the basis of the fair value of the underlying investments held by the fund less its liabilities. For those assets with a fair value measured using Level 3 inputs, policies and procedures are reassessed annually to determine if the current valuation techniques are appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

NOTE E--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F--TAX STATUS

The Plan is designed from a prototype plan, the Volume Submitter Profit Sharing Plan. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has any uncertain position that more likely than not would not be sustained upon examination by the IRS or the U.S. Department of Labor. The Plan is subject to routine audits by federal taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to tax examinations for years prior to 2021.

NOTE G--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H--RELATED PARTY TRANSACTIONS

The Plan invests in funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank was the trustee and custodian, as well as record keeper, of the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.



