Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Korea Times Los Angeles, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF PLAN

The following description of The Korea Times Los Angeles, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established by Korea Times Los Angeles, Inc. (the Plan Sponsor, the Employer and the Company) effective September 1, 1997, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was adopted under the provisions of Section 401(a) of the Internal Revenue Code (IRC) with a cash or deferred arrangement qualified under Section 401(k) of the IRC. The Plan is a defined contribution plan that covers all employees who have attained age 20-1/2 and completed one year of service. The Plan is subject to the provisions of ERISA, as amended.

Contributions

Participants may contribute a certain amount of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the Plan year-end are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The employer may make matching contributions equal to a discretionary percentage as determined by the Company. There were no employer matching contribution for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participant Accounts

Participants direct the investment of their accounts to investment funds offered by the Plan. Each participant's account is credited with the participant's contribution, the related employer matching contribution, if any, and an allocation of the Plan earnings and administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Loans

Participants may borrow from their investment fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed 5 years, except in the case for the purchase of a primary residence. The loans are secured by the balance in the participant's account and have interest rates between 4.25% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through semi-monthly payroll deductions.

Vesting

Participants are immediately vested in their own contributions, rollovers from other qualified plans, and actual earnings thereon. Vesting in the employer contributions is based on years of service. A participant is 100% vested after 5 years of service. A participant becomes fully vested in all contributions in the event that the participant retires, dies, or becomes totally disabled.

Payment of Benefits

On termination of service, a participant receives a lump-sum amount equal to the value of his or her accounts. Participants may also receive in-service withdrawals under certain conditions.

Forfeited Accounts and Plan Expense Account

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,207 and \$3,944, respectively, and the Plan expense account as funded by fee credits totaled \$89,413 and \$85,269, respectively. Forfeitures are used to reduce future employer contributions or pay Plan expenses. In 2024, no forfeitures were used to offset employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company is under no obligation or liability to continue its contributions and may discontinue such contributions or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, which approximates when interest is received. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in the mutual funds and common/collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)

Notes Receivable from Participants

Notes receivable from participants related to participant loans are stated at the unpaid principal balance. Interest income associated with the notes receivable are recorded when interest payments are received, usually semi-monthly. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid or upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor, at its option, and are excluded from these financial statements. Plan expenses include investment advisor fees, audit fees, and also certain fees related to specific participant transactions, such as for participant loans and benefit payments, which are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

3. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

Reliance Trust Company, the trustee of the Plan, has certified that the following information included in the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, is complete and accurate in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA is complete and accurate:

- a. Investments and participant loans as included in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- b. All information pertaining to investment income, including net appreciation (depreciation), and interest and dividends and participant loan interest, in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- c. Schedule of Assets (Held at End of Year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 with the related inputs to the valuation methodology are described as follows:

Following is a description of the valuation methodologies used for the Plan's investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds

Valued at the net asset value of units of the common/collective trust. The net asset value (NAV), as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. The common/collective trust funds have no unfunded commitments, have daily redemption frequency, and no redemption notice period, except for the Invesco Stable Asset Fund. Were the Plan to initiate a full redemption of Invesco Stable Asset Fund, the fund trustee requires a 12 month written notice and therefore reserves the right to temporarily delay withdrawal from the trust in order to ensure that the liquidations will be carried out in an orderly business manner.

5. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated October 6, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. PARTY-IN-INTEREST TRANSACTIONS

As mentioned in Note 2, certain administrative expenses are paid to various service providers such as the Plan recordkeeper, the Plan investment advisor, and Plan auditor. The above transactions, including the notes receivable from participants, qualify as allowable party-in-interest transactions for which there are statutory exemptions.

8. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan's trustee was changed from Reliance Trust Company ("Reliance") to ADP Retirement Trust Services, LLC ("ADP Trust").

In preparing these financial statements, the Plan administrator has evaluated subsequent events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.
