## **1. Description of Plan**

The following description of the United Infrastructure Group 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan covers employees of United Infrastructure Group, Inc. and its affiliate United Demolition, LLC, collectively ("UIG") or ("the Company").

The Plan is a defined contribution plan sponsored by UIG, which provides retirement benefits to eligible full-time employees of the Company who are age eighteen or older and have completed 30 days of service. (Prior to August 1, 2024, employees had to earn 1,000 hours of service in a six-month period. If the 1,000 hours of service requirement was not met in the first six months, employees became eligible at one year of service, provided they were an eligible employee at the end of that period.) Employees may begin participating in the Plan on the first day of the month coinciding with or following the date eligibility service requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### **Plan Amendments**

Effective August 1, 2024, the Plan was restated and amended to (1) include part-time employees as eligible employees, while excluding any employees covered by a collective bargaining agreement, and leased employees, (2) change eligibility service requirements from 1,000 hours of service completed in a six-month period to 30 days of service with no minimum hours of service, (3) change the permitted frequency of elective deferral changes from quarterly to monthly, and (4) permit hardship distributions.

### **Contributions**

Participants may contribute any percentage greater than or equal to 1% of their pre-tax annual compensation to the 401(k) portion of their account in the Plan and any percentage greater than or equal to 1% of their after-tax annual compensation to the ROTH 401(k) portion of their account in the Plan, as defined by the Plan document, subject to contribution limitations specified by applicable laws and regulations. Participants who have attained age 50 by the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

**1. Description of Plan (continued)**

The Plan has an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at four percent of eligible pretax compensation. The amount of such automatic enrollment will increase annually by one percent up to a maximum of eight percent unless the participant makes an alternative election.

The Company made safe harbor matching contributions equal to one hundred percent of employee deferrals up to a maximum of four percent of compensation for each participant that contributed to the Plan in 2024 and 2023. The Company may also make discretionary contributions to the profit sharing portion of the Plan. The Company made no profit sharing contributions for 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, safe harbor matching contributions, plan earnings (or losses), and charged with an allocation of any administrative expenses paid by the Plan. Each participant's profit sharing portion of their account is credited with an allocation of the Company's contribution, if any, plan earnings (or losses), and forfeitures of terminated participants' non-vested accounts, if any. Company profit sharing contributions and plan forfeitures are allocated based on the ratio of each participant's compensation, as defined in the Plan document, to the total compensation of all plan participants for the Plan year.

Participants may elect to allocate current contributions among a variety of investment fund options. The allocations remain in effect until a new election is made. Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective deferrals and employer safe harbor matching contributions plus actual earnings thereon. Non-safe harbor employer contributions vest using a 3-year cliff-vesting schedule. Vesting is computed using the Plan's year end date of December 31. A participant becomes fully vested in their employer contributions in the event of retirement at age 65, death, disability, or plan termination.

**Notes Receivable from Participants**

Under the terms of the Plan document, participants may borrow from their accounts, subject to certain restrictions. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years, except for loans made for the purchase of a primary residence. Loans are secured by the balance in the participant's account. Accordingly, no allowance for credit losses is deemed necessary. Interest rates are established on the date of the loan based on rates charged for similar types of loans by other lenders. Loans to participants have interest rates ranging from 4.25% to 10.50% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On retirement, disability, death, termination of employment, or attainment of age 59 ½, participants or their beneficiaries may elect to receive their vested interest in his or her account in a lump-sum amount or in installments at the participant's direction. Upon termination of employment due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution upon meeting certain requirements. Beginning August 1, 2024, hardship distributions are permitted upon determination of financial hardship. The Plan makes mandatory distributions to participants who have been terminated if their account balances are under \$7,000.

**Forfeitures and Expense Accounts**

The Plan's provisions allow available forfeitures to be used for administrative expenses of the Plan or reallocated to participant accounts. Forfeitures not used to pay plan expenses may be used to reduce future employer matching and profit sharing contributions. During the years ended December 31, 2024 and 2023, there were no forfeitures available to be allocated.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Administrative Expenses**

Certain administrative expenses are charged to individual participants' accounts. The Plan pays custodial, recordkeeping, investment advisory and certain professional fees. Any administrative expenses not paid by the Plan are paid by the Company.

## **2. Basis of Presentation and Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

### **Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for fully benefit responsive investments, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

As of December 31, 2024, the Plan's investments include the Principal Fixed Income Guaranteed Option ("PFIGO"), an investment option under a group annuity contract issued by Principal Life Insurance Company ("Principal Life") to Principal Trust Company as custodian. PFIGO maintains the contributions in a general account. Participant accounts are credited with earnings on the underlying investments. Benefit payments to participants for plan benefit events, including retirement, termination of employment, disability, plan termination, death, loans and withdrawals, as allowed by the Plan, are made without any surrender charge. PFIGO is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. While Principal Life declares rates and backs the principal and interest of PFIGO, any guarantees are subject to the claims paying ability of the insurance company. Participant transactions (purchases and sales) may occur daily.

**Investment Valuation and Income Recognition (continued)**

As of December 31, 2023, the Plan's investments included the Lincoln Stable Value Separate Account ("LSV"), an investment option under a group fixed annuity contract issued by The Lincoln National Life Insurance Company ("LNLIC"). LNLIC maintained the contributions in a general account. Participant accounts were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. LNLIC was contractually obligated to repay the principal and specified interest rate that was guaranteed to the Plan. While LNLIC declared rates and backed the principal and interest of LSV, any guarantees were subject to the claims paying ability of the insurance company. Participant transactions (purchases and sales) could occur daily.

Because the PFIGO and LSV meet the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the stable value option. Contract value, as reported to the Plan by Principal Life and LNLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Principal Life and LNLIC. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan invests in investment securities that are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values in investment securities will occur in the near term and that these changes could materially affect the amounts reported in the 2024 statement of net assets available for plan benefits.

### **Payment of Benefits**

Benefit payments are recorded as paid.

## **3. Certified Investments**

Information presented in the accompanying financial statements as of and for the year ended December 31, 2024, and for the period from August 1, 2024 through December 31, 2024 related to investments, notes receivable from participants, net appreciation in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Trust Company ("Principal"), the custodian. Information disclosed in the accompanying financial statements for the period from January 1, 2024 through August 1, 2024 and as of and for the year ended December 2023 related to investments, net appreciation in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Matrix Trust Company ("Matrix"), the custodian until August 1, 2024.

## **4. Fair Value Measurements**

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. All of the Plan's mutual funds were valued using Level 1 inputs, based on quoted net asset values of the shares held by the Plan. No Level 2 or Level 3 inputs were used by the Plan.

**4. Fair Value Measurements (continued)**

*Mutual funds* – Valued at the daily closing price as reported by the funds. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (“NAV”) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts* – Valued at NAV, as provided by Principal, as a practical expedient to estimate fair value. The NAV of each account is based on the fair value of the underlying investments held less the account’s liabilities. This practical expedient is not used when it is determined to be probable that the collective trusts will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Collective trusts* – As of December 31, 2024, Plan investments include Great Gray Trust RetirePilot American Funds collective investment trust funds whereby the underlying investments primarily consist of American Funds mutual funds and the Great Gray Trust Stable Value Fund. As of December 31, 2023, Plan investments included the Legal & General S&P 500 Collective Investment Trust, a collective trust whereby the underlying investments primarily consist of publicly traded US equity securities. These collective trusts are valued at NAV, as provided by the issuer, as a practical expedient to estimate fair value. The NAV of each account is based on the fair value of the underlying investments held less the account’s liabilities. This practical expedient is not used when it is determined to be probable that the collective trusts will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the account provider reserves the right to temporarily delay withdrawal from the collective trusts in order to ensure that security liquidations will be carried out in an orderly business manner.

The Plan’s investments are participant directed. The methods used to measure fair value may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Although plan management believes the valuation methods used are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

**5. Parties-in-Interest Transactions**

PenServ Plan Services (“PenServ”) provided recordkeeping services to the Plan until August 1, 2024. All transactions with PenServ qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, fees paid to PenServ for recordkeeping services totaled approximately \$32,000 and \$33,000, respectively.

**5. Parties-in-Interest Transactions (continued)**

Matrix provided custodial services to the Plan until August 1, 2024. All transactions with Matrix qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, fees paid to Matrix for custodial services totaled approximately \$5,000 and \$7,000, respectively. As of December 31, 2024 and 2023, the Plan had fees payable to Matrix of \$0 and approximately \$2,000, respectively, which were included in administrative fees payable in the accompany statements of net assets available for plan benefits.

Wells Fargo Clearing Services, LLC (“WF”) provides investment advisory and certain fiduciary services to the Plan. All transactions with WF qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, fees paid by the Plan for these services totaled approximately \$22,000 annually. As of December 31, 2024 and 2023, the Plan had fees payable to Wells Fargo of \$0 and approximately \$6,000, respectively, which were included in administrative fees payable in the accompanying statements of net assets available for plan benefits.

Beginning August 1, 2024, Principal began providing custodial and recordkeeping services to the Plan. All transactions with Principal qualify as party-in-interest transactions. During the year ended December 31, 2024, fees paid to Principal for custodial and recordkeeping services totaled approximately \$46,000.

These party-in-interest transactions, including notes receivable from participants, are exempt from the prohibited transaction rules of ERISA.

**6. Income Tax Status**

The Plan is a non-standardized pre-approved profit sharing plan, designed to be in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Internal Revenue Service (“IRS”) issued an opinion letter dated June 30, 2020, that the pre-approved plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended and restated since the date of the letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust was tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan had certain operational errors during the years ending December 31, 2024 and 2023. Management believes they have taken the corrective active necessary to ensure the Plan is being administered in accordance with the Plan document and management does not believe the operational errors impacted the Plan’s qualified status.

Corrective distributions payable related to an operational error for the year ending December 31, 2020 were paid out to affected participants during 2023. Management believes the necessary corrective actions were taken in 2023 to preserve the Plan’s qualified status.

**6. Income Tax Status (continued)**

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2024 and 2023.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress

**7. Subsequent Events**

Management has evaluated events and transactions after December 31, 2024 through October 14, 2025, the date on which the financial statements were available to be issued, for subsequent events.

Effective March 1, 2025, the Plan was amended to add United Engineering & Consulting, LLC as a new adopting employer.

There were no other subsequent events to report.
