# Independent Auditor's Report

To the Participants and Plan Administrator of

## ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Lennox International Inc. Merged Profit Sharing and 401(k) Retirement Plan for Salaried Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lennox International Inc. Merged Profit Sharing and 401(k) Retirement Plan for Salaried Employees's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

## ***Opinion***

## Notes to the Financial Statements

### **1. Description of Plan**

The following description of the Lennox International Inc. Merged Profit Sharing and 401(k) Retirement Plan for Salaried Employees (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established effective January 1, 1991, as restated January 1, 2023. The Plan covers all salaried employees, excluding individuals who reside in Puerto Rico or are nonresident aliens without U.S.-source income, those covered by a collective bargaining agreement not included in the plan, those classified as leased employees or independent contractors, and those not listed as common law employees, of Lennox International Inc. (the Company or Employer) who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Administrative Committee is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Master Trust*

A portion of the Plan's investments are held in a Master Trust (the "Master Trust"), which was established for the investment of assets of the plan and one other Lennox International Inc. sponsored retirement plan. Each participating retirement plan has a divided interest in the Master Trust. The assets of the Master Trust are held by Fidelity Management Trust Company.

#### *Contributions*

Each year, participants may contribute up to 75 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan, as applicable.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1 percent on the anniversary of their enrollment date until their deferral rate reaches 6 percent.

Lennox International, Inc. employees are eligible for a Safe Harbor contribution (3% of eligible compensation) after their one year anniversary. In addition, Lennox International, Inc. employees are eligible for a matching contribution of 50% of the first 6% of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

All prior profit sharing contributions made to the Plan are invested by Fidelity Management Trust Company under a discretionary trust agreement between the Employer and Fidelity Management Trust Company. Participants are unable to direct contributions made by the Company on their behalf.

### *Participant accounts*

Each participant's account is credited with the participant's contributions, Company matching and Safe Harbor contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are immediately vested in their contributions and Safe Harbor contributions plus actual earnings thereon. Vesting in the Company's matching contributions plus actual earnings thereon is based on years of continuous service as defined by the Plan.

### *Notes receivable from participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participants' account. The loan interest rate, determined at the time of issuance, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to 5 years or greater for the purchase of a primary residence.

### *Payment of benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of rollover or lump sum. A participant who incurs severance of employment and who will receive a distribution prior to age 62 or normal retirement age will receive an automatic rollover to an IRA if the distribution is greater than \$1,000 and less than or equal to \$5,000. If the distribution is less than \$1,000, the participant will receive the distribution in the form of a lump sum cash payment. A participant may make an in-service withdrawal of all or a portion of the total amount credited to his or her account if he or she has reached age 59½ and is still employed by the Company. A hardship withdrawal will be considered based on an immediate and significant financial need of a participant as determined by the Plan.

Profit sharing participants who terminate service by reason of retirement, death, or disability have fully vested interests in their accounts. Upon the retirement or disability of a participant, the entire vested interest is distributed to such participant per Plan provisions. Upon death of the participant, the vested interest of such participant is distributed to the participant's surviving spouse or designated beneficiary. Payment of the benefit is made in the form of a lump-sum payment or annuity contract purchased from a company selected by the Board.

### *Forfeited accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$498,605 and \$10,254, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts. Subsequent to year-end, forfeitures totaling \$300,000 were used to reduce 2024 employer contributions paid in 2025.

### **2. Summary of Accounting Policies**

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

At the direction of the Committee, Fidelity Management Trust Company has the right to divide the Trust into two or more funds, which shall serve as vehicles for the investment of the participant accounts. The general characteristics and objectives of each fund are determined by a committee appointed by the Company.

Fidelity Management Trust Company has complete investment discretion over each fund assigned to it, subject only to the general investment characteristics and objectives established for each particular fund. Fidelity Management Trust Company values each fund as of each valuation date, as defined. The valuation reflects the quoted market value of the assets comprising such fund.

Income from investments is recorded as earned on an accrual basis. Purchases and sales of investments are reflected on a trade date basis.

In the statements of changes in net assets available for benefits, the Plan presents its proportional interest in the net change in the Trust investment, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments, and interest and dividend income.

#### *Master Trust Allocation*

The 401(k) Plan invests in the Lennox International Inc 401(k) plan Master Trust, and a portion of the Plan's assets represent allocated shares determined pro rata, based upon the sum of the value of participant accounts for the Plan. Assets of the Plan are transferred between the Plan and the Lennox International Inc. 401(k) Plan for Hourly Employees as the employment status of a participant changes.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments and Plan interest in master trust income.

### *Subsequent Events*

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.

## **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment manager reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Interest in Master Trust

### 6. Transfers Into or Out of the Plan

During 2024, certain participant account balances were transferred from the Plan to the Lennox International Inc. 401(k) Plan for Hourly Employees. Net transfers out of the Plan totaled \$1,550,021.

Effective December 31, 2024, the Company approved the legal mergers of the AES Mechanical Services Group, Inc. 401(k) Profit Sharing Plan and the AES Industries, Inc. 401(k) Profit Sharing Plan into the Lennox International Inc. 401(k) Plan for Hourly Employees and the Lennox International Inc. Merged Profit Sharing and 401(k) Retirement Plan for Salaried Employees.

As a result of the merger, participant account balances previously held in trust by John Hancock Life Insurance Company were transferred to Fidelity Management Trust Company in January 2025. Accordingly, the financial statements reflect a receivable of \$4,362,334, representing the fair value of the funds subsequently received into the Lennox International Inc. Merged Profit Sharing and 401(k) Retirement Plan for Salaried Employees.

### **7. Information Certified by a Qualified Institution**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### **8. Related-Party and Party In Interest Transactions**

Certain Plan investments are managed by a qualified institution, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### **9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### **10. Tax Status**

The IRS has determined and informed the Company by a letter dated November 28, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
