### 1. DESCRIPTION OF THE PLAN

The following description of the Adfinitas Health 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, established January 1, 2007, covering substantially all employees of Adfinitas Management, LLC, Adfinitas Health, LLC and Adfinitas-AIM Management, LLC (collectively, the Company), who are at least twenty-one years of age, except union and non-resident aliens, as defined by the Plan. There is no service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended effective January 1, 2024 to exclude pro re nata (PRN) employees from Company matching contributions.

#### **Participant Contributions**

Participants may elect to contribute up to 100% of their annual compensation to the Plan, up to the maximum allowed by the Internal Revenue Code (the Code) which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catchup contributions, subject to limitation imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Participants are permitted to make Roth elective contributions to the Plan. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Roth elective contributions are treated as elective contributions for all purposes under the Plan. Participants are also permitted to make rollover contributions from other qualified retirement plans into the Plan.

#### **Company Contributions**

The Company makes matching contributions at a rate determined each year. For the year ended December 31, 2024, the Company made matching contributions equal to 50% of the first 4% of participants' elective deferrals of compensation on a per payroll basis. Matching contributions totaled \$812,381 for the year ended December 31, 2024. The Company may also make discretionary matching contributions. Discretionary matching contributions are determined by the Company and are allocated on the basis of each participants' annual contributions and annual compensation. There were no discretionary matching contributions for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is participant-directed and contributions are credited with the investment options selected by each participant. Plan earnings, losses and administrative expenses are allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Company matching contributions, discretionary matching contributions and profit sharing contributions is based on years of service, according to the following schedule:

However, a participant shall become fully vested upon retirement, death or disability (as defined by the Plan).

#### Forfeitures

Non-vested amounts will be forfeited by participants upon termination, and may be used to pay administrative expenses of the Plan or to reduce Company matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$110,398 and \$42,804, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Company matching contributions. Forfeitures totaling \$11,664 were used to pay administrative expenses during the year ended December 31, 2024.

#### Notes Receivable from Participants

Participants may borrow from their accounts, excluding Roth elective deferral or Roth rollover accounts, a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Prior to January 1, 2022, loan terms could not exceed five years except for loans used to purchase a principal residence, which could not exceed 15 years. Effective January 1, 2022, loan terms of loans used to purchase a principal residence may not exceed 30 years. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate at time of issuance plus one percent. Participants who are on active duty with the military may qualify for a lower interest rate. Principal and interest are paid ratably through payroll deductions. The Plan allows participants to have only one outstanding loan at a time.

#### Payment of Benefits

Upon termination of employment or termination of service due to death, disability or retirement, a participant, or the participant's beneficiary in the case of the death of the participant, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in partial installments over time. Upon termination of service, participants with vested account balances of \$7,000 or less will be automatically cashed out. In-service distributions are also permitted upon meeting certain requirements as defined by the Plan. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.

Effective January 1, 2024, in accordance with the SECURE 2.0 Act (SECURE 2.0), the Plan elected to allow for certain additional distribution events as follows: (a) the threshold for mandatory distributions increased from \$5,000 to \$7,000, (b) participants may take penalty-free early distributions in cases of domestic abuse wherein eligible participants may withdraw up to the lesser of \$10,000 or 50% of their vested account balance, provided the distribution occurs within one year of the domestic abuse incident, subject to specific provisions, and (c) the Plan permits distributions of up to \$22,000 for expenses incurred as a result of a federally declared disaster, in accordance with the permanent disaster relief rules established under SECURE 2.0. Such federally declared disaster distributions are not subject to the 10 percent additional tax and are taken into account as gross income over 3 years, subject to specific repayment options. A formal amendment incorporating all SECURE 2.0 provisions is expected to be adopted no later than December 31, 2026, in accordance with Internal Revenue Service (IRS) guidelines. As of October 3, 2025, the Plan has not been formally amended for these provisions.

As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not been paid by year-end.

#### Plan Expenses

All administrative expenses are required to be paid with assets of the Plan, unless paid by the Company, at its discretion. During the year ended December 31, 2024, the Company elected to pay a portion of the Plan's direct expenses. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant accounts and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

The Plan utilizes a revenue sharing account to offset recordkeeping fees due from the Company. There were no revenue sharing amounts credited back to the Plan for the year ended December 31, 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities may occur that materially affect participant account balances and amounts reported in the statements of net assets available for benefits.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Fair Value Measurement**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

*Interest in stable value collective trust:* Valued at the net asset value (NAV), as a practical expedient, calculated on a daily basis by the administrator of the trust.

*Interest in common/collective investment trust:* Valued at NAV as determined by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Interest income is recorded on the accrual basis. Delinquent notes are treated as distributions based on the terms of the Plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 3, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure except as disclosed in Note 1.

### 3. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedule, including assets held at December 31, 2024 and 2023, and interest and dividend income and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Custodian of the Plan, Alerus Financial, N.A.

### 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 5. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants to take out notes against their vested account balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 6. INCOME TAX STATUS

Effective January 1, 2022, the Plan adopted a Pollard & Associates non-standardized 401(k) Profit Sharing Plan agreement. The Internal Revenue Service (IRS) issued an opinion letter to Pollard & Associates Inc. dated November 30, 2020. The opinion letter states that the Plan document is acceptable and may be relied on by an adopting employer with respect to the qualification of the Plan under Section 401(a) of the Code. Although the Plan has been amended since receiving the latest opinion letter, the Plan administrator believes that the Plan is designed, and currently being operated in compliance with the applicable requirements of the Code, and therefore, believes the Plan continues to be qualified, and the related trust tax-exempt.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.
