Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter - supplemental schedule required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the Retail Travel Services/Duty Free Air & Ship Supply 401(k) Plan (the "Plan") provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Retail Travel Services, Inc. (the "Company" and "Plan Employer") in January 2018. Employees of the Company and other participating employers are eligible to participate in the Plan provided they are at least 21 years of age and have at least three months of service with the Company or one of the participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan's trustee is Reliance Trust Company ("Trustee") and recordkeeper is Automatic Data Processing, Inc. ("ADP").

Contributions

Participants may contribute up to 90% of their pre-tax annual compensation, as defined in the Plan document, without exceeding limitations prescribed by the Internal Revenue Code ("IRC"). Additionally, the Plan allows participants to make Roth 401(k) deferrals to the Plan, subject to the same limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollovers"). Catch-up contributions, as defined in the IRC, are permissible for eligible participants who are at least age 50 or will attain age 50 before the end of the calendar year. All participant contributions during a plan year are subject to maximum dollar limitations established by the IRC.

The Plan allows the Company to make non-elective contributions to the Plan on behalf of eligible participants at its discretion. The Company did not make any discretionary non-elective contributions to the Plan for the year ended December 31, 2024.

The Plan allows a matching Company contribution of 100% of the first 3% contributed by Participants. The Plan also allows for a true up for Company matching contributions which will be recalculated following the close of the Plan year based on the ratio of elective deferrals to compensation for the Plan year.

Participant Accounts

A separate individual account is established for each participant in the Plan. Each participant's account is credited with the elective deferral contribution, Company contributions, and an allocation of Plan earnings and charged with withdrawals, an allocation of administrative expenses and Plan losses. Allocations of the Plan's earnings are based on participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their contributions and the earnings thereon. Vesting in the Company's discretionary non-elective contributions, plus actual earnings thereon, is based upon years of service with the Company as follows:

Forfeitures

Forfeitures of terminated non-vested account balances may be used to reduce the Company's contributions, if any, or to pay the Plan's administrative expenses. During 2024, \$4,413 forfeitures were used to offset the Company match.

Investment Options

Participants direct the investment of their contributions plus actual earnings thereon into various investment options offered by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants

Under the terms of the Plan, a participant may borrow a minimum amount of \$500 and up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The notes are repayable over a period of up to five years, unless the proceeds are used to purchase a primary residence, in which case the loan is repayable over a period of up to 30 years. The notes are secured by the balance in the participant's account and bear interest at the Prime Rate plus 2%. Principal and interest are paid ratably through payroll deductions. A participant may have only one loan outstanding at a point in time.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant (or the participant's beneficiary) may elect to receive an amount equal to the value of the vested interest in a lump-sum payment. Participants may also withdraw funds from their account when they reach the age of 59½ or in the event of financial hardship.

Upon termination of service, vested amounts of \$5,000 or less are automatically distributed to the participant or rolled over to another qualified plan at the request of the participant. Vested amounts exceeding \$5,000 in such terminated participant's accounts are maintained until retirement, disability, or death unless the participant elects to receive the entire vested amount in a lump-sum payment or has a direct rollover to another qualified plan. Payment will occur within one year of such election. The Company allows participants, upon their retirement, to receive distributions of their vested amounts in a lump-sum payment. Benefits are recorded as deductions from net assets available for benefits when paid.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of the financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Risks and Uncertainties

The Plan provides for investment options in a variety of investment securities. Investment securities in general are exposed to various risks, such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

Net Appreciation or Depreciation in Fair Value of Investments

Net realized and unrealized appreciation or depreciation of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments and includes net gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

The Company pays most administrative expenses associated with the Plan. Expenses relating to Plan investments are paid by the Plan and borne on a pro-rata basis by each participant. These expenses are included in net appreciation in fair value of investments.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the net asset value ("NAV") of shares held by the Plan at year end in active markets. The mutual funds provide for daily redemptions by the Plan at reported NAV's with no advance notice requirement. The mutual funds are deemed to be actively traded

Collective Trusts - The Plan has interests in collective trusts valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. These investments can be redeemed daily and without any restrictions on the timing of the redemption. At December 31, 2024 and 2023, the Plan had no unfunded commitments related to these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date. There were no changes to methodologies at December 31, 2024 or 2023.

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Certain investment related fees incurred by the Plan are netted against the appreciation in fair value of investments as they are paid through revenue sharing, rather than as a direct payment. All other Plan related fees are paid for by the Company. Notes receivable from participants are also considered to be party-in-interest transactions.

NOTE F - TAX STATUS

The Internal Revenue Service ("IRS") has determined that the prototype non-standardized profit-sharing plan adopted by the Company and provided by ADP is designed in accordance with applicable sections of the IRC, and informed ADP of such in a letter dated July 8, 2014. The Plan was created subsequent to receiving the opinion letter. However, the Plan Administrator believes the Plan is designed and operating in compliance with the applicable requirements of the IRC.

US GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
