## INDEPENDENT AUDITOR'S REPORT

## **One TrueAccord 401(k) Plan Notes to Financial Statements**

### 1. Description of the Plan

One True Holding Company (the Company or Employer) established the One TrueAccord 401(k) Plan (the Plan), effective January 1, 2014, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated effective January 1, 2024, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. Charles Schwab Trust Bank (Schwab Bank) is the Plan's trustee and Schwab Retirement Plan Services, Inc. is the Plan's third-party administrator to process and maintain the records of participant data. Schwab Bank holds, invests, and reinvests Plan assets in the interest and at the direction of the participants and their beneficiaries.

#### *Eligible Participants:*

Company employees, as defined by the Plan agreement, may participate in the Plan immediately upon hire.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferral and post-tax Roth contributions up to 92% of their eligible annual compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan provides for automatic enrollment on the date participants become eligible for the Plan. The automatic salary deferral contribution is 5% of participant compensation, unless the participants request a different amount to be contributed or formally decline participation. Participants may adjust their deferral rate or discontinue their contributions at any time.

### 1. Description of the Plan (continued)

#### *Contributions:* (continued)

The Plan was amended on November 17, 2023 to discontinue the Company's safe harbor matching contributions effective January 1, 2024.

The Company may make discretionary profit-sharing contributions, as determined by the Company's Board of Directors. The Company has not made any discretionary profit-sharing contributions to the Plan through 2024.

Contributions are subject to certain limitations under the Code.

#### *Participant Accounts:*

Participant accounts are credited with participant contributions, Company contributions, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period of one to five years, except for notes used to purchase a primary residence in which case longer note periods are allowed. Participant notes are evidenced by a written note, secured by the participant account, and bear interest at the prime rate published in The Wall Street Journal, plus 1%, on the date the note was issued. Participants may have only one note outstanding. The interest rates on the notes outstanding as of December 31, 2024 range from 4.25% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Note receivable transactions with participants qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

### 1. Description of the Plan (continued)

#### *Vesting:*

Participants are fully vested (100%) in their account balances.

#### *Payment of Benefits:*

Upon termination of employment, participants may elect to receive an amount equal to their account balances. Distributions will be paid as soon as administratively feasible and may be paid in lump sum cash payment or rolled into another qualified retirement plans or individual retirement accounts, as elected by the participants, subject to certain stipulations in the Plan agreement. Terminated participant accounts between \$1,000 and \$5,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Terminated participant accounts below \$1,000 may be automatically distributed directly to participants without participant approval. The Plan agreement also allows for certain in-service and hardship withdrawals to current employees. Benefits are recorded when paid.

#### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain administrative expenses are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

#### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments:*

The Plan's investments consist of mutual funds, a money market fund, and a common/collective trust. These investments are accounted for as follows:

- *Mutual Funds and Money Market Fund:* These funds are reported at fair value, which is the net asset value of shares held by the Plan at year end, as quoted in active markets.
- *Common/Collective Trust:* The Plan's investment in a common/collective trust (CCT) does not have a readily available market quotation. The CCT's fair value is based on the fair value of securities in the trust's portfolio, which typically is the amount the trust might reasonably expect to receive for the sale of securities. The CCT may invest in mutual funds, U.S. and international stocks, fixed interest insurance investment contracts, money market funds, corporate and government bonds, mortgage-backed securities, bond funds, and other fixed income securities. The Plan has no unfunded commitments with the CCT.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

*Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

- *Level I:* Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- *Level II:* Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- *Level III:* Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

#### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab Bank, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated September 21, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

#### 4. Income Tax Status (continued)

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 5. Subsequent Events

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
