### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Fundbox 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Fundbox, Inc.'s (the Company) Fundbox 401 (k) Plan (the "Plan") provides for general information purpose only. Participants should refer to the plan agreement and amendments for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

***A. General***

The Company has established a retirement plan to supplement its employee's retirement income. Contributions are made into a Trust Fund, which pays benefits to the employees at retirement. The Plan was originally effective on January 01, 2018, which was amended and restated on October 01, 2020. All employees are eligible to participate from the first date of the month following the date of their hire. It is subject to the provisions of ERISA.

***B. Contributions***

Participants may elect to defer a portion of their eligible compensation into the Plan and not to exceed the limits established by the Internal Revenue Code, subject to certain limitations as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified benefit plans.

The Company may elect to make a matching contribution to the Plan, although the Company is not required to make this contribution. Participants must make elective deferrals to the Plan to receive the matching contribution. In addition, the Company may elect to make non-elective contribution. However, the Company did not make any matching or non-elective contributions during the years 2024 and 2023.

Contributions are subject to certain limitations. The limits include:

***C. Vesting Schedule***

Participants are always fully vested in their elective deferral and rollovers, if any. For the purpose of matching contributions and non-elective contributions account, the following vesting schedule is used:

***D. Benefits***

The Plan generally provides that upon reaching the normal retirement age of 65, death, disability or termination, participants are entitled to receive the value of their account in one lump sum payment of cash if the individual account is less than \$5,000. If the value of the individual account exceeds this amount the participants may elect to keep it in the Plan, however the benefit must begin to be distributed no later than April 1st of the calendar year following the later of the participant attaining the age of 70 ½ or the calendar year in which the participant retires. The participant may rollover their entire vested balance to individual retirement account (IRA) or to another employer's tax qualified plan. In the event of financial hardship, participants may withdraw from their account.

***E. Participant loans***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years, and longer repayment terms are permitted for the purchase of a principal residence. The loans are secured by the balance in the participant's account. The interest rate for a loan will be the rate in effect in the month the loan is effective. The interest rate is the prime rate as published in the Wall Street Journal on the 14th of each month plus two percentage points. Principal and interest are paid through payroll deductions.

***F. Forfeiture***

Participants terminating their employment before becoming 100% vested in their account balance but not taking any distribution from the Plan, then their non-vested portion of the account balance will be forfeited as of the date they have five years period of severance. If the participant receives a distribution from the vested portion of their account, the non-vested portion of their account will be forfeited when they take their distribution.

As of December 31, 2024, and 2023, there were no forfeited non-vested account balances. Forfeited accounts are first used to reduce future employer contributions and then to pay plan expenses.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

***A. Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

***B. Use of Accounting Estimates***

The preparation of financial statements in conformity with U.S. generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period.

***C. Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and insurance company.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES - CONT'D**

***C. Investment Valuation and Income Recognition - Cont'd***

See note 4 for discussion of fair value measurements. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Investment contracts are valued at fair value, which is determined by the trustee. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the exdividend date. Interest income is recorded on an accrual basis.

Management fees and operating expenses charged to the Plan for investment in mutual funds are reflected as a reduction of net assets in the Statement of Changes in Net Assets Available for Benefits.

***D. Receivable***

Receivables from participants are determined based on the outstanding amounts owed by participants to the Plan but have not yet paid. As of December 31, 2024, and 2023, the Plan has participant contribution receivable amounting to \$15,865 and \$24,823, respectively.

***E. Loans to participants***

Loans to participants are measured at their unpaid principal balance. As of December 31, 2024, and 2023, the outstanding balances are \$87,654 and \$46,991, respectively.

***F. Contributions***

Contributions from employees and the employer are recorded in the period in which the employer transfers the funds to the Plan.

***G. Refundable Contributions***

The Plan completes annual non-discrimination testing, including the Actual Contribution Percentage (ACP) test, as required by IRS regulations. For the year ended December 31, 2024, and 2023, the Plan passed the ACP and non-discrimination test.

***H. Rollovers***

Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met. As of December 31, 2024, and 2023, the Plan has participant's rollovers amounting to \$7,366 and \$141,796 respectively.

***I. Distributions***

Distributions requested by participants are recorded when paid.

***J. Deemed distributions***

Deemed distributions represent the amount of unpaid principal on participant loans actively participating in the Plan and have yet to continue to make payments on the outstanding notes as required under the participant loans from the participant's program. As of December 31, 2024, and 2023, there were \$0 and \$26,245 of deemed distributions respectively.

***K. Expenses***

Certain Plan administrative expenses are paid by the Employer.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

Fundbox has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reposting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified that the following data include in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as reported on the Statements of Net Assets Available for Benefits as of December 31, 2024;
- Dividend income, net investment income, and interest income on notes receivable from participants as shown on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Investment amounts included in the Notes to Financial Statements;
- All investment information included in the Supplemental Schedule of Assets (Held at the End of Year) -as of December 31, 2024.

At the request of the Fundbox, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Internal Revenue Service has determined that the form of the Plan and related trust are designed in accordance with applicable section 401 of the Internal Revenue Code (IRC). The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* -Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* -Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Values at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/ Collective Trust: It is valued daily and has a daily redemption period. There are no unfunded commitments for the common/collective trust held by the Plan as of December 31, 2024 and 2023. The total value of the common/collective trust is \$6,319 and \$3,592 as of December 31, 2024 and 2023, respectively.

There were no Level 2 and Level 3 assets as of December 31, 2024 and 2023.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the account balance of each Participant would become fully vested, as prescribed by ERISA and its related regulations, and would be distributed to each Participant according to the provisions of the Plan.

**NOTE 6 - TAX STATUS**

The Company has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions are recognized as exempt party-in-interest transactions.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**NOTE 9 - ERISA FIDELITY BOND**

In accordance with ERISA Section 412, the Plan covers a fidelity bond intended to protect the Plan from risk of loss due to fraud or dishonesty on the part of persons who handle funds or other property on behalf of the Plan.

**NOTE 10 - SUBSEQUENT EVENTS**

The management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and have determined that no adjustments are necessary to the amounts reported in the accompanying financial statements, nor have any subsequent events occurred, the nature of which would require disclosure.
