### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Transwood Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). #### Note 1. Description of Plan

The following description of the Transwood Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Transwood, Inc. and its wholly owned subsidiaries (the Company). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees are responsible for oversight of the Plan. The Company's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

**Eligibility:** Employees of the Company who have completed one month of service are eligible to participate in the Plan. Once eligible, employees are allowed to enter the Plan on January 1 and July 1 of each plan year. All eligible employees contributing to the Plan are eligible for the Company employer matching and discretionary contributions.

**Contributions:** Participants may contribute an amount equal to a dollar or percentage of their pretax annual compensation not to exceed federally defined limits, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company will contribute, for each participant, a matching contribution in an amount to be determined each year at management's discretion. The Company contributed an amount equal to 30% of the participant's contribution on the first 6% of the participant's annual compensation. The Company may also make discretionary contributions to the Plan as determined by Company management. There were no discretionary contributions during the year ended December 31, 2024. Contributions to a participant's account are not to exceed limits as defined in the IRC.

**Participant accounts:** Each participant's account is credited with the participant's salary deferral contribution and allocations of: (a) the Company's matching and discretionary contributions and (b) Plan earnings, and charged with an allocation of Plan administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** Participants direct the investment of their contributions and the allocations of the employer matching and discretionary contributions into various investment options offered by the Plan. Participants may change their investment options any time throughout the year via direct phone or internet access to Vanguard Group, Inc., the Plan record keeper (third-party processor).

#### Note 1. Plan Description (Continued)

**Vesting:** Participants are vested immediately in their salary deferral contributions plus actual earnings thereon. For purposes of vesting, a year of service is defined as a plan year including at least 1,000 hours of service. Vesting in the Company's matching and discretionary contributions and the related earnings is based on the following schedule:

**Payment of benefits:** Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount or installment amount equal to the value of the participant's vested interest in his or her account. If a participant terminates employment and the participant's account balance is less than \$7,000, the balance will be transferred to an individual retirement account in the absence of other instructions. In-service distributions are not permitted unless the participant has attained age 65, certain hardship conditions are met, or rollover contributions are available.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42,338 and \$14,236, respectively. Forfeitures of terminated participants' nonvested accounts are used to pay Plan administrative expenses or reduce employer matching contributions. During the year ended December 31, 2024, \$53,626 of forfeitures were used to reduce the employer's matching contribution.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the employer matching and discretionary contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Allowance for credit losses:** The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management provided for no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectible.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the 2024 statement of net assets available for benefits.

**Payment of benefits:** Benefits are recorded when paid. There were no withdrawals approved but not yet paid as of December 31, 2024.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Interest-bearing cash:** Interest-bearing cash is valued at cost, which approximates fair value.

**Registered investment companies:** Registered investment companies are valued at the daily closing price as reported by the fund. Investment funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price. The investment funds held by the Plan are deemed to be actively traded.

**Common collective trusts:** The collective trust is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimating fair value based upon the fair value of the underlying investments less liabilities.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Plan investments are managed by Renaissance Financial. Ascensus Trust Company is the trustee and Vanguard Group, Inc. is the record keeper; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the investment advisor, trustee and record keeper amounted to \$136,456 for the year ended December 31, 2024.

#### **Note 7. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Other expenses of the Plan are paid by the Plan and the Company.

#### **Note 9. Prohibited Transactions**

During the year ended December 31, 2023, the Plan Sponsor inadvertently failed to deposit \$113,308 of participant contributions within the required time frame as stated by the United States Department of Labor regulations. The Plan Sponsor intends to deposit lost interest to correct this failure in 2025. The Plan Sponsor intends to file Form 5330 and intends to pay the applicable excise tax to the IRS. The correction of any excise taxes, if applicable will be made from the Plan Sponsor's assets and not from assets of the Plan.

#### **Note 10. Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
