Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Urology America MSO 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Urology America MSO 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

General

The following description of Urology America MSO 401(k) Plan, formerly Urology Austin 401(k) Plan (Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Urology America MSO, LLC (Company) for the benefit of its employees, and employees of its affiliates, who have at least one hour of service during the first six months of employment with the Company. Eligible employees enter the Plan semi-annually on January 1 and July 1. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Matrix Trust Company (Matrix Trust) is the trustee of the Plan. Effective January 1, 2023, the Plan was amended to add Urology Associates, P.C., as a participating employer. Effective August 1, 2023, the Plan was amended to adopt Urology America MSO, LLC as the Plan Sponsor and add Urology Austin, PLLC as a participating employer. Effective August 1, 2023, the Plan was restated and amended to change the Plan's name from Urology Austin 401(k) Plan to Urology America MSO 401(k) Plan. Effective August 18, 2023, the Plan's provisions related to 411(d)(6) protected benefits were amended.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of not less than 1% and not more than 100% of their annual eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes safe harbor nonelective contributions of 3% of employees' compensation. The Company may also make additional discretionary matching and profit-sharing contributions. Company safe harbor contributions totaled \$1,138,187 and \$1,111,079 for the years ended December 31, 2024 and 2023, respectively. Company profit-sharing contributions totaled \$1,246,783 and \$1,322,632 for the years ended December 31, 2024 and 2023, respectively. The Company did not make discretionary matching contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. Automatically enrolled participants have their deferral rate set at 2% of annual eligible compensation. The automatic deferral feature also provides for an annual increase of 1% in the percentage deferred and is ultimately capped at 6%.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, including rollover contributions, and the Company's safe harbor contributions plus earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions, plus earnings thereon, is based on years of service. A participant is fully vested upon death, disability, or retirement. A participant is fully vested after five years of continuous service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate. Participants may only have one loan outstanding at a time. Principal and interest is paid ratably through monthly payroll deductions over a period generally not to exceed five years, unless the funds are used for purchase of a principal residence, in which case repayment terms may be extended.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account, partial withdrawals, or substantially equal installments. Withdrawals from the Plan may also be made upon circumstances of financial hardship. In-service distributions of all or a portion of a participant's vested account are permitted if the participant is at least age 59½.

Forfeited Accounts

Forfeitures are used to pay plan administration expenses or reduce employer contributions. Forfeitures of approximately \$382,000 and \$142,000 were used to reduce employer contributions as of and for the year ended December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Self-directed brokerage accounts (SDBA) allow a participant to direct the investment of the participant's contributions to the Plan among various investment options. The SDBAs are valued based on methodologies appropriate for the individual investments held, such as common stock, money market funds, and exchange traded funds. Common stock is valued at the closing price reported on the active market on which the individual securities are traded. Money market funds are valued as cash equivalents, which approximates fair value due to their short-term maturities. Exchange traded funds are valued at the daily closing price as reported by the fund. These funds are required to publicize their daily NAV and to transact at that price. The exchange traded funds held by the Plan are deemed to be actively traded.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust, the trustee of the Plan as of and for the year ended December 31, 2024 and 2023, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedules.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays any other fees related to the Plan's operations.

The Company also provides certain administrative services at no cost to the Plan.

Note 5. Plan Amendments

Effective January 1, 2023, the Plan was amended to add Urology Associates, P.C., as a participating employer. Effective August 1, 2023, the Plan was amended to adopt Urology America MSO, LLC as the Plan Sponsor and add Urology Austin, PLLC as a participating employer. Effective August 1, 2023, the Plan was restated and amended to change the Plan's name from Urology Austin 401(k) Plan to Urology America MSO 401(k) Plan. Effective August 18, 2023, the Plan's provisions related to 411(d)(6) protected benefits were amended. Effective November 3, 2023, the Plan was amended to add Conrad/Pearson Clinic, P.C. as a participating employer.

Note 6. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan holds no Level 3 securities.

Note 7. Investment Contract With Insurance Company

The Plan offers a fully benefit-responsive investment contract, the AUL Stable Value Account Series A, with American United Life Insurance Company (AUL). The trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

AUL may not terminate the contract at any amount less than contract value. Upon termination of the contract, a single sum equal to the aggregate withdrawal value of all participant accounts (participant account balances less the applicable withdrawal charge) will be payable to the Plan. AUL has the right to apply a withdrawal charge to any termination of employment payments made during a year (or 365-day trailing period) which exceed 20% of the aggregate account value as of the beginning of the year (or 365-day trailing period).

Certain events limit the ability of the Plan to transact at contract value with AUL. Such events include the following: (1) the Plan is changed so as to significantly affect AUL's obligations to the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract's requirements, (5) failure to provide information, (6) the sum of the contract account values after the first three contract years is \$100,000 or less, or (7) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator is not aware of any events which would limit the Plan's ability to transact at contract value with participants that are probable of occurring.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 9. Transfer of Plan Assets

An aggregate of \$397,541 was transferred into the Plan from the Employee Profit Sharing and Salary Reduction Plan of Urology Associates, P.C., during the year ended December 31, 2023 and is included as a transfer on the accompanying statement of changes in net assets available for benefits.

Note 10. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by OneAmerica Financial Partners, Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11. Nonexempt Transactions

As required by ERISA Section 2510.3-102, the plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. During 2024 and 2023, the Company failed to remit to the Plan's trustee certain employee contributions totaling \$526,641 and \$124,073, respectively, within the period prescribed by DOL regulations. Delays in remitting contributions to the trustee were due to administrative errors. The delayed contributions are considered prohibited, or nonexempt, transactions. The Plan is in the process of taking corrective action including payment of lost interest and related taxes and penalties on 2024 nonexempt transactions. The Plan corrected 2023 and 2022 nonexempt transactions in November 2024.
