#### Planned Scope and Timing of the Audit

During the performance of our audit, there were no significant changes to our audit scope, the nature and timing of the procedures we anticipated performing and the completion of our audit.

#### Compliance with All Ethics Requirements Regarding Independence

The engagement team, others in our firm, as appropriate, our firm, and our network firms have complied with all relevant ethical requirements regarding independence.

Auditing standards generally accepted in the United States of America require that we communicate at least annually with you regarding all relationships between our firm and the Plan and those in financial reporting oversight roles within the Plan that may reasonably be thought to bear on our independence. We are not aware of any relationship between our firm and the Plan that may reasonably be thought to bear on our independence. During 2024, we assisted in the preparation of the Plan's financial statements and footnotes.

We do not believe these additional services impacted our independence. We did not provide any other non-audit related services, which might impact or bear on our independence. Furthermore, we confirm to you that during the year ended December 31, 2024 and through the date of this letter, we have been and remain independent with respect to the Plan.

#### Significant Risks Identified

We have identified the following significant risks that were identified to you during the planning stage of our audit—no changes have been made to these risks:

- a. Contributions, specifically whether such contributions have been properly recognized in accordance with generally accepted accounting principles, whether contributions and plan compensation has been calculated correctly, and whether contributions are timely remitted in accordance with DOL rules and regulations.
- b. Lack of segregation of duties, specifically with regard to a management override of the Company's system of internal controls.

#### Qualitative Aspects of Accounting Practices

##### *Significant Accounting Policies*

Management has the responsibility to select and use appropriate accounting policies. A summary of the

significant accounting policies adopted by the Plan is included in notes to the financial statements. There has been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

#### *Significant Accounting Estimates*

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments. During the year ended December 31, 2024, management did not make any significant estimates or judgments throughout the normal course of the Plan's operations.

#### *Financial Statement Disclosures*

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the Plan financial statements relate to fair value estimate of mutual funds.

In addition, during the year ended December 31, 2024, there were several new accounting pronouncements issued by the various organizations that promulgate accounting standards. However, none of these newly issued standards will materially impact on your financial reporting process and no new accounting standards will be formally adopted by the Plan.

#### Significant Unusual Transactions

For the purposes of this communication, professional standards require us to communicate to you significant unusual transactions identified during our audit. We encountered no significant unusual transactions during our audit.

#### Identified or Suspected Fraud

We have not identified or have obtained information that indicates that fraud may have occurred.

#### Significant Difficulties Encountered During the Audit

We encountered no significant difficulties during our audit.

#### Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. This includes the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. Our audit procedures noted no known uncorrected

misstatements.

#### Disagreements with Management
