### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Storage Solutions, Inc. 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

### Opinion

## Notes to Financial Statements

### 1. Description of Plan

The following description of the Storage Solutions, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established on January 1, 2019, covering all employees of a controlled group, which includes Storage Solutions, Inc. and Warehouse Solutions, Inc. (the Plan Sponsor), except for union or leased employees and non-resident aliens. Employees may enter the Plan on the first day of the month after achieving two months of service and 21 years of age. The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective May 1, 2024, the Plan was amended to change the timing of elective deferrals to each pay period, and participants may stop their election to contribute at any time.

#### Contributions

Participants may contribute up to 100% of pretax annual compensation as defined by the Plan, up to the maximum allowable under the Internal Revenue Code (IRC), or designate all or a portion of elective deferrals as Roth elective deferrals. Participant contributions are presented net of prior-year corrective contributions distributed, if any. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans in the form of rollovers.

The Plan elected to be a Safe Harbor plan and includes matching contributions calculated as 100% of participant deferrals that do not exceed 3% of eligible compensation, plus 50% of participant deferrals that exceed 3% of eligible compensation up to 5% of eligible compensation. Employer Safe Harbor matching contributions were \$658,301 in 2024. The Plan Sponsor may elect to provide a discretionary profit-sharing contribution each plan year. The plan sponsor made a safe harbor match for 2024 of \$113,912, which was deposited on June 27, 2025. The extent and amount of each year's discretionary profit-sharing contributions, if any, are at the discretion of the Plan Sponsor. Any profit-sharing contribution will be determined by the Plan Sponsor. There were no discretionary profit-sharing contributions during 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, safe harbor matching contributions, allocations of the Plan Sponsor's discretionary profit-sharing contributions (if any), and Plan earnings, losses, and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their investments into various options offered by the Plan. The Plan offers 27 variable investment options through a pooled separate account and one guaranteed fixed interest account as investment options for participants.

### Vesting

Participants are immediately vested in their contributions, employer safe harbor matching contributions, plus actual earnings or losses thereon. Vesting in the Plan Sponsor's discretionary profit-sharing contributions is based on years of continuous service as follows:

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate as specified in the Plan Document, which was the prime rate plus 2% at the loan inception date for loans originating during 2024. The interest rate on loans outstanding at December 31, 2024, was 5.25% to 10.50%. Loan repayments are made ratably through payroll deductions over a period not to exceed five years, unless a loan is used to purchase a primary residence, in which case, a loan may be repaid up to a period not to exceed 30 years.

### Payment of Benefits

On termination of service, death, total and permanent disability, or retirement, participants or beneficiaries will receive a lump-sum amount equal to the value of their vested interest in his or her account. If, at termination, the participant's vested balance is \$5,000 or less, the Plan may distribute the entire vested balance out of the Plan, as allowable by the Plan. Partial distributions are allowed. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

### Forfeitures

Forfeitures from nonvested participant accounts may be used to reduce future employer contributions or administrative expenses. Forfeitures included in net assets were \$2,246 and \$32,150 at December 31, 2024 and 2023. Forfeitures used to reduce employer contributions in 2024 were \$39,894.

### Administrative Expenses

An annual administrative fee for processing Form 5500 (the Plan's annual tax filing) and a full-service fee based on the number of participants in the Plan are paid by the Plan Sponsor and excluded from the accompanying financial statements. Fees paid by the Plan, net of forfeitures

used, include trustee, custodian, and asset fees. Third-party fees are directly deducted from the individual participant's accounts as charged by the funds.

### Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). The presentation is permitted by the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Cash basis financial statements that adjust securities investments to fair value are considered to be prepared on a modified cash basis of accounting. Under the modified cash basis of accounting, certain additions and related assets are recognized when received rather than when earned, and certain deductions are recognized when paid rather than when the obligation is incurred.

The principal items that would be required to be reflected in the financial statements by US GAAP (the amounts of which are not practicable to determine) are as follows:

- Accrual of all contributions owed at each year-end but not received until the following year.
- Accrual of dividends declared but not paid.
- Accrual of interest income from participant loans earned at each year-end but not received until the following year.
- Accrual of the Plan expenses and management fees incurred at year-end but not paid until the following year.

#### Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### Notes Receivable From Participants

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance. Related fees are recorded as administrative expenses when they are incurred. The Plan classifies all participant loans with no payments received by the end of the calendar quarter following the calendar quarter in which the payment is first delinquent as in default. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits. There were no deemed distributions in 2024.

#### Fair Value Measurement

The Plan has determined the fair value of investments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Account: Valued at the net asset value (NAV) of units held by the Plan at year-end. The amounts allocated to the separate account are credited to a participant's account in the form of accumulation units. The value of an accumulation unit of any investment account is determined at the close of each business day and is directly related to the NAV of the shares of the underlying investment adjusted for any dividends or distributions received and the daily equivalent of any fee charged pursuant to the contract. Each investment account is invested exclusively in shares of a specific mutual fund. As a result, the fair value of the account is classified as Level 2.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Risks and Uncertainties

The Plan provides investment options in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities may occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for Plan benefits (modified cash basis).

The Plan had a concentration in individual investment funds greater than 10% in three funds totaling \$8,131,514 and four funds totaling \$7,451,847 at December 31, 2024 and 2023, respectively.

### Excess Contributions

Amounts paid to participants for contributions in excess of amounts allowed by the IRS are recorded as a reduction to contributions when paid. There were no excess contributions distributed in 2024.

### Payment of Benefits

Benefits are recorded when paid.

### 3. Information Certified by the Plan's Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Accordingly, the following investment information included in the accompanying financial statements and supplemental schedules as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was obtained and derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's custodian, Empower Annuity Insurance Company of America and Empower Trust Company, LLC:

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

#### **4. Investment, at Contract Value – Fixed Account**

The Plan maintains a guaranteed fixed interest account that is invested in a diversified portfolio consisting predominately of fixed-income investments (bond, mortgages, private placement, and short-term investments) where the objective is to maximize long-term, risk-adjusted returns. This account meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus credited interest less participant withdrawals and administrative expenses.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, may limit the Plan's ability to transact at contract value. The Plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is not probable.

#### **5. Related-party Transactions and Party-in-Interest Transactions**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These transactions qualify as party-in-interest transactions. The Plan allows participants to obtain loans from the Plan, which are also considered party-in-interest transactions. Fees paid by the Plan for administrative services were \$2,993 for the year ended December 31, 2024. Additional investment fees paid to the custodian are netted against investment returns. These party-in-interest transactions are not prohibited under ERISA.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts, and the balance of the net assets of the Plan would be allocated among the participants and beneficiaries as prescribed by ERISA.

### **7. Tax Status**

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by CCH Incorporated, DBA ftwilliam.com that obtained a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Pre-Approved Profit Sharing Plan Document, as then designed, was in compliance with the applicable requirements of the IRC and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, no provision for income taxes is included in the Plan's financial statements.

The Plan reviews its tax positions for uncertainty and records a provision for tax positions which may not be sustained based on their technical merits if examined by taxing authorities. At December 31, 2024 and 2023, there were no matters requiring a provision for uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Late Remittances**

The Plan remitted certain employee deferrals late, totaling \$290 in 2023. Lost earnings of \$3 related to the 2023 late remittances were contributed in 2024.

### **9. Subsequent Events**

Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.
