## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Waterfall Asset Management, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the Waterfall Asset Management LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s information.

**General**—The Plan is a defined contribution plan covering substantially all employees of Waterfall Asset Management LLC (the “Company” or “Employer”) who are not covered by another plan. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company serves as the custodian of the Plan and Principal Life Insurance Company serves as the insurance carrier of the Plan. Prime Pensions Inc. serves as the administrator of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary profit-sharing contributions made by the Company, and (iv) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the Plan.

Participants may elect to contribute a percentage or dollar amount up to 50% of their eligible compensation, to the Plan each year, subject to the limitations, as defined in the Plan document. Traditional contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company matches 100% of the first 2% of eligible compensation that a participant contributes to the Plan. The Company matching contribution for year-end December 31, 2024 totaled \$719,795. The Company may also make a discretionary profit-sharing contribution. During the year ended December 31, 2024, the Company made \$966,272 discretionary profit-sharing contribution to the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related Company contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments**—Participants may direct the investment of their contributions, Company matching contributions, and discretionary profit-sharing contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

**Vesting**—All employer and employee contributions as well as earnings on such contributions are vested 100% at time of contribution.

**Notes Receivable from Participants**—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The loans are secured by the participant's vested interest in the Plan, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator plus 1%. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from one year to five years, however, terms may exceed five years for the purchase of a primary residence. As of December 31, 2024, participant loans have maturities through 2029 at interest rates ranging from 4.25% to 9.50%.

**Payment of Benefits**—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or monthly, quarterly or annual installments. Benefit payments in the form of installments are only available for participants who are required to receive lifetime minimum distributions.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**Forfeited Accounts**—Because all contributions are vested immediately, there is no provision for forfeited accounts.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as geopolitical concerns and uncertainty. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

**Concentrations of Investments** - Included in investments at December 31, 2024 and 2023 are shares of Principal LargeCap S&P 500 Index SA-z Separate Account of \$3,244,663 and \$2,854,837, respectively. This investment represents 11% percent and 11% of total investments at December 31, 2024 and 2023

respectively. A significant decline in the market value of the fund would significantly affect the net assets available for benefits.

**Investment Valuation and Income Recognition**—The Plan’s investments are stated at fair value, except for the fully benefit-responsive guaranteed investment contract (the “GIC”), which is reported at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 6). See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Contributions**—Employee contributions are recorded when withheld. Employer matching and discretionary profit-sharing contributions are recorded when earned.

**Administrative Expenses**—Administrative expenses of 0.41% through December 31, 2024 per participant (based on the average monthly account balance) are deducted from participant accounts each month. Participants also pay administrative costs for loans, distributions, and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024 or 2023.

**Excess Contributions Payable**—There were no excess contributions due to participants as of December 31, 2024 and 2023.

**Subsequent Events**—Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued. No events occurred that require additional disclosure or adjustment to the Plan’s financial statements.

### 3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that were prepared by or derived from information prepared by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodian of the Plan, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, and Principal Life Insurance Company, collectively, the insurance carrier for the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the custodian and insurance carrier that such information is complete and accurate.

### 4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification 820, *Fair Value Measurement*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds**—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts*—The NAV as provided by the insurance carrier is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

*Collective Trust Funds*—Valued at the NAV of units of a bank collective trust. The NAV as provided by the insurance carrier is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

## 6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

A portion of the Plan's assets are held in a GIC with Principal Life Insurance Company. The GIC is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus income earned, less funds used to pay benefits to participants and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Limitations on the Ability of the GIC to Transact at Contract Value**—Amounts invested in the GIC may be subject to certain restrictions if the contract is terminated. Principal Life Insurance Company has control of the assets held under the GIC. The value of the GIC is subject to the financial stability of Principal Life Insurance Company. There are no reserves against contract value for credit risk of the contract issuer or otherwise. If the Plan exercises a termination option available under the GIC, a surrender charge would apply and participant transactions would no longer be at contract value. Plan

management does not intend to terminate the contract. Principal Life Insurance Company may not terminate the contract at any amount less than the contract value.

Principal Life Insurance Company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate of the GIC is reset quarterly as determined by Principal Life Insurance Company. The rate that is credited to participant accounts will be the greater of the actual crediting rate or a minimum 1.5% floor rate.

**7. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Trust Company or an affiliate of Principal Trust Company. Principal Trust Company is the custodian, as defined by the Plan. Principal Life Insurance Company is the issuer of the GIC. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

**8. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

**9. FEDERAL INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by Prime Pensions Inc. Prime Pensions Inc. received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The prototype Plan document has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.
