Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of My Wireless 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of My Wireless 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1 – Plan Description

The following description of the My Wireless 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan was established on January 1, 2015, and restated effective September 1, 2019, and is intended to qualify under section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration – The Plan is sponsored by Digital PCS Nevada, Inc. (the Company or Sponsor), which also serves as the plan administrator. Reliance Trust Company (Reliance Trust or Trustee) is the Plan's trustee and maintains the Plan's assets. ADP Retirement Services (ADP) is the Plan's record keeper.

Eligibility – Full-time employees of the Company and participating employers who have attained age 21 and completed 12 months of service are eligible to participate in the Plan. However, non-resident aliens, and union employees are excluded from participating in the Plan. There are no additional requirements for participants to receive Employer matching contributions. In order to be eligible for Employer profit sharing contributions, if any, participants must be employed as of the last day of the Plan year, and have completed at least 1,000 hours of service during the Plan year.

Contributions – Plan participants may make contributions of up to 90% of pretax annual compensation, as defined in the Plan, and not in excess of the maximum allowed by the IRC. However, highly compensated employees (as defined by the Plan) may be subject to further limitations. Employees who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified plans. All participant contributions are participant-directed by the participant in one or more of the investment options offered under the Plan. Contributions are subject to IRC regulation limitations.

The Plan provides for the Company to make matching contributions of 50% of a participant's elective deferrals, up to a maximum of 6% of eligible compensation. The Plan also provides for employer discretionary profit-sharing contributions based upon a discretionary percentage of each participant's deferral contributions as determined by the Sponsor. No discretionary profit-sharing contributions were approved or made during the year ended December 31, 2024.

Participants' accounts – Participants' contributions are invested in various funds according to participant elections and must be allocated among the available funds in whole percentages. Individual accounts are maintained for each of the Plan's participants to reflect each participant's contributions and related employer contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of the plan income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are 100% vested at all times in their deferral contributions, plus actual earnings or losses thereon.

Vesting in employer matching contributions, and Employer profit sharing contributions, if any, is based on years of continuous service. Participants vest in accordance with the following schedule:

Forfeited accounts – If a participant’s employment is terminated before full vesting of employer contributions and related earnings are attained, the amount not vested is allocated to pay any administrative expenses of the Plan or to reduce any employer contributions. Forfeited non-vested accounts totaled \$12,190 and \$8,179, respectively, at December 31, 2024 and 2023. During the year ended December 31, 2024, forfeitures of \$11,703 were used to reduce employer contributions.

Payment of benefits – Distributions and withdrawals are payable upon retirement, termination of employment, financial hardship, disability, or death. Upon termination, if a participant's vested account balance is equal to or less than \$1,000, the balance is immediately distributed as a lump-sum payment. Upon termination, if a participant's vested account balance is greater than \$1,000 and less than \$5,000, their balance shall be automatically rolled over into an individual retirement account designated by the Plan administrator, unless otherwise elected. Upon termination, if a participant's vested account balance is greater than or equal to \$5,000, the participant (or beneficiary) may elect to receive a distribution of their account balance as a lump-sum payment, as partial payments, in substantially equal installments, or postpone payment to a later date and remain in the Plan.

Hardship withdrawals – A withdrawal from a participant’s account may be permitted if the participant has a financial hardship for certain specific reasons as defined in the Plan Document.

Participant loans – Participants may borrow not less than \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants (participant loans) must be repaid within five years, unless the participant's loan is used to acquire a primary residence, in which case the repayment term may exceed five years. Participant loans are secured by the respective participant's vested account balance. Participant loans bear interest at a rate commensurate with local prevailing rates for instruments with similar characteristics at the time of issuance. Principal and interest are generally paid ratably through payroll deductions with payments made each pay period. Outstanding participant loans at December 31, 2024, bear interest at annual rates of between 4.25% and 9.50% and mature at various rates through October 2026.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could materially differ from those estimates.

Investment valuation – Investments are stated at fair value (see Note 3).

The Plan's trustee, Reliance Trust Company, certifies the fair value of all investments. In accordance with the policy of stating plan assets at fair value, the Plan presents the net appreciation in the fair value of its investments in the statement of changes in net assets, which consists of the realized gains or losses and the unrealized appreciation on those investments.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest and other income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits – Benefit payments are recorded when paid.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loans to be in default, the participant loan is reduced and a benefit is recorded.

Administrative expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Excess contributions payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – The fair value of mutual funds is determined based on quoted market prices in active markets, which represent the net asset value of shares of the mutual fund held by the Plan at year end. Mutual funds are classified in Level 1 of the valuation hierarchy.

Common and collective trusts – Units of the common and collective trusts are stated at net asset value (NAV) which is based on the aggregate fair value of the underlying assets of the trust in relation to the total number of units outstanding. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations will be carried out in an orderly business manner.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividends, and interest, and other income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and;
- Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 5 – Income Tax Status

The Internal Revenue Service (IRS) issued a determination letter dated October 6, 2020, stating that the prototype plan adopted by the Plan was designed in accordance with the applicable IRC requirements as of that date. Although the Plan has been amended since the date of the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes is reflected in the accompanying financial statements. Continued qualification is dependent on the Plan's future operations.

In accordance with GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that is more-likely-than-not to be sustained upon audit by the IRS. An uncertain income tax position will not be recognized if it has less than a 50% likelihood of being sustained. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds and common collective trusts. Such investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in their value, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 – Plan Termination

Although the Company has not expressed any such intention, the Plan may be discontinued at any time by the Company. In the event of termination, participants' rights to company contributions become fully vested and the net assets of the Plan would continue to be held for normal withdrawal by participants assuming the Company's operations continue, or would be distributed to participants immediately if the Company's operations cease.

Note 8 – Subsequent Events

Plan management has evaluated and determined that no events have occurred subsequent to December 31, 2024, the date of the accompanying net assets available for benefits, through October 13, 2025, the date of issuance of these financial statements, which would require recording or disclosure in its financial statements.
