Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the Fortson-Peek Company, Inc. 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statement of Net Assets Available for Benefits as of December 31, 2024, the related Statement of Changes in Net Assets Available for Benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Predecessor auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated September 30, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1: Description of Plan

The following brief description of the Fortson-Peek Company, Inc. 401(K) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan sponsored by Fortson-Peek Company, Inc. (the “Plan Sponsor”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all eligible employees of the Plan Sponsor and Peek Pavement Marking, LLC. The Plan was originally adopted on November 1, 1972 and has since been amended and restated. The Plan was amended effective January 1, 2024 to adopt certain employer safe harbor matching contribution provisions. See Note 7 for a subsequent amendment to allow hardship distributions.

The Leadership Team, appointed by the Plan Sponsor, has responsibility for the administration of the Plan. Reliance Trust Company served as trustee through December 31, 2024; however, the Plan changed to ADP Retirement Trust Services, LLC (“ADP Trust”) as trustee subsequent to year end. See Note 7. The Plan’s trustee is responsible for the management, operation and administration of the Plan’s trust fund. ADP Retirement Services (“ADP”) serves as the Plan custodian and recordkeeper. A fee is charged for trustee, recordkeeping, and custodial services rendered.

Eligibility - Employees must have completed three months of qualified service based on time elapsed. Participants are automatically enrolled into the Plan at a 1% deferral rate on the first of the month coincident with or next following the meeting of the participation requirement.

Contributions - Participants may contribute, on a pre-tax or post-tax (Roth) basis, a specified dollar amount of their compensation, up to the Internal Revenue Code (“IRC”) limitations, as defined in the Plan. Also, participants may transfer to the Plan account balances from previously existing qualified Plans. Prior to January 1, 2024, the Plan Sponsor made matching contributions equal to a discretionary dollar amount, which was determined by the Plan Sponsor. The matching contribution for 2023 was \$1,000 per participant. Effective January 1, 2024, the Plan was amended such that the Plan Sponsor will make a safe harbor matching contribution equal to 100% of the participants’ salary deferrals up to 3% of compensation plus 50% of the participants’ salary deferrals between 3% and 5% of compensation. Additionally, the amendment added a “true-up” contribution provision to the Plan.

The Plan Sponsor may also make a discretionary contribution to the Plan as determined annually by the Leadership Team. The Plan Sponsor elected not to make discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts - Each participant's account is credited with the participant's contributions, an allocation of the Plan Sponsor's matching and discretionary contributions, when applicable, and Plan earnings and losses. Each account is also charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan.

Vesting - Participants are immediately vested in their contributions, plus actual earnings thereon. Participants are also immediately vested in the Plan Sponsor's discretionary and matching contributions plus actual earnings thereon.

Unallocated accounts - Unallocated accounts consist of advance deposits made by the Plan Sponsor and forfeitures, which represent the non-vested portion of a participant's account balance that is forfeited upon termination. They may be used to reduce the Plan Sponsor's contributions and pay Plan expenses in accordance with Plan specifications.

Investment Options - A participant may direct participant and employer contributions in any of the investment options established by the Leadership Team. Participants may change their investment options daily.

Payment of Benefits - Upon termination of employment due to death, disability, retirement, or other reasons, participants will be entitled to receive distribution of their balances in a lump-sum amount or in installments. The Plan also allows for in-service withdrawals of a participant's vested interest upon reaching the age of 59 ½.

Plan Termination - Although there is no present intention to terminate the Plan, the Plan Sponsor may terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, the trustee shall dispose of the Plan assets by distribution to participants and their beneficiaries.

NOTE 2: Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of the valuation and methodologies used to determine each investment's respective fair value.

Net appreciation of the fair value of investments consists of the unrealized appreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Plan Expenses - Significant costs of administering the Plan are absorbed by the Plan Sponsor and are not reflected in these financial statements. These costs include legal, administrative, accounting and trustee fees. Certain investment management fees and administrative expenses, including audit fees, are incurred and paid by the Plan. Other investment related expenses are included in net appreciation of fair value of investments.

Tax Status - The Plan obtained its latest determination letter dated October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America, ("GAAP") require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or state or local taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods; however, there are currently no audits for any tax periods in progress.

Reclassification - Certain items in the 2023 financial statements have been reclassified in order to be in conformity with the 2024 statement presentation.

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 3: Fair Value Measurement

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at net asset value of shares held by the Plan at year end.

Common/Collective Trusts ("CCT"): A detailed description of the valuation methodologies of the CCT can be found in the footnotes of the Invesco Stable Asset - ADPZ audited financial statements.

NOTE 5: Party-in-Interest Transactions

Certain Plan transactions are affiliated with ADP who serves as third-party administrator as defined by the Plan; therefore, these transactions qualify as party-in-interest. Certain fees incurred by the Plan for services provided are included in net appreciation in fair value of investments rather than a direct payment.

NOTE 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 7: Subsequent Events

The Plan's Leadership Team has evaluated all subsequent events that may qualify for disclosure through October 10, 2025, which is the date the financial statements were available to be issued. Beginning January 1, 2025, ADP Trust became the trustee of the Plan. Additionally, the Plan Sponsor was acquired by Frontline Road Safety Operations, LLC on August 21, 2025, and the name of the Plan was changed to the Peek Pavement Marking, LLC 401(k) Plan. There were no changes to Plan provisions as a result of the acquisition. Also, in September of 2025 the Plan was amended to allow hardship distributions effective October 1, 2025. There were no other transactions requiring disclosure under professional guidance.
