### 1. Description of the Plan

The following description of the Paramount Die Company, Inc. (the Company) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- A. General – The Plan is a defined contribution plan covering substantially all employees of the Company. Employees are allowed to enter the Plan after completing at least three months of service by the next plan entry date. Participants must also reach the age of 21 to become eligible to make salary deferrals or to receive employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's management oversees governance of the Plan, the appropriateness of the Plan's investment offerings, and monitors investment performance.
- B. Contributions – Each year, participants may contribute up to 80% of their eligible annual compensation, as defined by the Plan. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation and their contributions invested in a target date fund until changed by the participant. The Plan also includes an auto-escalation provision whereby the deferral rate is increased each year until the deferral rate reaches 8 percent, unless a participant elects otherwise. The Company contributes a percentage of base compensation that a participant contributes to the Plan. For the plan year ended December 31, 2024, the Company made a discretionary matching contribution of 15 percent of the first 8 percent of base compensation that a participant contributed to the Plan. The Company may also make discretionary non-elective contributions to the Plan to be allocated to all employees eligible to participate in the Plan. The Company made no discretionary non-elective contributions to the Plan for the year ended December 31, 2024. Contributions are subject to certain statutory limitations.

### 1. Description of the Plan (continued)

- C. Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the Company’s matching and discretionary non-elective contributions according to the following graduated vesting schedule:

- E. Notes Receivables from Participants – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at rates of prime plus 2%, which is commensurate with local prevailing rates as determined by the plan administrator at the origination of the loan. Principal and interest is paid ratably through payroll deductions.
- F. Payment of Benefits – Upon termination of service, retirement (age 65), death, disability, or attainment of age 59 ½, a participant or their beneficiary, in the event of death, is entitled to a distribution of their vested account balance, as defined by the plan agreement. Distributions from the Plan are payable in the form of a lump sum payment. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, contributed deferral amounts may be withdrawn for hardship purposes. Distributions are subject to the applicable provisions of the plan agreement. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.
- G. Forfeited Accounts – Upon a participant terminating from the Plan, non-vested employer contributions can be used to reduce future Company contributions to the Plan and to pay for administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$959 and \$3,798, respectively. Also, in 2024, employer contributions were reduced by \$3,386 from forfeited nonvested accounts.

### 2. Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan’s valuation policies. See Note 4 for discussion of fair value measurements.

**Purchases and sales of securities** are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

**Payment of Benefits** – Benefits are recorded when paid.

**Excess Contributions Payable** – For the years ended December 31, 2024 and 2023, amounts payable to participants totaling \$-0- and \$24,595, respectively, for contributions in excess of amounts allowed by the IRS are recorded in excess contributions payable with a corresponding reduction to contributions. The Plan distributed the excess contributions in the following year.

### 2. Significant Accounting Policies (continued)

Expenses – Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

### 3. Information Prepared and Certified by ADP Retirement Trust Services, LLC and Reliance Trust Company

The following information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustees. ADP Retirement Trust Services, LLC certified information as of December 31, 2024 and from September 5, 2024 through December 31, 2024. Reliance Trust Company certified information from January 1, 2024 through September 4, 2024 and as of December 31, 2023.

### 4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

#### *Level 1 Fair Value Measurements*

*Registered Investment Companies (mutual funds):* Valued at the daily closing price as reported by the funds. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

In accordance with FASB ASU 2015-07, certain investments that are measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy.

*Common Collective Trusts:* Valued at the NAV of shares in each account held by the Plan at year end. The net asset value is not a publicly-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 at the end of the reporting period. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

## 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its participation at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company' contributions.

## 6. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subjected to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
