Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Unique People Services 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Unique People Services 401(k) Profit Sharing Plan (the "Plan") provides only general information. Readers should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

- A. **General** - The Plan is a defined contribution 401(k) plan covering all full or part-time employees of Unique People Services, Inc. (the "Employer" or "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments. The effective date of the Plan was January 1, 2001 and it was amended on January 15, 2014 and May 26, 2022.
- B. **Eligibility** - All employees who have completed twelve months and 1,000 hours of service, are age 18 or older and are not subject to a collective bargaining agreement are eligible to participate in the Plan. Participation in the Plan begins on the first day of each calendar month of the Plan year coincident with or immediately following the satisfaction of the eligibility requirements. Effective January 15, 2014, employees were allowed to participate and contribute their own money to the Plan upon hire.
- C. **Contributions** - Each year, participants may elect to contribute a percentage of their pre-tax annual compensation limited to the amounts prescribed by the Internal Revenue Code (the "Code"). Participants who make elective deferrals and who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Sponsor's profit-sharing contributions to the Plan are made at its discretion. Effective on July 1, 2018, the Sponsor's profit-sharing contributions were 5% of the participants' pre-tax annual compensation. However, participants must have completed twelve months and 1,000 hours of service, are age 18 or older, and are not subject to a collective bargaining agreement in order to be eligible to receive profit-sharing contributions.
- D. **Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of the Sponsor's profit-sharing contributions, Plan earnings and administrative expenses. Allocations are based on participant earnings, deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.
- E. **Vesting** - Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service and is as follows:

F. **Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with the prime rate of interest charged by the Employer's commercial bank plus 1.0%. Loan repayments are made ratably through payroll deductions over a period not to exceed five years, except for the purchase of a principal residence which may be repaid within a reasonable time determined at the time the loan is made. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant. Effective January 15, 2014, participants are allowed a maximum of only two concurrent outstanding loans at any point in time.

Loan balances of \$68,089 and \$60,445 during 2024 and 2023, respectively, were defaulted on and reported as deemed distributions in the accompanying financial statements.

G. **Payment of Benefits** - Participants may make withdrawals from their accounts at age 59½ or prior to that age in the case of hardship, provided all other resources are already utilized, including loans from the participants' accounts. Upon termination of service due to death, disability or retirement, a participant or participant's beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

H. **Forfeited Accounts** - As of December 31, 2024 and 2023, unapplied forfeited accounts totaled \$82,114 and \$75,952, respectively. These accounts are generally used to reduce future Employer contributions. In 2024 and 2023, employer contributions were reduced by \$63,642 and \$16,844 from forfeited nonvested accounts, respectively. During the years ended December 31, 2024 and 2023, the forfeiture account increased by \$6,162 and \$28,727, respectively.

I. **Administrative Expenses** - Certain administrative expenses of the Plan are paid directly by the Sponsor. Administrative expenses recorded by the Plan represent custodian fees and other recordkeeping fees paid directly from the Plan to the Plan's custodian. Loan fees are deducted directly from the participant's account.

J. **Regulatory Compliance Affecting Retirement Plans** - The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE Act made major changes to the Required Minimum Distribution ("RMD") rules, increasing the age from 70 ½ to 72 for participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 plan year.

The SECURE Act 2.0 (SECURE 2.0) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030. The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024.

In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year.

Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. **Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan adheres to accounting principles generally accepted in the United States of America ("U.S. GAAP").
- B. **Use of Estimates** - The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. **Investment Valuation and Income Recognition** - Investments are reported at fair value, except for fully benefit-responsive contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- D. **Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.
- E. **Payment of Benefits** - Benefits payments to participants are recorded upon distribution.

NOTE 3 - INVESTMENTS - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan administrator has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information for 2024 and 2023 was certified as complete and accurate by Empower Annuity Insurance Company of America ("Empower"), formerly Massachusetts Mutual Life Insurance Company ("Mass Mutual"), the Plan's custodian and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Separate Accounts:

Separate accounts are valued using net asset value ("NAV") of shares held at year end as determined by the issuer of the fund as a practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (1) **Separate Accounts:** The primary objectives of these accounts are to approximate the risk and return characteristics of the S&P 500 index. This index is commonly used to represent the large cap segment of the U.S. equity market. To achieve its objective, the accounts employ a replication technique which generally seeks to hold each index constituent in its proportional index weight. The accounts may make limited use of futures and/or options for the purpose of maintaining equity exposure.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY - INFORMATION PREPARED AND CERTIFIED BY THE INVESTMENT CUSTODIAN AS COMPLETE AND ACCURATE

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower, formerly Mass Mutual, totaling \$763,878 and \$718,947 in 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer, but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity-wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments as of December 31, 2024 and 2023 are shares of separate accounts and a guaranteed investment account managed by Empower who is also the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Generally, Plan administrative fees were paid by the Sponsor. The Plan allows participants to take loans against their account balances, which are considered exempt party-in-interest transactions.

Administrative expenses paid for by the Plan amounted to \$12,404 and \$7,980 for the years ended December 31, 2024 and 2023, respectively.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Sponsor contributions. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Sponsor may determine.

NOTE 8 - TAX STATUS

The Sponsor has obtained an Internal Revenue Service opinion for the Non-standardized pre-approved Profit Sharing Plan with Cash or deferred arrangement ("CODA") issued to Associated Pension Consultants, Inc., dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – REFUND OF EXCESS CONTRIBUTIONS LIABILITY

Subsequent to December 31, 2023, certain participant contributions were deemed to be excess contributions under the Code. Such contributions and the related investment earnings thereon were refunded to Plan participants. A liability for excess contributions of \$9,708 was recorded in the Plan's financial statements as of December 31, 2023.

NOTE 11 – DELINQUENT PARTICIPANT CONTRIBUTIONS

In accordance with the DOL's Regulation 2510.3102, an employer is required to segregate participants' contributions from its general assets as soon as practical, but in no event later than the 15th business day following the end of the month in which amounts are contributed by participants or withheld from their wages for a pension benefit plan such as the 401(k) Plan. In 2024, the Sponsor failed to timely remit two payments totaling to \$62,028 for participant contributions withheld during the year ended December 31, 2024. During 2025, the Plan Sponsor remitted any lost earnings to the affected participants.

NOTE 12 - SUBSEQUENT EVENTS

Management has evaluated, for potential recognition and disclosure, events subsequent to the date of the statement of net assets available for benefits through October 14, 2025, the date the financial statements were available to be issued.
