### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Star Exhibits & Environments, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on October 1, 1993. The Plan agreement underwent legislative restatement to the third six-year cycle effective January 1, 2022.

#### **Eligibility**

All employees of Star Exhibits & Environments, Inc. (the "Company") that are at least 18 years of age and have completed one month of eligibility service are eligible to join the Plan on the first day of the next month that these requirements were met. Employees, who did not satisfy the months of eligibility service, are eligible to enter the Plan upon completion of 1,000 hours to constitute a year of eligibility service, and 500 hours must be exceeded to avoid a break in eligibility service.

#### **Contributions**

Participants may, after meeting eligibility requirements, contribute a percentage of their pre-tax annual compensation, as defined in the Plan. The Plan allows after-tax (Roth) contributions. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation, with an automatic 1% increase in the beginning of the following year, up to a maximum of 6%. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will contribute for each participant a safe harbor matching contribution equal to 100% of the first 1% plus 50% of the next 5% of the elective contributions made by the participants, but not more than the first 6% of compensation the employee contributes to the Plan through salary deferral. The Company may also make discretionary qualified matching and profit-sharing contributions. During 2024 and 2023, the Company elected not to make discretionary contributions into the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are fully vested in safe harbor matching contributions after two years of service. Participants vest ratably 20% each year in discretionary qualified matching and profit-sharing contributions and are fully vested at the end of five years of credited service. If a participant dies or becomes disabled while an employee of the Company, they will become 100% vested.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum number of outstanding loans at any time is two. The loans are secured by the balance in the participant's account and bear interest at 2% over the Prime Rate on the date of the loan request. Principal and interest is paid ratably through payroll deductions. If note payments by participants are delinquent, they are considered a deemed distribution in the Plan year they are delinquent.

**Payment of Benefits**

Participants or designated beneficiaries may receive distributions from the Plan upon death, disability, retirement, termination of service, or certain "in-service" situations, as defined by the Plan. A participant may elect to receive a lump sum amount equal to the vested value of their account or a non-recurring partial payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Normal retirement age is 65. In-service withdrawals of elective deferrals are allowed after a participant attains age 59.5. In-service withdrawals of matching and profit-sharing contributions are allowed after a participant attains age 65. Upon termination of employment, the participant's eligible vested account balance may remain in the Plan if the balance is over \$7,000. Balances between \$1,000 and \$7,000 are automatically rolled over to a qualified individual retirement account. Balances under \$1,000 are automatically distributed.

**Forfeited Accounts**

Forfeitures resulting from a terminated participant's failure to be fully vested in the employer contributions to the Plan are used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,606 and \$13,212, respectively and were available for future use. No forfeitures were used to offset employer contributions during the year ended December 31, 2024. During the year ended December 31, 2023, employer contributions were reduced by \$983 from forfeited nonvested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments in mutual funds are stated at fair value. Fair values are determined by reference to security exchanges at the last reported sales price on the last business day of the Plan year. The Plan's investments in collective trust funds are valued at net asset value (NAV) as a practical expedient to fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Net Appreciation in Fair Value of Investments**

Net appreciation in the fair value of investments represents the net realized gains and the net unrealized appreciation of investments. Realized gains or losses are the difference between the proceeds received and either the cost of the investment sold, determined on a first-in, first-out basis, or the fair value at the end of the previous year, whichever is applicable. Unrealized appreciation is the change in the difference between fair value and the cost of investments or the fair value at the end of the previous year, whichever is applicable.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Funding Policy**

Safe harbor matching contributions are generally remitted to the Plan at the same time as employee deferrals. Discretionary contributions are remitted to the Plan generally following the end of the Plan year.

**Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* valued at the NAV as a practical expedient to fair value based on the fair value of underlying investments at year-end.

*Stable value collective trust fund:* a stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust at year-end. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value:

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

The following events may limit the ability of the Plan to transact at contract value:

- The Plan's failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Any communication given to Plan participants designed to influence a participant not to invest in the Fund or to transfer assets out of the Fund.
- Any change in law, regulation, or administrative ruling applicable to the Plan that could have material adverse effect on the Fund's cash flow.
- Any transfer of assets from the Fund directly into a competing investment option.
- The establishment of a defined contribution plan that competes with the Plan for employee contributions.
- Complete or partial termination of the Plan or its merge with another plan.
- Any substantive modifications of the Fund or the administration of the Fund that is not consented to by the wrap issuer.
- Any substantive modifications of the Fund or the administrative ruling applicable to a plan investing in the Fund that could have a material adverse effect on the Fund's cash flow.

Plan management believes the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

**NOTE 4 - CERTIFICATIONS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan).

**NOTE 5 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Company has been designated as the plan administrator and plan sponsor. Certain employees provide administrative services to the Plan. These services are provided at no cost to the Plan.

Certain Plan investments are managed by the Vanguard. Vanguard is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Notes receivable from participants also qualify as party in interest transactions.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7 - INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the prototype plan, on which the Plan is based, is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, delinquent contributions of \$116, were not remitted to the Plan on a timely basis as required by the United States DOL regulations. As such, the late deposits are considered prohibited transactions. These delinquent contributions and related lost earnings were corrected in 2025.

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Star Exhibits & Environments, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on October 1, 1993. The Plan agreement underwent legislative restatement to the third six-year cycle effective January 1, 2022.

#### **Eligibility**

All employees of Star Exhibits & Environments, Inc. (the "Company") that are at least 18 years of age and have completed one month of eligibility service are eligible to join the Plan on the first day of the next month that these requirements were met. Employees, who did not satisfy the months of eligibility service, are eligible to enter the Plan upon completion of 1,000 hours to constitute a year of eligibility service, and 500 hours must be exceeded to avoid a break in eligibility service.

#### **Contributions**

Participants may, after meeting eligibility requirements, contribute a percentage of their pre-tax annual compensation, as defined in the Plan. The Plan allows after-tax (Roth) contributions. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation, with an automatic 1% increase in the beginning of the following year, up to a maximum of 6%. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will contribute for each participant a safe harbor matching contribution equal to 100% of the first 1% plus 50% of the next 5% of the elective contributions made by the participants, but not more than the first 6% of compensation the employee contributes to the Plan through salary deferral. The Company may also make discretionary qualified matching and profit-sharing contributions. During 2024 and 2023, the Company elected not to make discretionary contributions into the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions and Plan earnings or losses. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are fully vested in safe harbor matching contributions after two years of service. Participants vest ratably 20% each year in discretionary qualified matching and profit-sharing contributions and are fully vested at the end of five years of credited service. If a participant dies or becomes disabled while an employee of the Company, they will become 100% vested.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum number of outstanding loans at any time is two. The loans are secured by the balance in the participant's account and bear interest at 2% over the Prime Rate on the date of the loan request. Principal and interest is paid ratably through payroll deductions. If note payments by participants are delinquent, they are considered a deemed distribution in the Plan year they are delinquent.

**Payment of Benefits**

Participants or designated beneficiaries may receive distributions from the Plan upon death, disability, retirement, termination of service, or certain "in-service" situations, as defined by the Plan. A participant may elect to receive a lump sum amount equal to the vested value of their account or a non-recurring partial payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Normal retirement age is 65. In-service withdrawals of elective deferrals are allowed after a participant attains age 59.5. In-service withdrawals of matching and profit-sharing contributions are allowed after a participant attains age 65. Upon termination of employment, the participant's eligible vested account balance may remain in the Plan if the balance is over \$7,000. Balances between \$1,000 and \$7,000 are automatically rolled over to a qualified individual retirement account. Balances under \$1,000 are automatically distributed.

**Forfeited Accounts**

Forfeitures resulting from a terminated participant's failure to be fully vested in the employer contributions to the Plan are used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,606 and \$13,212, respectively and were available for future use. No forfeitures were used to offset employer contributions during the year ended December 31, 2024. During the year ended December 31, 2023, employer contributions were reduced by \$983 from forfeited nonvested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments in mutual funds are stated at fair value. Fair values are determined by reference to security exchanges at the last reported sales price on the last business day of the Plan year. The Plan's investments in collective trust funds are valued at net asset value (NAV) as a practical expedient to fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Net Appreciation in Fair Value of Investments**

Net appreciation in the fair value of investments represents the net realized gains and the net unrealized appreciation of investments. Realized gains or losses are the difference between the proceeds received and either the cost of the investment sold, determined on a first-in, first-out basis, or the fair value at the end of the previous year, whichever is applicable. Unrealized appreciation is the change in the difference between fair value and the cost of investments or the fair value at the end of the previous year, whichever is applicable.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Funding Policy**

Safe harbor matching contributions are generally remitted to the Plan at the same time as employee deferrals. Discretionary contributions are remitted to the Plan generally following the end of the Plan year.

**Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* valued at the NAV as a practical expedient to fair value based on the fair value of underlying investments at year-end.

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

*Stable value collective trust fund:* a stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust at year-end. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

The following events may limit the ability of the Plan to transact at contract value:

- The Plan's failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Any communication given to Plan participants designed to influence a participant not to invest in the Fund or to transfer assets out of the Fund.
- Any change in law, regulation, or administrative ruling applicable to the Plan that could have material adverse effect on the Fund's cash flow.
- Any transfer of assets from the Fund directly into a competing investment option.
- The establishment of a defined contribution plan that competes with the Plan for employee contributions.
- Complete or partial termination of the Plan or its merge with another plan.
- Any substantive modifications of the Fund or the administration of the Fund that is not consented to by the wrap issuer.
- Any substantive modifications of the Fund or the administrative ruling applicable to a plan investing in the Fund that could have a material adverse effect on the Fund's cash flow.

Plan management believes the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

**NOTE 4 - CERTIFICATIONS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan).

**NOTE 5 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Company has been designated as the plan administrator and plan sponsor. Certain employees provide administrative services to the Plan. These services are provided at no cost to the Plan.

Certain Plan investments are managed by the Vanguard. Vanguard is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Notes receivable from participants also qualify as party in interest transactions.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7 - INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the prototype plan, on which the Plan is based, is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, delinquent contributions of \$116, were not remitted to the Plan on a timely basis as required by the United States DOL regulations. As such, the late deposits are considered prohibited transactions. These delinquent contributions and related lost earnings were corrected in 2025.
