NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the Two Roads Brewing Company LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan, established on January 1, 2020, covering substantially all employees of Two Roads Brewing Company LLC (the Company or Plan Sponsor) who have completed six months of consecutive service and are age 21 or older. Participants are eligible to participate on the first of the month coinciding with or next following the date requirements are met. Participants must complete one year of service to receive the Company matching contribution and discretionary nonelective profit sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The plan administrator oversees governance of the Plan, determines the appropriateness of the Plan's investments and monitors investment performance.

Participant Contributions and Investment Options:

Participants may voluntarily contribute a percentage of their pre-tax and post-tax annual eligible compensation, up to the maximum deferral allowed by the Internal Revenue Code (the Code) and as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan with various objectives and degrees of financial risk. The Plan currently offers various pooled separate accounts as investment options for participants.

Employer Contributions:

For the years ended December 31, 2024 and 2023, the Plan Sponsor made a discretionary matching contribution equal to 100% of the first 3% of eligible participant compensation. The Company may also make a discretionary nonelective profit sharing contribution to the Plan. This contribution, if made, would be allocated to all employees eligible to participate in the Plan. There was no nonelective profit sharing contribution made to the Plan during 2024 and 2023.

Participant Accounts:

Each participant's account is credited with the participant's contribution and Company discretionary matching contributions, as well as an allocation of the Company's discretionary nonelective profit sharing contribution, if applicable. Participant accounts are also credited with an allocation of investment earnings or losses, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued):

Unit Values:

Participants do not own specific securities or assets in the various funds, but have an interest represented by units within the account. Unit values are calculated on a daily basis.

Contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit value as last determined, and the participant's accounts are charged or credited with the number of units properly attributed to each participant.

Vesting:

Participants are fully vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution, as well as the discretionary nonelective profit-sharing contribution, are based on years of continuous service, as defined. A participant will receive partial vesting of 25% per year between years one through four and will be 100% vested after four years of service.

Notes Receivable from Participants:

A participant may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of the value of their vested interest in their account. Loans are evidenced by written promissory notes for the amount of the loan and are secured by the participant's vested account balance. The loans have terms of up to five years, or greater if used for the purchase of a primary residence. The loans bear interest at a rate of 1% over the prime interest rate. Principal and interest are paid ratably through payroll deductions. Participants may only have one outstanding loan at any time. These loans are subject to certain restrictions as defined by the Plan and applicable restrictions under the Code.

Forfeitures:

Forfeitures typically represent unvested employer contributions and will be used to pay any administrative expenses, reduce future employer contributions, or transfer to the Plan's cash account. The forfeiture account totaled \$12,947 and \$12,461 as of December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023 there were no forfeitures used to reduce administrative expenses or employer contributions.

Payment of Benefits:

Upon termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A partial withdrawal is permitted upon termination of service due to disability or retirement for participants or their beneficiaries who must receive required minimum distributions as defined by the Code. Participants with a vested account balance of \$5,000 or less will receive a lump-sum amount equal to the value of the vested portion of their account. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or due to hardship, as defined by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates:

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements, and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent loans are treated as distributions based on the terms of the Plan document. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary at December 31, 2024 or 2023.

Payment of Benefits:

Benefits are recorded when paid.

Excess Participant Contributions Payable:

Excess participant contributions payable represents payments due to certain active participants to return excess contributions in order to satisfy the relevant nondiscrimination provisions of the Plan. The Plan distributes the excess contributions to applicable participants prior to March 15th each year. There were no excess contributions for the year ended December 31, 2024. For the year ended December 31, 2023, excess contributions totaled \$5,190.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Reclassifications:

Certain 2023 amounts have been reclassified to conform to the 2024 presentation. Such reclassifications have no material effect on the financial statements.

Subsequent Events:

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 – CERTIFIED INVESTMENTS:

Certain information related to investments, cash and cash equivalents, and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held, cash and cash equivalents, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (the trustee of the Plan), a qualified institution.

NOTE 5 – FAIR VALUE MEASUREMENTS:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date. Authoritative guidance establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The following summarizes the fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value (NAV) practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued as determined by the investment manager which represents the NAV. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Included in the pooled separate accounts is a stable value fund which represents participant units of a collective investment trust for which the net asset value is based on the market value of the underlying investments. The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities' liquidations will be carried out in an orderly business manner.

NOTE 5 – FAIR VALUE MEASUREMENTS (Continued):

The underlying securities in other pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) reported by the trustee approximates fair value of the investments. The investments are redeemable at the adjusted NAV under agreements with the trustee.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the pooled separate accounts and, consequently, the fair value of the Plan's investments.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

All plan investments are participation units held in pooled separate accounts through sub-accounts of John Hancock. John Hancock provides services to the Plan as the trustee and recordkeeper; therefore, these investments and transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, including any employer contributions.

NOTE 8 – TAX STATUS:

The Plan is being operated under a volume submitter Plan document, which received an Internal Revenue Service (IRS) opinion letter, most recently amended June 30, 2020, stating that the form of the volume submitter plan is acceptable under Section 401(a) of the Code. Although the Plan has been amended since receiving its opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RECONCILIATION TO FORM 5500:

The differences between these financial statements and the Form 5500, if any, are immaterial.

NOTE 10 – DELINQUENT PARTICIPANT CONTRIBUTIONS:

During the years ended December 31, 2024 and 2023, the Company failed to deposit participant deferrals and loan repayments within the required timeframe as stated by the United States Department of Labor (DOL). Delinquent contributions, including loan payments, totaled \$316,905 and \$323,566 for the years ended December 31, 2024 and 2023, respectively. DOL regulations require that employee contributions be transferred to the trustee as of the earliest date on which such contributions and loan payments can be reasonably segregated from the employer's general assets.

For the years ended December 31, 2024 and 2023, the Company made corrective contributions for the lost earnings on the delinquent contributions totaling \$3,630 and \$8,692, respectively, that are remitted into the participants' accounts during the following plan year. The corrective contributions are included in other employer contributions receivable in the accompanying statements of net assets available for benefits and other employer contributions in the accompanying statements of changes in net assets available for benefits.
