The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1. Description of Plan

The following description of the Prosci, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and summary Plan description for more complete information.

**General and eligibility:** The Plan is a defined contribution plan established on January 1, 2020, to cover all employees of Prosci, Inc. (the Company or Plan Sponsor). All employees are eligible to participate in the Plan; there is no minimum age requirement or service hour requirement.

**Contributions and investment options:** Each year participants may contribute a specified percentage or dollar amount between 1% and 90% of pretax annual compensation, as defined by the Plan, subject to certain Internal Revenue Service (IRS) limitations. The Plan allows participants to designate contributions as Roth 401(k). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2022, the Plan was amended to reinstate the safe harbor matching contribution. The Company matches 100% of the first 3% of employee contributions and 50% of the next 2% of employee contributions each pay period, true-up on an annual basis. Effective January 1, 2024, the Plan was amended to remove the annual true-up for matching contributions. The Company may make nonelective contributions to the Plan at its discretion to eligible participants who are employed by the Company on the last day of the plan year. There were no nonelective contributions made to the Plan during 2024.

Participants in the Plan direct their contributions and Company contributions, if any, into various investment options offered by the Plan. Participants may change their elections daily. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant accounts:** Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately 100% vested in their voluntary contributions, employer safe harbor matching contributions, and nonelective contributions, plus allocated earnings and losses thereon.

**Payment of benefits:** On termination of service due to retirement, death or disability, a participant, or their beneficiary in the case of death, may elect to receive a lump-sum amount equal to the value of the participant's account, or an annuity which provides for annual installments over a specified period. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution less applicable taxes, or the participant may elect to roll over his or her account balances into another qualified retirement savings account. If the participant's account balance is less than \$1,000 at the time of termination, a lump-sum payment of cash will automatically be made.

**Notes receivable from participants:** Participants may borrow from their fund accounts amounts from \$500 to \$50,000 reduced by the excess, if any, of the highest outstanding balance during the prior 12 months over the outstanding balance on the date on which the new note is made and limited to a maximum of 50% of the present value of the participant's vested account balance. The notes bear interest at The Wall Street Journal prime rate on the 14th of each month, plus two percentage points. Notes receivable are collateralized by the participant's vested account balance. The repayment period is limited to five years, except that a note used for the purchase of a principal residence may be up to 30 years. The repayment period may not extend beyond the participant's normal retirement date. Principal and interest are paid ratably through payroll deductions. Participants are allowed one loan at a time. Notes receivable outstanding at December 31, 2024, bear interest at rates ranging from 5.25% to 10.50% and are due through May 2053.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Accounting estimates and assumptions:** The preparation of financial statements in accordance with generally accepted accounting principles requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Risks and uncertainties:** The Plan utilizes various funds as investment instruments. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**Administrative expenses:** Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Administrative expenses of the Plan are charged against earnings, except to the extent expenses are paid by the Company.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of benefits:** Benefit payments to participants are recorded upon distribution.

The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate to the best of their knowledge and belief. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

#### Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

**Level 1:** Quoted prices in active markets for identical assets or liabilities;

**Level 2:** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; and

**Level 3:** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Reported at fair value based on quoted market price of the fund and classified within Level 1 of the valuation hierarchy.

**Common collective trust (CCT):** These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus the liabilities, and then divided by the number of shares outstanding. The CCT is not classified within the fair value hierarchy pursuant to Accounting Standards Update (ASU) No. 2015-07, *Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)*.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated October 6, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Party-in-Interest Transactions

Service charges paid by the Plan to the third-party administrator for recordkeeping services totaled \$44,221 for the year ended December 31, 2024, and are included in administrative expenses on the statement of changes in net assets available for benefits.
