Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mosaic ATM, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Mosaic ATM, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established and became effective on March 15, 2005. The Plan is a defined contribution plan covering eligible employees of Mosaic ATM, Inc. (the "Company") who are age 21 or older. The Company is responsible for oversight of the Plan. The Plan's Management determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Plan's Trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute up to 90% pre-tax of their eligible compensation to the Plan. The total annual pretax participant contribution is subject to the annual dollar limit set by the Internal Revenue Code. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a nonelective safe harbor contribution annually of 3% of the participants' eligible compensation. The Company may also make a discretionary profit-sharing contribution annually. For the year ended December 31, 2024, the Company's nonelective safe harbor and profit-sharing contributions totaled \$367,706. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and related matching contributions and allocations of (a) the Company's nonelective and profit-sharing contributions (if any) and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions to the Plan and Company nonelective contributions to the Plan plus actual earnings thereon.

Notes to Financial Statements

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. The notes receivable are secured by the balance in the participant's account, and bear interest at the Prime rate plus 1%. Notes must be repaid within five years, unless the purpose is to obtain a mortgage on a primary residence, whereas the loan must be repaid within thirty years. Principal and interest are prepaid or paid ratably through payroll deductions.

Payment of Benefits

Benefit payments are recorded when paid. Upon termination of service due to resignation, death, disability, involuntary termination, or retirement, a participant is entitled to a distribution of their account balance in a lump-sum amount equal to the value of the vested interest in their account, equal installments, partial withdrawal, or roll over into another qualified plan or Individual Retirement Account. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts vested may be withdrawn for a hardship purpose. Additionally, for participants who have reached the age of 59½, in-service distributions are available up to the amount of the participant's vested interest in his or her account. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to retirement age. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeited Accounts

Forfeitures of terminated non-vested participant's accounts may be used to pay Plan expenses or reduce future Company contributions. At December 31, 2024 and 2023, no forfeitures were available to reduce future contributions of the Company.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Notes to Financial Statements

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Note 3. Certification

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the prior trustee of the Plan, and Empower Annuity Insurance Company of America, the current trustee of the Plan.

Notes to Financial Statements

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Valued as determined by the issuer of the collective trust fund based on the fair value of the underlying investments, which is valued at the NAV of units of the collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds or exchange traded funds that are valued on the basis of readily determinable market prices.

The Plan evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of different levels.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and/or to terminate the Plan, subject to the provisions of ERISA. In the event of a complete or partial Plan termination, participants would become 100% vested in their entire account balances. In the event of such Plan termination, the trustees shall determine whether the assets of the Plan shall be liquidated and distributed or whether the assets shall continue to be held in trust and distributed in accordance with the terms of the Plan.

Note 6. Tax Status

The Plan uses a pre-approved plan sponsored by Empower Retirement LLC. The plan previously had adopted a volume submitter plan sponsored by ADP LLC. The pre-approved plan provider has received an opinion letter from the Internal Revenue Service dated November 14, 2022, as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan has been amended since the opinion letter was received; however, the Plan Administrator believes the Plan is designed (including all amendments to the Plan) and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

In accordance with authoritative guidance issued by the FASB, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related Party Transactions and Party-in-Interest Transactions

Empower Annuity Insurance Company of America is the current administrator and recordkeeper for the Plan. ADP was the prior administrator and recordkeeper for the Plan. The Plan pays fees to Empower Annuity Insurance Company of America and ADP for these services which qualify as party-in-interest transactions. Certain Plan investments are managed by Empower Annuity Insurance Company of America, the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Empower Annuity Insurance Company of America and Reliance Trust Company provides certain administrative services to the Plan, pursuant to an agreement, and receive revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the party-in-interest for administrative services to the Plan. If the revenue received by this party-in-interest from such mutual fund service providers exceeds the amount owed under the agreement, excess amounts are remitted to the Plan's

trust. Such amounts may be applied to pay Plan administrative expenses or allocated to participant accounts. During 2024, there were no excess amounts allocated to participants based on their respective account balance. The Plan or Plan Sponsor may make direct payments to a party-in-interest for administrative expenses not covered by revenue sharing.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

CURRENT VALUE: The value of all assets in each investment option as of the last day of the plan year
