NOTE A - DESCRIPTION OF PLAN

The following description of MDVIP, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of MDVIP, LLC, MDVIP Practice Management, LLC and MDVIP Medical Group Holdings, LLC and its subsidiaries (collectively, the “Employer”) as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Effective March 1, 2010, the Employer entered into Adoption Agreement No. 001 to the Prototype Non-standardized Safe Harbor Profit Sharing Plan in order to amend the Plan to comply with recently enacted legislation, and on December 16, 2013, the Plan moved to a new Prototype Non-standardized Safe Harbor Profit Sharing Plan in conjunction with a change in trustees. These changes did not result in any significant changes to the Plan’s operations or structure.

Plan Administration

The Plan is administered by the Employer. On September 3, 2024 there was a change in service providers from Empower Retirement to T. Rowe Price. On September 3, 2024, the Plan transferred all assets from Empower Retirement to T. Rowe Price. On December 31, 2024, all plan assets were held by T. Rowe Price. The Plan’s assets are maintained and administered by T. Rowe Price (the “Trustee”), who also functions as the Plan’s record keeper for the year ended December 31, 2024 and Empower Trust Company, LLC for the year ended December 31, 2023. There were no fees related to the change of service providers.

Eligibility and Participant Contributions

Employees who are at least 18 years of age and have completed 30 days of service are eligible to enroll in the Plan. Each year, participants may elect to make pre-tax contributions to the Plan as defined in the Plan document. The Plan also allows a Roth Deferral option for participant contributions. Participants may modify their contribution percentage at any time. Participants may also contribute amounts representing distributions from other qualified plans (“rollover contributions”). Catch-up contributions, as defined in the Internal Revenue Code (“IRC”), are permissible for eligible participants who are at least age 50 or will attain age 50 before the end of the calendar year. All participant contributions during a Plan year are subject to maximum dollar limitations established by the IRC. For the year ended December 31, 2024, the total maximum allowable tax-deferred contribution to the Plan under the IRC from employee sources was \$23,000 plus catch-up contributions of \$7,500 for eligible employees.

Matching Contributions

The Employer may make a discretionary matching contribution in an amount equal to a percentage of the participant’s contribution. Employees become eligible for the Company’s match after completing 6 months of service. For the year ended December 31, 2024, the Employer elected to make matching contributions

equal to 100% of the participant's contribution, up to the first 6% of the participant's eligible compensation, as defined in the Plan document.

Participant Accounts

A separate individual account is established for each participant in the Plan. Each participant's account is credited with the participant's contribution, any Employer matching contribution and allocations of investment earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' contributions and rollover contributions plus actual earnings thereon are 100% vested at all times. Participants immediately vest in Employer contributions.

Investment Options

Upon enrollment in the Plan, a participant is required to direct their contributions plus actual earnings thereon to be invested in any of the investment options offered by the Plan. Participants have the ability to modify their investment options daily.

Forfeitures

Forfeitures of terminated non-vested account balances may be used to reduce the Company's contributions, if any, or to pay the Plan's administrative expenses. There was \$4,773 and \$4,566 of forfeitures at December 31, 2024 and 2023, respectively. During 2024, \$4,773 in forfeitures were used to offset the Company match.

Payment of Benefits

Effective October 1, 2021, the Plan was amended to allow partial payments following termination of service due to death, disability or retirement.

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the vested interest in a lump-sum payment or in a partial payment. Participants may also withdraw funds from their account when they reach the normal retirement age of 65 or in the event of financial hardship.

Upon termination of service, vested amounts of \$5,000 or less are automatically distributed to the participant or rolled over to another qualified plan. Vested amounts exceeding \$5,000 in such terminated participant's accounts are maintained until retirement, disability, or death unless the participant elects to receive the entire vested amount in a lump-sum payment or in a partial payment or has a direct rollover to another qualified plan.

Payment will occur within one year of such election. The Employer allows participants upon their retirement to receive distributions of their vested amounts in a lump-sum payment or in a partial payment. Benefits are recorded as deductions from net assets available for benefits when paid.

Notes Receivable from Participants

Participants may borrow for any purpose, up to the lesser of 50% of the participant's vested account balance or \$50,000. Loans are repayable over a period of up to five years, unless the proceeds are used to purchase a primary residence, in which case the loan is repayable over a period of up to ten years. Loans are secured by the participant's account balance and evidenced by a promissory note. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made. Interest rates on outstanding loans are stated at the prime rate plus 1%. A participant may have only one loan outstanding at a point in time. As of December 31, 2024 and 2023, interest rates on participant loans ranged from 4.25% to 9.50%. There was no allowance for credit losses on December 31, 2024 or 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation or Depreciation in Fair Value of Investments

Net realized and unrealized appreciation or depreciation of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation or depreciation in fair value of investments and includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants consist of participant loans which are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan provides for participant-directed investment options in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market volatility and credit risk. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

Administrative Expenses

The Employer pays certain administrative fees associated with the Plan. Fees relating to Plan investments will generally be allocated among the accounts of all participants in the Plan proportionately based on the value of account balances or number of participants in the Plan. Expenses specifically incurred by, or attributable to, a participant may be allocated directly to a specific participant's account. Administrative functions are performed by certain employees of the Employer. No such employees receive compensation from the Plan.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds – Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The mutual funds provide for early redemptions by the Plan at their reported NAV with no advance notice requirement. Mutual funds are deemed to be actively traded.

Collective Trusts – The Plan has interests in collective trusts valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. These investments can be redeemed daily and without any restrictions on the timing of the redemption. On December 31, 2024 and 2023, the Plan had no unfunded commitments related to these investments.

NOTE D - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fees paid for investment management and administrative services to the Plan's trustees, T. Rowe Price and Empower Trust Company, LLC, were \$77,891 for the year ended December 31, 2024. Notes receivable from participants are considered to be party-in-interest transactions because they are transacted with the Plan participants.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE F - TAX STATUS

The Employer adopted a Prototype Non-standardized Safe Harbor Profit Sharing Plan which received its latest favorable opinion letter from the Internal Revenue Service ("IRS") on November 14, 2022 which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. Plan management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and accordingly is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of both December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – INVESTMENT CERTIFICATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivables from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price and Empower Trust Company, LLC, the trustees for the Plan.
