Note 1. Plan Description

General

The following description of the Florida Proton Therapy Institute, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan, which was established effective January 1, 2010, and subsequently amended, is a defined-contribution plan covering all employees of Florida Proton Therapy Institute, Inc. (the “Institute”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Voya Retirement Insurance and Annuity Company (the “Plan Custodian”/“Voya”) serves as Plan Custodian

Contributions

Immediately upon hire, employees may contribute a percentage of their pre-tax, or after-tax annual compensation, as defined in the Plan, up to the annual limit, as determined by the Internal Revenue Service (“IRS”). Catch-up contributions are allowed for participants who are at least 50 years of age by the end of the Plan year. Contribution deferral percentages can be changed throughout the year.

Employees who are over 18 years of age become eligible for company-matching, profit-sharing contributions and discretionary contributions following the completion of one year of service, with at least 1,000 hours per year. At the discretion of the Board of Trustees, the Institute may make matching or profit-sharing contributions to the Plan. During the year ended December 31, 2024, the Institute made a profit-sharing contribution of 3% of eligible compensation for eligible employees.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Institute’s matching contribution, if any, (b) the Institute’s profit-sharing contribution, if any, (c) the Institute’s discretionary contribution, if any, (d) Plan earnings, and (e) administrative expenses charged to the Plan. Allocations are based on participants’ earnings or account balances, as defined by the Plan. Participants are entitled to the benefit of their vested account balance.

Vesting

Participants are immediately vested in their voluntary employee contributions and earnings thereon. Vesting in the Institute’s matching, profit-sharing, and discretionary contributions, plus earnings thereon, is based upon years of continuous service in which the employee is credited with at least 1,000 hours of service per year as follows:

1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 or more years	100%

The Plan provides for the full vesting of a participant’s account to the participant or beneficiary on the date the participant becomes totally and permanently disabled or dies.

Forfeited Accounts

Forfeitures of terminated participants' non-vested accounts will be used to reduce administrative expenses of the Plan or to reduce the Institute's contributions to the Plan. At December 31, 2024 and 2023, there were approximately \$36,600 and \$25,000, respectively, of forfeitures available to reduce future administrative expenses and Institute contributions. Approximately \$700 of forfeitures were used to reduce the Institute's contributions during the year ended December 31, 2024.

Investment Options

Participants may determine their own investment mix from the various investment options made available by the Plan.

Participant Loans

Loans are not permitted by the Plan.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation of service, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in their account. Early retirement is not permitted under the Plan. Normal retirement age is 60, as detailed in the Plan agreement.

Investment Risk

The Plan's investments are not insured by the Plan Custodian, the Institute, the Federal Deposit Insurance Corporation, or any other governmental agency; accordingly, the Plan is subject to the normal investment risks associated with money market funds, mutual funds, stocks, bonds, and other similar types of investments that it may elect.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments in pooled separate accounts at December 31, 2024 and 2023 with the Plan Custodian are valued at their accumulation unit value ("AUV").

The separate accounts are valued daily as the accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value ("NAV") of shares of the underlying fund, the fund's dividends and the contract's separate account charges.

Purchases and sales of marketable securities are reflected on a trade-date basis, and interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. The change in fair value for each year is reflected in the statement of changes in net assets available for benefits as net change in fair value of investments.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts (see Note 5). The Plan's investments in the insurance company general account are stated at contract value. Contract value is deemed to be the relevant measurement attribute for those contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions and reinvested income, less any withdrawals, plus accrued interest.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Administrative and Investment Expenses

Certain administrative expenses are paid directly by the Institute and will not be reimbursed by the Plan. Certain investment expenses are netted against net change in the fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing the financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Plan Custodian Certification

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Custodian, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively.
- Investment income as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurement

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 5. Fully Benefit-Responsive Investment Contracts

The Plan's investments held in the guaranteed income fund ("GIF") as of December 31, 2024 and 2023 are deemed to be a fully benefit-responsive group annuity products with Voya and, therefore, are reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The GIF does not limit the Plan's ability to transact at contract value. The GIF contract permits either party to terminate the contract with 90 days' notice. The Voya Fixed Account, the Plan's only GIF, guarantees principal and a guaranteed minimum interest rate of 1.00% for the life of the contract. The average crediting interest rates were between 1.00% and 1.50% as of December 31, 2024 and 2023, respectively.

Note 6. Tax Status

The Plan is intended to be a qualified trust under Section 401(a) of the Internal Revenue Code and is subject to the provisions of ERISA. The original Plan is a prototype plan prepared and maintained by the Plan Custodian. The prototype plan received a determination of qualification from the IRS, dated March 31, 2008. The Plan administrator believes that the adopted and amended Plan continues to qualify and will remain exempt from federal income taxes under Section 401(a). Accordingly, no provision for income tax has been included in the Plan's financial statements.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Institute has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Parties-In-Interest Transactions

The Plan's investments are managed by Voya and, therefore, these transactions qualify as party-in-interest transactions.
