Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Denver Commercial Property Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2023 and 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Denver Commercial Property Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective January 1, 2018. The Plan utilizes an IRS approved prototype plan obtained from Reliance Trust Company (the “Trustee”) and has not been amended. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”). The Advisory Board is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Eligibility

Employees of Denver Commercial Property Services, Inc., DCPS Cleaning, LLC, and DCPS Coatings, (collectively, the “Company”) become eligible to participate in the Plan after completing six months of service and reaching 21 years of age.

Contributions

Each year, participants may contribute at least 1%, but not more than 90% of annual compensation to the Plan, as defined within the Plan. Deferral contributions may not exceed the limits set forth by the Internal Revenue Code of the United States of America (\$23,000 for 2023). Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions (\$7,500 for 2024). Participants may change their contribution percentage throughout the year and may cease contributions at any time. Participants direct the investment of their contributions into the various investment options offered by the Plan. Participants’ pre-tax elective deferrals into the Plan are 100% vested when contributed.

The Company has elected to make matching contributions in amounts deemed appropriate by the Company. Employer contributions made by the Company during 2024 totaled \$418,127. For the year ended December 31, 2024 matching contributions were 100% of the first 1% of salary deferrals, plus 50% of salary deferrals up to 6%, with a maximum match of 3.5%. Rollover contributions from other qualified retirement plans or from Individual Retirement Accounts may be accepted as permitted by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution plus actual earnings thereon. Participant accounts are also credited with allocations Company contributions and related earnings. In addition, participant accounts are charged an allocation of Plan expenses. Allocations are based upon account balances, as defined by the Plan. The benefit to which a participant is entitled the benefit that can be provided from the participant’s vested balance.

NOTE 1 DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching portion of their account and related earnings is based upon years of continuous service. Participants become fully vested upon completion of two years of employment. Participants may also become fully vested upon death or permanent disability.

Investment Options

Participants may direct employee and employer contributions into any of the investment options offered by the Plan.

Payment of Benefits

In the event of termination of employment, retirement, disability, or death, participants will receive their accumulated contributions and actual earnings thereon, plus the vested portion of accumulated Company contributions and actual earnings thereon. Benefits may be rolled into another qualified plan, received in a lump sum, or paid in installments over a specific period based upon age at retirement. Account balances with less than \$1,000 at termination will be rolled in another qualified plan or paid in a lump sum. The Plan also allows for hardship withdrawals and qualified reservist distributions, with eligibility determined on a case-by-case basis.

Forfeited Accounts

Pursuant to the Plan document, forfeitures from non-vested participants shall be utilized to offset expenses and company contributions. Total forfeitures available for these purposes approximated \$9,233 for Plan year 2024, and were fully utilized.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through the date of the independent auditors' report, which is also the date these financial statements were available to be issued.

NOTE 3 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions and related earnings.

NOTE 4 TAX STATUS

The Plan utilizes an IRS prototype plan obtained from the Trustee. The Prototype is places reliance on an opinion letter obtained from the IRS by the Trustee indicating the Plan is qualified under Section 401 of the IRC and therefore not subject to income tax under current law. The prototype plan has not been amended. Accordingly, the Plan Administrator believes the Plan is qualified, and the related trust is tax exempt.

NOTE 4 TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize tax liability or (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is generally subject to audits by taxing jurisdictions for three years from filing dates. There are currently no audits for any tax periods in progress.

NOTE 5 CERTIFICATION OF INVESTMENT INFORMATION

Reliance Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants (if any) reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurements) and the lowest priority to unobservable inputs (Level 3 Measurements).

NOTE 7 FAIR VALUE OF INVESTMENTS (continued)

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for identical or similar assets or liabilities active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and,
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2022.

All assets except receivables are mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and transact at that price. The mutual funds held by the plan are deemed to be actively traded.
