Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1      DESCRIPTION OF PLAN**

The following description of the Transwestern 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Transwestern Commercial Services, LLC (the Company) is the Plan Sponsor. The Plan is a defined contribution plan covering substantially all salaried employees of the Company and its affiliated entities that have satisfied eligibility requirements during the Plan year. It is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosures under the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is a multi-employer plan that has been adopted by the Company's affiliated entities. Employees of the Company and Transwestern Interests, LLC (TILLC) are eligible to participate in the Plan.

Eligible participants are enrolled automatically in the Plan on the first day of the month after they have attained 21 years of age and completed one month of service, unless they decline participation.

The Company's Investment Committee is responsible for the general administration of the Plan. Fidelity Management Trust Company is the Plan Trustee (the Trustee or Fidelity), with Fidelity Workplace Services LLC as the record-keeper of the Plan.

Contributions

Each Plan year, participants may contribute up to 60% of their annual wages before bonuses, overtime, taxable value of a qualified or non-qualified stock option, or severance pay. Participant contributions are subject to certain Internal Revenue Code (the Code) limitations. Effective March 1, 2016, the Company implemented an automatic contribution deferral program of 4%, with an option for the participant to opt out. The Company also makes an employer matching contribution for eligible participants of the Company and TILLC at the rate of 50% of the first 4% of eligible pay, up to an annual maximum contribution of \$3,500 and a Company discretionary contribution when decided. The Company's Investment Committee has the option to contribute additional amounts at their discretion.

In addition, participants may roll over contributions from another qualified plan to the Plan with the approval of the Plan administrator. The Company does not make matching contributions on rollover contributions. The Plan allows for participants over the age of 50 to make catch-up contributions according to the amounts allowable by the Code. The Company does not match catch-up contributions.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with their contributions, the Company's matching contributions, an allocation of the Company's discretionary contribution, if any, and the Plan's earnings. Also, a participant's account is charged with withdrawals and an allocation of Plan losses, if any, and administrative expenses. The allocation is based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Investment Options

Participants direct their contributions into various investment options offered by the Plan. If a participant is automatically enrolled, their contributions are invested in the applicable lifecycle fund based on the participant's age and their anticipated retirement date. Company contributions are allocated in the same manner as that of the participant's elective contributions. The Plan currently offers several mutual funds and a common collective trust, as well as the opportunity for participants to invest in common stocks, certificates of deposit, and various other traded mutual funds through a brokerage link account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. The Plan was amended in 2006 to change the vesting schedule of employer matching contributions and earnings thereon, based on years of credited service as follows:

A participant is 100% vested after three years of credited service.

Participant Loans

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000, or 50%, of their eligible account balance, whichever is less. Loan terms generally range from one to five years for general purpose loans, or up to a maximum of 15 years for the purchase of a primary residence. Interest rates are fixed over the life of the loan, and the loans outstanding at December 31, 2024 and 2023, carry interest rates ranging from 6.25% to 11.50%, respectively. Loans are collateralized by participant account balances and loan repayments are made through payroll deductions.

Payment of Benefits

Upon termination of service, the normal form of benefit is a lump-sum disbursement (including direct rollover) or, depending on the age of the participant, installment payments from the trust of the minimum required distribution. Invested fund balances of less than \$1,000 are automatically cashed out for terminated employees.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period and repays the full amount of the vested distribution before the end of the five-year period that begins on the date of re-hire, the forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce employer contributions or pay administrative expenses. Unallocated forfeited balances as of December 31, 2024 and 2023 was \$205,447 and \$169,734, respectively. Forfeitures used to offset employer contributions and pay for expenses in 2024 and 2023 totaled \$211,893 and \$475,983, respectively.

Termination

Although the Company has not expressed any such intent, it has the right under the Plan to discontinue the Plan at any time and terminate the Plan subject to the provisions of the ERISA. In the event that the Plan terminates, participants will become 100% vested in their accounts.

Basis of Accounting

The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (U.S. GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to U.S. GAAP issued by the FASB in these footnotes are in accordance with the FASB Accounting Standards Codification.

The accompanying financial statements have been prepared on the accrual basis of accounting.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in investment securities that are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the risks associated with certain investment securities and the associated participant account balances, it is possible that their values will change in the near term. The changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3).

Purchases and sales of securities are recorded on a trade-date basis. Interest is recognized when earned and dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

Management fees and operating expenses charged to the Plan for its investment in the mutual funds are deducted from income earned on a daily basis and are not reflected separately. Consequently, management fees and other investment-related expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan as provided in the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

**NOTE 3      INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of ERISA. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Plan's Trustee.

**NOTE 4      FAIR VALUE MEASUREMENTS**

In accordance with Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

Level 1: Quoted unadjusted prices for identical instruments in active markets that the Plan has the ability to access at the date of measurement.

Level 2: Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuation in which all significant inputs and significant value drivers are observable in active markets. Level 2 inputs are those in markets for which there are few transactions, the prices are not current, little public information exists, or instances where prices vary substantially over time or among brokered market makers.

Level 3: Model-derived valuation in which one or more significant inputs or significant value drivers are unobservable. Unobservable inputs are those inputs that reflect the Plan's assumptions that market participants would use to price the instrument based on the best available information.

An instrument's fair value measurement within the fair value hierarchy is based on the lowest level of any inputs that is significant to the fair value measurement. Valuation techniques used maximize the use of the observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Common collective trust fund*—The common collective trust fund was valued using the net asset value (NAV) per share as a practical expedient.

*Mutual funds*—The mutual funds were valued at the NAV of the shares held by the Plan based on publicly traded prices.

*Brokerage link*—The external and Fidelity mutual funds are valued at the NAV of the shares held by the Plan based on publicly traded prices. Common stocks and units are valued at the closing price reported in the active market on which the individual securities are traded.

*Certificates of deposit*—The certificates of deposit are valued at amortized cost, which approximates fair value.

Participant-directed redemptions have no restrictions; however, withdrawals initiated by the Plan Sponsor will normally be provided as soon as practicable within 12 months following written notice to the Trustee. This amount is not levelled as the valuation technique used NAV as a practical expedient.

The valuation methods described above may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 TAX STATUS**

The Plan uses a prototype document sponsored by Fidelity. Fidelity received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Code. The Plan also received a determination letter from the IRS dated July 22, 2003; however, the Plan and related trust rely on Fidelity's opinion letter for its tax-exempt status. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Management believes the Plan and related trust are in compliance.

**NOTE 5 TAX STATUS** *(continued)*

U.S. GAAP requires the Plan’s management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024, there were no uncertain tax positions taken or are expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds managed by Fidelity. Fidelity is the Trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.
