## **INDEPENDENT AUDITORS' REPORT**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Trinity Episcopal School Corporation Tax Deferred Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### NOTE A - DESCRIPTION OF THE PLAN

Likewise, the brief description of the Plan contained herein is provided solely for purposes of general information, and interested persons should refer to the Plan agreement for a more complete description of the Plan's provisions. A copy of the Plan agreement can be obtained from the Trinity Episcopal School Corporation (the "School"), which is the administrator of the Plan. The Plan was amended and restated effective January 1, 2024.

#### [1] General:

The Plan is a defined-contribution plan designed to meet the requirements of Section 403(b) of the Internal Revenue Code (the "Code") and is subject to the provisions of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan covers all eligible employees of the School, as defined. TIAA and CREF are the insurance companies for the Plan's non-mutual fund investments. TIAA Trust, N.A. serves as custodian of the Plan's investments in mutual funds. TIAA is the Plan's record-keeper. The Plan administrator controls and manages the operation and administration of the Plan.

#### [2] Eligibility for participation:

**Employee elective deferrals:** Employees are eligible to participate in the Plan and may elect to have compensation deferrals made on their behalf immediately upon becoming employed by the School. Certain employees may be excluded from participation, however, if they fall within the categories listed in the Plan agreement.

**Employer matching contributions:** Effective January 1, 2024, employees who participate in the Plan through employee elective deferrals are eligible to receive matching contributions from the School. Certain employees may be excluded from participation, however, if they fall within the categories listed in the Plan agreement.

#### [3] Contributions:

*Employee elective deferrals:* Participants may elect to contribute a certain amount of their annual gross compensation, subject to limitations as provided in the Code. Catch-up contributions are permitted under the Plan if (i) a participant has 15 years of service, thus allowing the limit on his or her elective deferrals to his or her participant account to be increased by up to \$3,000 in any year, up to a lifetime maximum of \$15,000, and/or (ii) a participant has attained the age of 50 before the end of the Plan year, thus becoming eligible to make catch-up contributions up to \$7,500 in 2024. If a participant is eligible for the 15-year rule increase in elective deferrals and the age-50 catch-up contribution, elective deferrals are to be allocated first under the 15-year rule and thereafter as an age-50 catch-up contribution. In no event may participant contributions exceed any statutory limitations. Participants may also roll over to their accounts those balances accumulated in other qualified defined-benefit or defined-contribution plans.

*Employer matching contributions:* Effective January 1, 2024, the School began making matching contributions for Plan participants equal to 100% of their elective deferrals. Participants must be at least 21 years of age and have completed at least one year of service to receive the matching contribution. The School will not match their elective deferrals in excess of 1.5% of compensation for such period. Prior to January 1, 2024, the School was not permitted to make employer contributions.

Participants direct the investment of participant and employer matching contributions, and rollover contributions into various investment options offered by the Plan. Such amounts are 100% vested and non-forfeitable.

### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

#### [4] Participant accounts:

The activity in each participant's account includes the participant's contribution, the School's matching contribution, benefit payments or withdrawals, and allocations of the earnings or losses on Plan assets and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, eligible compensation, or specific transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### [5] Vesting:

Participants are fully vested in all contributions to the Plan, plus actual earnings thereon, immediately when made.

#### [6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, as defined. Interest rates on outstanding loan balances range from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are paid rateably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### [7] Plan loans:

Prior to 2020, participants were able to borrow from TIAA and CREF, the insurance company, and use a portion of their Plan account balance as collateral for the loan. Beginning in 2020, these loans were no longer provided by the Plan and all existing loans will remain and be repaid accordingly. The Plan now provides for notes receivable from participants as noted above. These loans were issued as separate contracts by TIAA and CREF and did not represent loans from, or distributions of, Plan assets. Instead, loans were collateralized using a participant's TIAA Traditional Annuity account balance in an amount equal to 110% of the outstanding loan balance. A participant was able to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 45% of their vested account balances, subject to annuity contract and Plan provisions. Loan terms ranged from one to five years; however, terms were able to exceed five years for the purchase of the participant's primary residence, as defined. Interest rates on outstanding loan amounts as of December 31, 2024 and 2023 range from 5.28% to 5.73%. Principal and interest are paid rateably by the participant to TIAA and CREF and not through a salary-reduction arrangement with the School. Plan loan balances outstanding from participants to TIAA and CREF were approximately \$37,000 and \$41,000 as of December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, approximately \$41,000 and \$46,000, respectively, of the participants' TIAA Traditional Annuity account balances were pledged as a collateral.

#### [8] Payment of benefits:

Participants, alternate payees, or beneficiaries of the Plan may receive a distribution of their vested employee contributions upon death, disability, reaching age 59½, normal retirement, hardship, or termination of employment.

There are various methods by which benefits may be distributed to participants from the Plan, depending on (i) how the benefits are invested, (ii) the participant's marital status, and/or (iii) the elections made by the participant, or his or her spouse, if any. For termination of service due to other reasons, a participant receives the value of the vested interest in his or her account as a lump-sum distribution as of the most recent valuation date.

#### [9] Plan termination:

Although it has not expressed any intention to do so, the School has the right under the Plan to discontinue participants' contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### NOTE B - SUMMARY OF ACCOUNTING POLICIES

#### [1] Basis of accounting:

The accompanying financial statements and supplemental schedule have been prepared using the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at their fair values, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### [2] Investments:

The Plan reports a fair-value measurement of its investments (except for fully benefit-responsive investment contracts, which are reported at contract value), in accordance with the provisions of the Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Participants may direct their contributions into any of four investment alternatives: (i) fixed annuity contracts, (ii) variable annuity contracts, (iii) a pooled separate account, and (iv) mutual funds. (See Notes D and E for further discussions concerning each of these investment alternatives.)

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net realized appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

#### [3] Payment of benefits:

Benefits are recorded when paid.

#### [4] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements.

#### [5] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect (i) the reported amounts of net assets available for benefits at the date of the financial statements, (ii) the changes in net assets available for benefits during the reporting period, and (iii) when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### [6] Income taxes:

The Plan has adopted an ERISA 403(b) Volume Submitter Plan sponsored by TIAA. On August 7, 2017, the Internal Revenue Service stated in an advisory letter that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Code and, therefore, the related accounts are exempt from taxation. The Plan has been amended since receiving the letter, however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes that the Plan is qualified and the related accounts are tax exempt.

U.S. GAAP requires Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### [7] Subsequent events:

The Plan has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, TIAA and CREF and TIAA on behalf of TIAA Trust N.A with respect only to the Plan's investments held by TIAA Trust N.A. as directed trustee or custodian and record-kept by TIAA for TIAA Trust, N.A., have certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

### NOTE D - INVESTMENTS AND FAIR-VALUE MEASUREMENTS

The FASB's ASC Topic 820 provides the framework for measuring fair value. The framework provides a fair-value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair-value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair-value measurement.

The asset's or liability's fair-value measurement level within the fair-value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2024 and 2023.

**TIAA Real Estate Account** – This is a pooled separate account/insurance company account and is a variable annuity product valued at net asset value ("NAV") per accumulation unit, as a practical expedient to measuring fair value, based on the market value of the underlying real-estate holdings or other real estate-related investments. Real-estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on the assessment of specialists and reported by TIAA. The TIAA Real Estate Account sometimes holds securities as well, and these are generally valued from independent pricing sources. Transactions out are limited to one per calendar quarter. The TIAA General Account provides the TIAA Real Estate Account with a liquidity guarantee.

**CREF Variable Annuity Accounts** – These are variable annuity accounts that invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Each CREF Account is a separate portfolio with its own investment objective and strategies. Investments in a CREF Variable Annuity Account enable a unit-holder to acquire units, whose accumulation unit value, or the NAV used as a practical expedient to measure the fair value, is calculated each business day. The value of a unit-holder's investment rises and falls with the returns on the underlying assets. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing.

**CREF Money Market Accounts** – These are portfolio securities that are valued at their amortized cost bases. This valuation method does not factor in unrealized gains or losses on the account's portfolio securities. Amortized cost-valuation involves first valuing a security at its cost, and thereafter assuming a constant amortization to maturity of any discount or premium, regardless of the impact of fluctuating interest rates on the security's market value.

Accumulation units in CREF accounts are transacted at the accumulated unit value. Participants will be locked out of a CREF Account for 90 days if a purchase-sale-repurchase within that account is made within a 60-day period, other than for the CREF Money Market Account.

**Mutual funds** – These are valued at their daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Nuveen mutual funds** – The funds invest principally in equity securities, fixed-income instruments, other mutual funds and short-term instruments in accordance with each funds' investment objectives. Fund holdings are generally valued using market quotations or prices obtained from independent pricing services. Shares of Nuveen funds are value at NAV. Certain funds charge a 2% redemption fee on redemption of shares occurring within 60 days of the initial purchase date. The funds impose a restriction whereby a participant is locked out of a fund for 90 days if the participant has a purchase, sale or repurchase within a fund, and is made within a 60-day period, for the majority of these funds.

The preceding methods described may produce a fair-value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial-instruments could result in a different fair-value measurement at the reporting date.

(A) Certain investments that are measured at fair value using the NAV per share (or its equivalent unit) as a practical expedient have not been classified in the fair-value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of amounts in the fair-value hierarchy to the amounts presented in the statements of net assets available for benefits.

(B) The strategy for each of these investments is described below:

The CREF Stock Account seeks a favorable long-term rate of return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of common stocks. Under normal circumstances, the account invests at least 80% of its assets in equity securities of foreign and domestic companies.

The CREF Social Choice Account seeks a favorable long-term rate of return that reflects the investment performance of the financial markets while giving special consideration to certain social criteria. The account is balanced, with assets divided between domestic and foreign stocks and other equities (about 60%) and bonds and other fixed-income securities, including money-market instruments (about 40%). The account invests only in companies that are suitable from a financial perspective and whose activities are consistent with certain environmental, social and governance criteria.

The CREF Core Bond Account seeks a favorable long-term rate of return, primarily through high current income consistent with preserving capital. Under normal circumstances, the account invests at least 80% of its assets in a broad range of fixed-income securities. The majority of the account's assets are invested in U.S. Treasury and other governmental agencies, corporate bonds, and mortgage-backed or other asset-backed securities.

The CREF Global Equities Account seeks a favorable long-term rate of return through capital appreciation and income from a broadly diversified portfolio that consists primarily of foreign and domestic common stocks. Under normal circumstances, the account invests at least 80% of its assets in equity securities of foreign and domestic companies.

The CREF Growth Account seeks a favorable long-term rate of return, mainly through capital appreciation, primarily from a diversified portfolio of common stocks that present the opportunity for exceptional growth. Under normal circumstances, the account invests at least 80% of its assets in common stocks and other equity securities. The account invests primarily in large, well-known, established companies, particularly those with new or innovative products, services or processes that may enhance future earnings prospects.

The CREF Equity Index Account seeks a favorable long-term rate of return from a diversified portfolio selected to track the overall market for common stocks publicly traded in the United States, as represented by a broad stock market index. The account buys most, but not necessarily all, of the securities in its benchmark, the Russell 3000® Index, and will attempt to create a portfolio that closely matches the overall investment characteristics of this index.

The CREF Inflation-Linked Bond Account seeks a long-term rate of return that outpaces inflation, primarily through investment in inflation-indexed bonds, fixed-income securities whose returns are designed to track a specified inflation index over the life of the bond. Under normal circumstances, the account invests at least 80% of its assets in U.S. Treasury inflation-indexed securities.

(C) The TIAA Real Estate Fund seeks to obtain favorable long-term total return through capital appreciation and current income by investing primarily in equity securities of companies engaged in the real estate industry.

### Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair-value level to another.

#### NOTE E - INVESTMENTS AT CONTRACT VALUE

The TIAA Traditional Annuity is a fixed-rate annuity contract that is fully and unconditionally guaranteed by TIAA. The guarantees and returns of the TIAA Traditional Annuity are backed by TIAA's claims-paying ability. Liquidity restrictions apply to the TIAA Traditional Annuity under certain types of annuity contracts. The TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3% or for Retirement Choice Plus ("RCP"), between 1% and 3%) and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant's account result in the purchase of a guaranteed amount of lifetime annuity income.

When a participant's account in the TIAA Traditional Annuity is annuitized based on the available options, the present value of the stream of payments should equal the account balance. The subsequent stream of annuity payments occurs outside of the Plan and does not represent an obligation of the Plan. The TIAA Traditional Annuity is fully benefit-responsive and is reported at contract value. The contract value equals the accumulated cash contributions, interest credited to the contracts, and transfers, if any, less any withdrawals and transfers. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange.

The TIAA Traditional Annuity within the Supplemental Retirement Annuity ("SRA"), Group Supplemental Retirement Annuity ("GSRA") and RCP contracts have no liquidity restrictions. The TIAA Traditional Annuity holdings within the Retirement Annuity ("RA") contracts have liquidity restrictions. The RA contract does not allow lump-sum cash withdrawals, and transfers must be spread over a period of ten annual installments, referred to as a Transfer Payout Annuity ("TPA").

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### NOTE F - RISKS AND UNCERTAINTIES

The Plan's investments are included in various investment alternatives made available by TIAA, CREF and TIAA Trust, N.A. Investment securities are exposed to various risks, such as interest rate, market and credit risks as well as risks related to the financial strength of the insurance companies. Due to the level of risk associated with any investment, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuations of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a subsequent market exchange.

#### NOTE G - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

A substantial portion of the investments are fixed and variable annuities, a pooled separate account, and mutual funds sponsored by TIAA and CREF and TIAA Trust, N.A. TIAA is the Plan's recordkeeper, TIAA and CREF are the Plan's insurance companies and TIAA Trust, N.A. is the custodian of certain Plan investments; therefore, transactions related to these investments qualify as party-in-interest transactions. TIAA also charges participant initiated transaction fees that qualify as party-in-interest transactions. For 2024, the Plan paid \$21,827 for these fees. The Plan also pays advisory fees. As a service provider to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$22,400 for the year ended December 31, 2024.

The custodian provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the custodian provides to the funds. This revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan. If the revenue received by the custodian from such mutual fund service providers exceed the amounts owed, the custodian remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, approximately \$9,000 was received and is included in net realized and unrealized appreciation in investments in the statement of changes in net assets available for benefits and approximately \$22,000 was used to pay Plan expenses. There were remaining balances of approximately \$8,000 and \$21,000 at December 31, 2024 and 2023, respectively.

#### NOTE H - MUTUAL FUND FEES

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or "12b-1 fees," which are ongoing fees allowable under the Investment Company Act of 1940 and are annual fees deducted to pay for the marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and they are therefore not separately identifiable as expenses.
