Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Massaro Construction Group Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Massaro Construction Group Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

Note 1 – Description of Plan

The following description of The Massaro Construction Group Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan is a defined contribution 401(k) plan covering all employees of Massaro Construction Group (the Company), Massaro Corporation, Massaro Restoration Services, LLC, Massaro Construction Management Services, LLC and Massaro Building Company, LLC, excluding collectively bargained employees, non-resident aliens with no U.S. source income, leased employees, and part-time employees who do not have 1,000 hours of service in an eligibility computation period as defined by the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA), as amended.

Employee Contributions – The Plan was amended effective January 1, 2019 to become an automatic enrollment plan. All employees who became eligible on or after January 1, 2019 were automatically enrolled with a default deferral election of 3% unless they actively elect a different amount or elect not to contribute. Their contributions are invested in a default investment election unless they make a specific investment election. Effective September 1, 2023, the Plan increased the automatic enrollment contribution to 5% for newly enrolled participants. Effective January 1, 2024, the automatic contribution arrangement deferral percentage increased from 3% to 5% of compensation for all participants previously auto-enrolled before September 1, 2023.

Participants may elect to defer up to 100% of pretax compensation, as defined in the Plan agreement, not to exceed statutory limitations. Participants may also contribute rollovers from other qualified plans. All contributions, including the employer contributions, may be directed at the discretion of each participant into the various investment options offered by the Plan.

Employer Contributions – The Company may match a discretionary percentage of the participants' salary deferrals as determined annually. During 2024 and 2023, the Company made matching contributions equal to 100% of the first 3% of employee compensation deferred and 50% of the next 2% of employee compensation deferred. The discretionary matching contribution for December 31, 2024 was \$331,518. The Company may also contribute a discretionary amount to the Plan. This amount is decided annually by the Company and is allocated to all eligible participants. During 2024 and 2023, the Company chose to forego a discretionary contribution. All employer contributions are calculated at the end of the Plan Year and are allocated to eligible participants. Employees must complete 1,000 hours of service and be employed on the last day of the Plan Year to receive these contributions, except in the case of death, disability, or retirement.

Participant Accounts – Each participant's account is credited with (a) the participant's contributions, (b) the Company's contributions, (c) forfeitures, and (d) any earnings or losses thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in 100 percent of their elective salary deferrals, rollover contributions and earnings thereon. Matching contributions are also immediately 100% vested. Employer discretionary contributions, if any, are subject to the following:

Forfeitures – Forfeitures represent participant account balances that are not vested upon the termination of an employee. Forfeitures may be used to reduce employer contributions or to pay administrative expenses of the Plan, as determined by the Company at its sole discretion. At December 31, 2024 and 2023, there were \$3,657 and \$201, respectively, of unallocated forfeitures.

Payment of Benefits – On termination of services, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in their account.

Administrative Expenses – Third party administrator recordkeeping and other administrative fees are allocated to participant accounts. Fees for transactions such as distributions are credited to the participant’s account to which the fee applies. Plan expenses paid for by the Company include audit fees.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are valued at fair value as of the last trade price or the last bid price as of the valuation date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment gains (losses) includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Contributions – Participants’ elective deferrals and Company contributions are recognized as additions to Plan assets in the year designated by the participant and Company, respectively.

Payment of Benefits – Benefits are recorded when paid.

Note 3 – Plan Termination

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan or reduce or cease contributions at its discretion, or to amend the Plan at any time and in any respect, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance.

Note 4 – Plan Amendments

Effective September 1, 2023, the Plan was amended to increase the automatic enrollment contribution to 5% for newly enrolled participants.

Effective January 1, 2024, the automatic contribution arrangement deferral percentage increased from 3% to 5% of compensation for all participants previously auto-enrolled before September 1, 2023.

Note 5 – Parties in Interest

Plan investments are held by Ascensus Trust Company. Ascensus Trust Company is the custodian for the Plan and Ascensus LLC is the Plan recordkeeper, therefore, their transactions qualify as party-in-interest transactions. Expenses paid by the Plan to Ascensus LLC amounted to \$4,547 for the year ended December 31, 2024. Other fees paid by the plan were for investment management, third party administration, and transaction fees. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

Note 6 – Tax Status

The Plan obtained a favorable advisory letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 – Information Certified by the Plan's Custodians

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Mid-Atlantic Trust Company and Ascensus LLC (authorized representative of Ascensus Trust Company), the custodians of the plan, except for comparing such information certified by the custodians to information included in the Plan's financial statements. The custodians certified to the completeness and accuracy of all investment activity reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the supplemental schedule as of December 31, 2024.

Note 9– Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASB 820-10 are:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value:

Mutual funds are valued at the net asset value of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds are valued at the net asset value of shares held by the Plan at year end. The collective trust funds held by the plan are not traded in an active market but have published fair values.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
