We have performed audits of the financial statements of Robert Fox, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 8, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period January 1, 2024 through October 8, 2024, and the related notes to the financial statements (collectively, the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. #### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Robert Fox, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a participant-directed defined contribution plan established on January 1, 1997 by Robert Fox, Inc. and its wholly-owned subsidiary, Orchard Apparel Group, Ltd. (collectively referred to as the “Company”, the “Employer”, or the “Plan Sponsor”) to provide benefits for all eligible employees, as defined in the Plan document. All employees are eligible to participate in the Plan, except for residents of Puerto Rico and independent contractors. Assets of the Plan are held by a trust established under the Plan with Charles Schwab Trust Bank (“Trustee” or “Schwab”). For the year ended December 31, 2023 TD Ameritrade Trust Company (“TD Ameritrade”) held the assets of the Plan and served as the Trustee, TD Ameritrade was acquired by and merged into Charles Schwab Trust Bank effective the period beginning January 1, 2024. The Trustee invests all contributions and allocates to each participant account its proportionate share of investment income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On October 8, 2024, the Plan transferred all assets and liabilities to the Ascensus - American Funds Pooled Employer Plan (the “Successor Plan”). As a result of the Plan Sponsor engaging a Professional Employer Organization for its benefits management, net assets of \$7,491,656 were transferred to the Successor Plan on October 8, 2024.

##### **Plan Administration**

The Company is the administrator of the Plan and as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. Schwab serves as the Plan’s directed trustee and asset custodian and Newport Retirement Services (“Newport” or “Recordkeeper”) provides record-keeping services and manages participant accounts and participant related transactions.

##### **Contributions**

Each year, participants may contribute to the Plan, on a pre-tax basis up to 100% of compensation, with dollar limits established by the Internal Revenue Code (“IRC”). The Plan requires an automatic deferral contribution of 3% of compensation for new employees, unless the participant elects not to make a contribution or elects a different percentage. Such contributions are excluded from the participant’s Federal taxable income until received as a withdrawal or distribution from the Plan. Participants may also elect to contribute to the “after tax,” Roth 401(k) Deferral Contribution. Except, with respect to the application of income taxes to Roth Deferral Contributions, Roth Deferral Contributions are subject to the same rules applicable to “pre-tax” Deferral Contributions, as described above. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). During 2024 the maximum annual 401(k) pre-tax contribution limit was \$23,000, and the maximum annual catch-up contribution for participants aged 50 and older was \$7,500. For the period January 1, 2024 through October 8, 2024, participant salary deferrals amounted to \$323,194.

The Plan provides for a discretionary employer matching contribution on a percentage of a participant’s compensation. For the period January 1, 2024 through October 8, 2024, the employer matching contribution was 25% of the first 4% of base compensation that a participant contributed to the Plan and totaled \$47,842. Employee rollover contributions from other qualified plans and catch-up contributions are excluded from the Company’s salary match. The Company may make qualified non-elective contributions (“QNECs”) in addition to employer matching contributions and employer discretionary matching contributions. The Company did not make any QNECs to the plan during the period January 1, 2024 through October 8, 2024.

**Participant Accounts**

Each participant’s account is credited or charged with the participant’s contribution and allocations of (i) employer’s 401(k) matching contributions and (ii) the participant’s share of earnings or losses on contributions and administrative expenses. Each participant directs all amounts credited into their account into one or more of the investment options available under the Plan. Accordingly, as a participant-directed plan, each participant’s investments determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions, rollovers and QNECs plus actual earnings thereon. Vesting in the Employer’s matching and non-elective contribution portion of their accounts plus actual earnings thereon is based on a 6-year graded vesting schedule, as follows:

**Investment Options**

Participants direct the investment of their contributions in 1% increments, into various investment options offered by the Plan. Participants may change their contribution investment options daily, transfer part or all of past investments to other funds daily, and may elect to change their deferral percentage or stop making contributions at any time.

**Notes Receivable from Participants**

Participants may borrow from their vested fund account balance at a minimum of \$1,000 and up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding Plan loan balance during the preceding year or (b) one-half of the value of their vested fund account balance reduced by any outstanding loan balance. The maximum payment term allowed for any loan will be five years (unless the loan is for the purchase of a principal residence in which case the term may not exceed 10 years) with interest fixed at the prime rate (8.00% and 8.50% as of October 8, 2024 and December 31, 2023, respectively) plus 1% at the time of the approval of the loan. The loans are measured at their unpaid principal balance plus any accrued but unpaid interest. A participant may have no more than three loans outstanding at any time. The loans are secured by the balance in the participant’s account, bear interest from 4.25% to 9.50% and mature at various dates through May 2029. Principal and interest are paid ratably through payroll deductions. Participant loan balances of \$102,842 were transferred to the Ascensus - American Funds Pooled Employer Plan on October 8, 2024.

**Hardship and In-Service Withdrawals**

The Plan Administrator may authorize a lump-sum distribution of the participant’s salary deferrals (excluding any investment earnings) but not to exceed the amount necessary to meet the financial need created by the hardship provided the participant submits positive evidence of an immediate and heavy financial need as defined in the Plan. The minimum hardship withdrawal is \$500. In-service distributions of the participant’s vested interest are available for any reason upon attaining age 59½.

**Benefit Payments**

On termination of service due to death, disability or retirement, as defined in the Plan, participants are generally entitled to a fully vested lump-sum payment of their account balance. For termination of service due to other reasons, participants are entitled to the value of the vested interest in their account as a lump-sum distribution. Under the terms of the Plan, if the vested value of the account of a participant is \$1,000 or less, the Plan Administrator will direct the Trustee to distribute it to the participant as a lump sum distribution without the participant's consent. As of October 8, 2024 and December 31, 2023, all employees who elected to withdraw from the Plan had been paid.

**Deemed Distributions**

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded in the calendar quarter during which the loan was defaulted.

During the period January 1, 2024 through October 8, 2024, there were \$9,444 of deemed distributions.

**Forfeited Accounts**

When certain terminations of participants in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. However, if the participant is re-employed and fulfills certain requirements, as defined in the Plan, the participant's account will be reinstated. Unvested forfeitures may be used to pay expenses of the Plan, then to reduce the Employer's matching contribution.

**Expenses of the Plan**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared in accordance on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 8, 2024 or December 31, 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan.

**Payment of Benefits**

Benefits are recorded when paid.

**Investment Valuation and Income Recognition**

All Plan investments are held by the Trustee. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. The assets of the Plan are subject to market fluctuations which could affect balances available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as components of net appreciation or decline in fair market value of investments for such investments.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were issued, October 6, 2025.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab and TD Ameritrade, the Trustees of the Plan, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of October 8, 2024 and December 31, 2023; and
- Net appreciation in the fair value of the investments, interest and dividend income and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period January 1, 2024 through October 8, 2024.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (“FASB”) established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Valued at quoted market prices of shares held by the Plan.

*Money market fund:* Valued at quoted market prices of shares held by the Plan.

*Common collective trust:* Valued at the net asset value (“NAV”) of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – EXEMPT PARTY-IN-INTEREST**

At October 8, 2024, certain Plan investments were managed by Schwab and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to the Trustee were \$47,332 for the period January 1, 2024 through October 8, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with a Cash or Deferred Arrangement (“CODA”) sponsored by TD Ameritrade. TD Ameritrade received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, as to the Plan’s qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan’s management does not believe it has any uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
