In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kinseth Hotel Corporation 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Kinseth Hotel Corporation 401(k) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Kinseth Hotel Corporation 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 DESCRIPTION OF PLAN

The following description of the Kinseth Hotel Corporation 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering employees of Kinseth Hotel Corporation (the Company) who have completed 1,000 hours of service within the one-year time period following their date of hire or when the employee completes one year of service, as defined, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective October 10, 2018, the Plan amended its eligibility requirements to waive age and service requirements and to retain years of service for vesting purposes for any Kahler Hotels LLC employee employed on September 30, 2018. Also, the Plan was amended to allow participants a share in matching contributions regardless of the amount of service they complete during the plan year and to exclude highly compensated employees of Kahler Hotels LLC from matching contributions.

Contributions

Participants may contribute up to 100% of compensation, as defined in the Plan. However, total deferral is subject to a dollar limit, which is set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective September 1, 2024, participants also have the option to contribute post-tax compensation through Roth contributions. The Company's board of directors may elect to make a discretionary contribution of up to 6% of participant compensation. In order to share in the discretionary contribution, the participant must be actively employed and actively contributing to the Plan for the period that the discretionary contribution relates to (i.e., quarter, etc.). During the years ended December 31, 2024 and 2023, discretionary contributions of 3% of applicable participant compensation were made totaling \$99,039 and \$88,253, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of service as follows:

Notes Receivable from Participants

Participants may borrow from their vested account balance. The loans may not exceed the lesser of (1) \$50,000 or (2) 50% of the participant's vested account balance, with a minimum initial loan balance of \$1,000. Loans are secured by the balance in the participant's account and bear a reasonable rate as determined by the Plan's custodian. Loans are repaid in level payments made not less frequently than quarterly over the term of the loan.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive benefits in one of the following forms: joint and survivor annuity, another form of an annuity, installment payments, or in a lump-sum payment. If the participant account balance is less than \$5,000 at the time of separation from service, the participant is automatically paid in a lump sum.

Forfeited Account Balances

Forfeitures from nonvested account balances may be used to reduce future employer contributions and to pay administrative expenses. At December 31, 2024 and 2023, nonvested account balances available for future use were \$-0- and \$209, respectively. During the years ended December 31, 2024 and 2023, \$2,918 and \$4,224, respectively, from forfeited nonvested account balances was used to pay administrative expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no benefits payable to be allocated to accounts of persons who had elected to withdraw from the Plan but had not yet been paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets available for benefits during the reporting period. Accordingly, actual results could differ from those estimates.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position taken that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The plan administrator has evaluated their material tax positions and determined there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Company.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of those other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and inputs other than quoted prices that are observable for the asset. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds, collective investment trust funds, money market fund – The fair values of the mutual funds, the collective investment trust funds, and the money market fund are based on quoted net asset values of the shares held by the Plan at year-end. These funds are deemed to be actively traded.

NOTE 4 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Administrative expenses paid directly by the Plan for 2024 and 2023 were contract administrative fees of \$15,698 and \$14,138, respectively, paid to EPIC Retirement Plan Services, the third party administrator, and investment advisory and management fees of \$38,085 and \$36,674, respectively, paid to Steele Capital Management.

Certain investments are managed by Schwab Capital Trust, an affiliate of Charles Schwab Trust Bank, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 6 TAX STATUS

Kinseth Hotel Corporation 401(k) Retirement Savings Plan has adopted the EPIC Retirement Plan Services Non-standardized Profit Sharing/401(k) Plan sponsored by EPIC Advisors, Inc. (EPIC). EPIC received an opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the prototype document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan itself has not received a determination letter. Although the Plan has been amended since the date of the opinion letter, the prototype sponsor and the plan administrator believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued. There were no subsequent events required to be accrued or disclosed.
