Note 1 – Plan Description

The following description of the InVeris Training Solutions, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the provisions of the Plan.

General: The Plan is a defined contribution employee 401(k) and profit-sharing plan. The Plan was established by InVeris Training Solutions, Inc. (formerly known as Meggitt Training Systems, Inc.) (the “Company”) as a spin-off from the Meggitt-USA, Inc. 401(k) Plan on June 30, 2020, with approximately \$43 million in assets transferring into the Plan. Effective August 27, 2020, the Plan was amended to reflect the plan sponsor’s name change (from the Meggitt Training Systems, Inc. 401(k) Plan to the InVeris Training Solutions, Inc. 401(k) Plan). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective July 12, 2022, Felix Alejandro, Vincent Dimeo, Scott Harris, and Al Weggeman are the trustees of the Plan. Effective August 24, 2023, the Plan added Andrea P. Czop as a trustee of the Plan.

The Plan was amended and restated effective January 1, 2022 to bring the Plan into compliance with the requirements of the 2017 Cumulative List (Notice 2017-37).

The Plan covers all employees of the Company, excluding union employees, non-resident aliens, leased employees, employees acquired in a Section 410(b)(6)(C) transaction, and certain co-op employees, who have completed at least 2 months of service, as defined in the Plan.

Contributions: Each year, participants may voluntarily contribute a portion of compensation, as defined in the Plan, on a pre-tax or Roth basis, not to exceed the Internal Revenue Service limit (\$23,000 in 2024 and \$22,500 in 2023). Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants who do not affirmatively elect to contribute to the Plan are automatically enrolled in the Plan with a contribution amount of 6% of compensation. The Plan provides that participants who will be at least age 50 by the end of the tax year and are making salary deferrals to the Plan can make an additional catch-up contribution (up to \$7,500 in both 2024 and 2023) on a pre-tax basis, if their pre-tax contributions have otherwise been restricted by Plan or IRS limits.

The Company may contribute a discretionary profit sharing contribution each Plan year. The Company did not contribute a discretionary profit sharing contribution during 2024 or 2023. Effective February 13, 2021, the Plan was amended to adopt a discretionary matching contribution. For the 2024 and 2023 Plan years, the Company contributed \$1,135,796 and \$1,098,340, respectively, in matching contributions. Catch-up contributions are not matched.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s discretionary contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are vested immediately in their contributions and any Company matching contributions plus actual earnings thereon. Company profit sharing contributions, if any, vest according to the following vesting schedule:

Payment of Benefits: Upon termination of employment for any reason, a participant’s vested account balance will be distributed in a lump-sum, installment, or partial distribution amount to the participant, or designated beneficiary, at his or her option. Hardship withdrawals of pre-tax, Roth, or rollover contribution accounts by active employees are permitted to the maximum amount available for hardship distribution in the account of the participant under Plan provisions. All accounts are also available for in-service withdrawal upon attainment of age 59½. Active employees are also entitled to a variety of non-hardship withdrawal options for their after-tax, rollover, and participant’s vested portion of Employer matching contribution accounts.

Notes Receivable From Participants: The Plan provides for loans from Plan accounts to participants from a minimum of one thousand dollars (\$1,000) to a maximum of the lesser of (1) \$50,000, reduced by their maximum outstanding Plan loan balance within the preceding 12 months or (2) 50% of the participant’s account balance. The loans are payable over a maximum of five years, unless the loan is used to acquire a principal residence, in which case, the maximum term is fifteen (15) years. A participant may have up to two loans outstanding at any time. The loans are secured by the balance in the participant’s account and bear a commercially reasonable rate of interest. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts: Forfeitures, resulting from application of the vesting provisions, are maintained separately by the Plan, and are used to reduce future Employer matching contributions or to pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,747 and \$2,161, respectively.

SECURE Act and CARES Act: On December 20, 2023, the IRS released Notice 2024-2, which extends the deadline for adopting any SECURE Act plan amendments until December 31, 2026, to provide relief for plan sponsors waiting for final IRS guidance on many of the SECURE Act's provisions. The Notice also extends the deadline for the 2020 waiver in the CARES Act of required minimum distributions until December 31, 2025. These amendments can be retroactively adopted; therefore, the Plan can implement the amendments prior to amending the plan instrument. Similarly, plans may have voluntarily adopted provisions under the CARES Act by placing them in operation without amending the plan as long as the plan management makes the required amendments to plan documents by December 31, 2026.

SECURE 2.0 Act of 2022: The SECURE 2.0 Act of 2022 ("SECURE 2.0 Act") was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the SECURE 2.0 Act generally need not be made until the end of the first plan year beginning on or after January 1, 2025; however, plans must be operated in accordance with the effective date of each new provision. There is no current impact to the Plan and these provisions did not have an impact on the financial statements. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates: The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and custodians. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments: Benefit payments are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3 – Tax Status of Plan

The Plan uses a Non-Standardized Pre-Approved Profit Sharing Plan With CODA plan document sponsored by Transamerica Retirement Solutions LLC. Transamerica Retirement Solutions LLC obtained an opinion letter on June 30, 2020, in which the IRS stated that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA plan document used by the Plan, as then designed, qualifies under Internal Revenue Code ("IRC") Section 401. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include risks related to pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 5 – Investments and Information Certified by the Custodians

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Transamerica Trust Company (as of December 31, 2024 and for the period from March 26, 2024 to December 31, 2024) and Transamerica Life Insurance Company (as of March 26, 2024 and for the period from January 1, 2024 to March 26, 2024 and as of and for the year ended December 31, 2023), the custodians of the Plan, as complete and accurate, except for comparing such information certified by the custodians with information included in the Plan's financial statements and supplemental schedules:

During the years ended December 31, 2024 and 2023, the Plan’s investments (including gains and losses on investments bought, sold, as well as held during the year) appreciated in value by \$4,771,498 and \$6,021,004, respectively.

Note 6 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment contract: Guaranteed investment contracts ("GIC") are valued at fair value based on underlying investments held by the GIC, which are predominantly observable assets with quoted market prices (see Note 7). Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the Plan's management evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings.

The categorization of an investment within the fair value hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Guaranteed Investment Contract with Transamerica Life Insurance Company

In 2020, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica Life Insurance Company (Transamerica) totaling \$2,590,192 for 2024 and \$4,306,884 for 2023. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0.75%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 7 – Guaranteed Investment Contract with Transamerica Life Insurance Company (continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 9 – Related-Party Transactions and Party-In-Interest Transactions

Management believes that fees paid during the year for administrative, recordkeeping, and managerial services rendered by Transamerica Trust Company and Transamerica Life Insurance Company, the custodians as defined by the Plan, and Transamerica Retirement Solutions LLC, the recordkeeper as defined by the Plan, were based on customary and reasonable rates for such services. These transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.
