### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Binex MSD 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Binex MSD 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

## Note 1 – Description of the Plan

The following description of the Binex MSD 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General and Eligibility

Binex Line Corp. (the “Company” or “Plan Sponsor”) established the Plan effective January 1, 2006. The Plan is a defined contribution plan covering all employees of the Company who are age 20 or older and have completed 3 months of service (one hour of service is credited for each month). Employees enter the Plan on the first day of the month following meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

### Participant Contributions

Each year, participants may contribute up to 100% of participant’s annual compensation, as defined by the Plan not to exceed certain statutory limitations, into any of the investment funds offered by the Plan on a tax-deferred basis. Such contribution was limited to \$23,000 in 2024. Participants aged 50 or older or who will turn 50 during the Plan year, are allowed to make additional pretax cash-up contributions up to maximum of \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

### Employer Contributions

The Plan includes provisions for required matching contributions as well as discretionary profit-sharing contributions. The Company contributes 100% of the base compensation that a participant contributes to the Plan. The Company will not match elective deferrals that exceed 8% of eligible compensation. The Company may also elect to make a discretionary nonelective contribution to the Plan. No nonelective contributions were made in 2024.

### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service, as defined in the Plan, according to the following schedule:

Years of Service	% Vested

3 years but less than 4 years	40%

## **Note 1 – Description of the Plan (Continued)**

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$500 and up to a maximum that is equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. Participants must fully repay through payroll deductions within 5 years unless the loan is used for the purchase of a principal residence. If the loan is used for the purchase of a principal residence, the Administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear a reasonable interest. The interest rate is the prime rate as published in The Wall Street Journal on the 14th of each month, plus two percentage points. This interest rate is effective for any loan processed as of the 16th day of the month. Principal and interest is paid ratably through payroll deductions. If participants terminate employment, any remaining payments are due immediately.

As of December 31, 2024 and 2023, outstanding participant loan balances were \$163,845 and \$64,744, respectively.

### **Distribution of Benefits**

On termination of service due to death or disability, all amounts credited to participant's account become fully vested and lump sum distribution will be made to the beneficiary. Hardship and in-service distributions are also permitted provided certain eligibility requirements are met.

### **Administrative and Investment Management Expenses**

Record keeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Plan sponsor.

### **Forfeited Accounts**

Forfeitures will be used to restore forfeitures, reduce employer contributions, or pay plan expenses. For the year ended December 31, 2024, \$32,235 of the unallocated forfeitures was used to reduce Company's matching contributions for 2024. As of December 31, 2024 and 2023, forfeited account balance was \$1,542 and \$893, respectively.

## **Note 2 – Summary of Significant Accounting Policies**

The accounting and reporting policies of the Plan conform to accounting principles generally accepted in the United States of America (US GAAP).

### **Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. Quoted market prices are used to value investments and shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Payment of Benefits**

The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan, but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Plan Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

### **Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **Recently Issued Accounting Standard**

In August 2018, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") No. 2018-13, Fair Value Measurement (Topic 820) Disclosure Framework Changes to the Disclosure Requirements for Fair Value Measurement. ASU 2018-13 improves and simplifies the disclosure requirements for fair value measurements. Plan management adopted ASU 2018-13 effective January 1, 2020; its adoption did not have a material impact on the Plan's financial statements.

## **Note 3 – Information Certified by the Trustee**

The Plan's investments were held by Reliance Trust Company, the Plan's trustee, as of December 31, 2024 and 2023 and for the year ended December 31, 2024. All investments are participant-directed. All investment information disclosed in the accompanying financial statements and supplemental schedule (Schedule H, Part IV, Line 4i) including investments held at December 31, 2024 and 2023, and net realized and unrealized appreciation or depreciation in fair value of investments, dividends, interest, and other income for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Plan's trustee.

## Note 4 – Fair Value Measurements

ASC 820-10 establishes a framework for measuring fair value as it related to financial assets and liabilities and to non-financial assets and liabilities measured at fair value on a recurring basis. Such framework provides fair value three-level valuation hierarchy based on upon observable and unobservable inputs with preference given to observable inputs.

The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1** – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets.

**Level 2** – Significant other observable inputs other than Level 1 prices such as quoted prices in markets that are not active, quoted prices for similar assets, or other inputs that are observable, either directly or indirectly, for substantially the full term of the asset.

**Level 3** – Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following description of the valuation method and assumption used by the Plan to estimate the fair values of investments applies to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

## Note 5 – Party-In-Interest Transactions

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. No plan investments in mutual funds are managed by Reliance Trust Company, the trustee of the Plan, as of December 31, 2024. Purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants held by the Plan are considered party-in-interest transactions.

## Note 6 – Income Tax Status

The Company has adopted a prototype plan and relies upon the prototype plan’s opinion letter from the IRS, which stated that the plan and related trust are designed in accordance with applicable sections of the IRC. The Company has not applied for a determination letter from the IRS specific to the Plan. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no tax audits in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
