Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Evenflo Company, Inc. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE A – DESCRIPTION OF PLAN

The following description of the Evenflo Company, Inc. Savings Plus Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information. The Plan was effective August 21, 1998. The Plan was amended and restated effective January 19, 2022.

General Information

The Plan is a defined contribution plan covering substantially all employees of Evenflo Company, Inc. and Columbus Trading-Partners USA, Inc. (collectively, the Plan Sponsor or the Company) who have 30 days of service. Temporary employees must have one year of service or 1,000 hours of service. The Benefits Committee of the Company controls and manages the operation and administration of the Plan. Schwab Retirement Plan Services, Inc. serves as the trustee of the Plan (the Trustee). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute up to 75% of their pre-tax annual compensation, as defined in the plan document, subject to certain Internal Revenue Code (the Code) limitations. Plan provisions include automatic enrollment at 3%. The Company contributes 50% of the first 6% of base compensation that a participant contributed to the Plan each pay period, not to exceed 3% of the employee base compensation. The Company's matching contributions for the year ended December 31, 2024, totaled \$839,219. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and plan earnings and forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed; however, the Benefits Committee of the Company has control over the investment offerings made available to plan participants.

Vesting

Participants are vested immediately in their contributions, Company matching contributions and Company discretionary contributions, if any, plus actual earnings thereon.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts were \$4,467 and \$23, respectively. These accounts are used to reduce future employer contributions. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions.

Payment of Benefits

Upon retirement, death, or other interruption of continuous service, a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments. Upon termination, benefits relating to a participant's contributions and vested employer contributions are distributed.

Notes Receivable – Participant Loans

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loans are secured by the balance in the participant's account and bear interest at rates equal to the Trustee's prime rate determined as of the time the application for the loan is made. The participant loans must be repaid over a period not to exceed five years, unless the purpose of the loan is to acquire, construct, or substantially rehabilitate a dwelling that is to be used as a principal residence for the participant, in which case the loan period may not exceed 15 years. Principal and interest is paid ratably through payroll deductions. The interest rates on outstanding loans ranged from 3.25% to 9.50% as of December 31, 2024.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board's Accounting Standards Codification (ASC).

Contributions

Participant contributions are recognized when withheld. Employer matching contributions are recognized concurrently with participant contributions.

Payment of Benefits

Benefits are recorded when approved. There were no approved but unpaid benefits as of December 31, 2024 or 2023.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan’s participant-directed investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

NOTE C – INVESTMENTS AND INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL)’s Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and dividends and interest for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D – FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurements* (ASC Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets of the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Stated at fair value as defined by observable quoted prices in active markets (Level 1).

Collective investment fund: Stated based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE D – FAIR VALUE MEASUREMENTS (CONTINUED)

The collective investment fund is a fully benefit-responsive investment contract with the Trustee and plan contributions are maintained in a general account. The account is credited with earnings on the underlying investments. The objective of the fund is to maintain safety of principal while generating a level of income generally exceeding that of a money market fund. The fund seeks to maintain a stable \$1.00 net asset value, although this is not guaranteed.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE F – PARTY-IN-INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of collective investment funds and registered investment companies managed by the Trustee and therefore, these transactions qualify as party-in-interest. However, they are exempt from the prohibited transactions rules under ERISA.

Certain administrative services are provided by the Company at no cost to the Plan. Administrative expenses paid by the Plan were \$92,977 for the year ended December 31, 2024.

NOTE G – INCOME TAX STATUS

The Internal Revenue Service (the IRS) has determined and informed the Company by a letter dated September 21, 2020, that the Plan and related trust are designed in accordance with the applicable requirements of the Code. Although the Plan has been amended and restated since receiving the approval letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) of the Plan if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan has no uncertain tax positions that require adjustment to the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

NOTE I – CORRECTIVE CONTRIBUTIONS

For the plan year ended December 31, 2024, the plan administrator identified one participant who was deferring at a rate contrary to their elected deferral rate. The plan administrator believes it has made necessary changes to the design of the Plan’s internal controls relating to the administration of employee deferral rates. The Company intends to make contributions to the participant to resolve the operational error. At December 31, 2024, included within employer contributions receivable was \$3,267 to address this plan error. The plan administrator has consulted with counsel and believes the resolution of this matter will not impact the tax qualification.

For the year ended December 31, 2024, the plan administrator identified one participant from whom the Plan Sponsor withheld but did not remit participant contributions. The plan administrator believes it has made necessary changes to the design of the Plan’s internal controls relating to the remittance of participant contributions. The Company intends to make contributions to the participant to resolve the operational error. At December 31, 2024, included within employee contributions receivable was \$1,087 to address this plan error. The plan administrator has consulted with counsel and believes the resolution of this matter will not impact the tax qualification.

NOTE J – CORRECTIVE DISTRIBUTIONS

The Plan failed to pass the Actual Deferral Percentage test for the plan year ended December 31, 2023. The accompanying statements of net assets available for benefits include a liability of \$22,667 as of December 31, 2023 related to the excess contributions due to the participants. As of December 31, 2024, the Plan completed corrective distributions to fully satisfy all excess contribution liabilities related to the 2023 plan year. These corrective actions were performed in accordance with applicable regulatory requirements to ensure the Plan’s continued compliance with Internal Revenue Code §401(k) and §401(m) nondiscrimination testing provisions.
