### Note A – Description of the Plan

#### General

The Crowley Retirement Income System Plan (the “Plan”) was adopted December 31, 1986 and was most recently restated effective January 1, 2015. It is a defined contribution pension plan for the benefit of all employees of Crowley Maritime Corporation (the “Company” or “Employer”) who are credited with one hour of service, except for: seasonal employees, hourly employees or interns with less than 1,000 hours of service; all union members whose bargaining agreements do not provide for application to the Plan; and all nonresident aliens who receive no U.S. earned income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan consists of two separate components: the Retirement Savings Account (“RSA”) and the Individual Pension Account (“IPA”).

Employees become eligible for the RSA component on the first day of the calendar month after they become an eligible employee as defined in the Plan document. Employees become a participant in the IPA component as of the date that they are credited with one hour of service. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### Administration of the Plan

The accounting records are maintained by the Company. The Plan’s assets were held and managed by Fidelity Management Trust Company (the “Custodian”). Contributions are held by Custodian, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Retirement Savings Account (RSA)

Participants are automatically enrolled at 6%, with an annual increase of 1% up to a maximum of 10%, unless elected otherwise. Participants may contribute up to 75% of base annual salary as defined in the Plan subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the year ended December 31, 2024 was \$23,000. The participant may designate how the savings are to be invested among various investment funds and may change the allocation at any time. The Company makes a 50% matching contribution, not to exceed 6% of the participant’s salary and not in excess of the amount per person allowed under Section 415 of the IRC. The Plan allows for catch up contributions up to \$7,500 for the year ended December 31, 2024 for those participants who will be 50 years of age or older by December 31st of each year. Participants are fully vested in the RSA at all times and have the right to receive the balance of their account as soon as administratively possible after they terminate or retire.

#### Individual Pension Account (IPA)

The Company makes contributions equivalent to 3% of the participant’s annual eligible earnings (base salary plus performance bonus, overtime pay and any differential allowance), but not in excess of the amount per person allowed under Section 415 of the IRC. Any participant who is credited with one hour of service on or after January 1, 2008 is fully vested in the IPA at all times and has the right to receive the balance of their account as soon as administratively possible after they terminate or retire.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with loan fees as applicable. Allocations are based on participant earnings or account balances, as defined. Transfers between funds and changes in contribution allocations are made based on participant instructions, subject to Plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Note A – Description of the Plan (continued)

#### Vesting

Participants are vested immediately in their employee and employer contributions plus actual earnings or losses thereon.

#### Notes Receivable from Participants

Participants may borrow up to 50% of the funds in their RSA account, with a minimum of \$1,000 and a maximum of \$50,000 for each loan. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans Fund. Only one loan per participant may be outstanding at a time, and it must be repaid within a maximum of 5 years. The loans are secured by the balance in the participant's account. The interest rate charged on Plan loans is 2% above the prime interest rate at the time the loan is made. Principal and interest payments paid on participant loans are paid into the participant's individual account.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution as of the first day of the second calendar quarter following the calendar quarter in which the participant failed to make a required installment payment.

#### Benefit Payments

Participants can elect to receive benefits in a lump sum cash payment or other payment forms as provided by the Plan. If a participant's vested balance is \$5,000 or less, the Company may distribute the entire vested account balance to the participant without their consent. Benefits may be received when a participant demonstrates a situation of financial hardship as defined by the IRC.

The Plan was voluntarily amended effective January 1, 2024, which increased the force-out amount from \$5,000 to \$7,000.

#### Death and Disability Benefits

If an active participant dies prior to retirement, the value of the participant's RSA will be paid as a lump sum benefit or other payment form as provided by the Plan. Active participants who become totally and permanently disabled may elect to receive their RSA account balances in a lump sum, as an annuity, or they may leave their account balance in the Plan until a later date. Once eligible for retirement, the participant will begin to receive distributions from the Plan.

#### Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts are used to pay administrative expenses or reduce future Employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$57,000 and \$49,000, respectively. No forfeitures were utilized to reduce Employer contributions and Plan expenses during the year ended December 31, 2024.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and non-forfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

### Note B – Summary of Significant Accounting Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### Accounting Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates and assumptions.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments

#### Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Mutual funds represent investments with various investment managers. The fair value of these investments are determined by reference to the fund’s underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (“NAV”) as of December 31, 2024 and 2023.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Fair Value Measurements (continued)

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that derived principally from or corroborated by observable market data by correlation or other means.  
If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* These are open-ended money market mutual funds valued at a \$1.00 stable NAV for reporting purposes and transact at \$1.00 for subscription and redemption activity. However, on a daily basis the funds NAV is calculated using the amortized cost (not market value) of the securities held in the fund.

*Common/collective trusts:* Valued at NAV provided by the Custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024 and 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. As of December 31, 2024 and 2023 and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Fidelity Management Trust Company, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

The IRS ruled on January 19, 2016 that the Plan qualified under Sections 401(a) and 401(k) of the IRC and was, therefore, exempt from federal income taxes. The Company believes the Plan, as currently designed, continues to qualify under Section 401(a) and 401(k) of the IRC. Accordingly, no provision of federal income taxes has been made.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

### Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note F – Party-In-Interest Transaction

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are shares of mutual funds managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$225,000 during the year ended December 31, 2024.

### Note G – Subsequent Events

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.
