### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Sun Pacific 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1 – Plan Description**

The following description of the Sun Pacific 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. This plan information is available at the corporate office of Sun Pacific Shippers, LP.

General

Effective January 1, 2018, the Plan is a defined contribution plan, covering employees of Sun Pacific Farming Cooperative, Inc, Sun Pacific 7<sup>th</sup> Standard Ranch Company, Sun Pacific Marketing Cooperative Inc. and Sun Pacific Shippers, LP (the Plan Sponsor) who are not non-resident aliens or independent contractors of the Plan Sponsor. Employees are eligible for entry on the employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 90% of compensation as defined in the Plan. In addition, total deferrals in any plan year may not exceed the dollar limit which is set by law. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans excluding Roth or voluntary after-tax contribution (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Funding consists of employee salary reductions and nonelective employer contributions. Participants may change their deferred election anytime online. Each pay period, the Plan Sponsor makes a nonelective contribution equal to four percent of the compensation of each eligible participant.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer's nonelective contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, including elective deferrals, catch-up contributions and rollover contributions, plus actual earnings thereon. For any employer contributions plus actual earnings thereon, participants vest 100 percent after three years and 500 hours of service.

Notes Receivable from Participants

The Plan does not permit participant loans.

Payment of Benefits

Participant's vested interest in his or her account may be distributed upon retirement, termination of employment, death or hardship. A participant may elect to receive his or her account balance in a lump sum payment or in equal installments over a fixed period selected by the participant based on guidelines provided in the Plan agreement. If the participant's vested account is under \$5,000, it will be paid out in a single lump sum. In the event of undue financial hardship, participants may withdraw all or a part of elective deferral contribution (not earnings) for immediate financial need. Also, a participant may withdraw any part of his/her eligible vested amount (resulting from elective deferral contributions) after attaining age of 59 ½.

Forfeited Accounts

Forfeited nonvested account balances are retained by the Plan and are used to offset Plan expenses, pay as additional discretionary nonelective contributions or reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested account balances totaled \$288,169 and \$273,497 respectively. In 2024, \$61,173 in administrative expenses were paid from the forfeited nonvested account.

**NOTE 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contribution. The Plan had excess contributions for the years ended December 2024 and 2023. The Plan distributed the 2024 and 2023 excess contributions prior to March 15, 2025 and March 15, 2024, respectively.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor which are excluded from these financial statements. Fees related to the distribution are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE 3 – Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and the related net depreciation/appreciation in fair value of investments, dividends and capital gains for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company (the Custodian).

**NOTE 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets.
- b. Quoted prices for identical or similar assets or liabilities in inactive markets.
- c. Inputs other than quoted prices that are observable for the asset or liability.
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4 – Fair Value Measurements (continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective Investment Funds (CIF) – Collective investment funds are made up of a wide variety of underlying investments such as equities and other collective investment funds. The net asset value of a CIF is based on the market value of its underlying investments, but collective investment fund's net asset value is not a publicly quoted price in and active market.

Mutual Funds – Valued at the daily closing price as reported by the fund. These funds are traded daily using their net asset value. All capital gains and dividends paid from these investments are reinvested into the fund's unit value.

**NOTE 5 – Related-Party Transactions and Party-in-Interest Transactions**

The Plan Sponsor pays for various plan fees, including bond fees, audit fees and recordkeeping. For the period January 1, 2024, through December 31, 2024, Plan investments were managed by Principal Trust Company, who is the custodian of the Plan. Participants of the Plan pay for investment management and recordkeeping. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Transactions with these service providing companies qualify as party-in-interest transactions. For the year ended December 31, 2024, the party-in-interest transactions were as follows:

These party-in-interest transactions are exempt from the prohibited transactions rules of the ERISA.

**NOTE 6 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7 – Tax Status**

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – Risks and Uncertainties**

The assets of the Plan are invested in various investment securities at the direction of the participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
