NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023
(LIQUIDATION BASIS)

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of The Retirement Plan of the Amalgamated Insurance Fund (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for complete information.

General - The Plan was adopted by the Amalgamated Insurance Fund Retirement Fund (“the Fund”) to provide eligible participants, who are primarily located in the Northeast, Mid-Atlantic, and Midwest regions of the United States, with benefits upon their retirement. The Plan is a defined benefit pension plan and is subject to the provisions of the ERISA, as amended.

Withdrawal Liabilities, Plan Termination and Pension Benefit Guaranty Corporation Loan - During 1996, the Plan entered into an agreement with the Pension Benefit Guaranty Corporation (“PBGC”) designed to maximize long-term contribution income to the Plan in the face of declining participation. Under the PBGC Relief Agreement (the “Agreement”), each agreeing employer’s withdrawal liability and contribution rate was capped, with past service related contributions applied as a credit against its withdrawal liability (calculated pursuant to mass withdrawal rules).

The Agreement provides for an agreed-upon mass withdrawal following the determination by the actuary of an accumulated funding deficiency in the Plan’s Funding Standard Account. The actuary projected such funding deficiency to occur during the year ended December 31, 2004, retroactively resulting in the agreed-upon mass withdrawal as of December 31, 2003.

The Fund’s Board of Trustees determined the Plan would no longer accept contributions from contributing employers and voted to terminate the Plan effective December 31, 2003, thereby triggering a mass withdrawal, as defined in ERISA. Once the agreed-upon mass withdrawal occurred, the Plan terminated, active employees ceased to accrue benefits, nonvested employees lost their accrued benefits to the extent not funded, employer contributions ceased and employers who were parties to the Agreement commenced payment of their net agreed-upon mass withdrawal liability over a 20-year period with interest at 6.2%. The employers were assessed their mass withdrawal liability provided by statute. Thereafter, the Plan continued paying benefits to pensioners at their vested benefit levels until the Plan no longer had sufficient assets to pay benefits when due. The Plan became insolvent in 2005. The PBGC began making monthly advances to pay the guaranteed benefits in September 2005. The advances from the PBGC have been structured as loans and bear interest at the rate in effect under Section 6621 (a) (2) of the Internal Revenue Code of 1986 (the “IRC”), compounded daily. The balance advanced from the PBGC was \$501,055,270 and \$484,311,410 as of December 31, 2024 and 2023, respectively. The amount of interest accrued on these advances was \$354,030,161 and \$288,928,834 as of December 31, 2024 and 2023, respectively.

NOTE 1. DESCRIPTION OF THE PLAN (continued)

As of December 31, 2024 and 2023, the actuarial present value of vested benefits exceeded Plan net assets by \$989.3 million and \$920.7 million, respectively. In accordance with the Multiemployer Pension Plan Amendments Act of 1980, the Plan requires assessment of withdrawal liabilities on employers withdrawing from the Plan. Since 1980, cumulative withdrawal liabilities amounting to \$313.4 million has been assessed, of which \$108.8 million has been collected, \$203.7 million has been written off as uncollectible, and the remaining withdrawal liability outstanding of \$0.9 million is recorded as receivable at December 31, 2024 and 2023.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - As a result of the Fund's Board of Trustees decision to terminate the Plan, the basis for accounting in the accompanying financial statements is the liquidation basis.

Estimates - The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; the disclosure of contingent assets and liabilities; and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses - Administrative expenses were paid from the Plan's assets.

Payment of Benefits - Benefit payments are recorded when paid.

NOTE 3. PRIORITIES UPON TERMINATION

Effective December 31, 2003, the Plan was terminated. Accordingly, the assets remaining in the Plan, after providing for administrative expenses, are required to be paid to beneficiaries and participants of the Plan in the manner specified by ERISA, and in accordance with the trust agreement and the agreement with the PBGC, as discussed in Note 1.

Certain benefits under the Plan are insured by the PBGC. The PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations.

Whether all participants receive their benefits will depend on the sufficiency of the Plan's assets to provide for accumulated benefit obligations and the level of benefits guaranteed by the PBGC.

NOTE 4. TAX STATUS

The Plan has received a determination letter regarding the termination from the Internal Revenue Service dated June 19, 2012, stating the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus is qualified and the related trust tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal, state or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. RELATED PARTY TRANSACTIONS

Retirement benefits are administered for the Plan by Amalgamated Employee Benefits Administrators, Inc., (AEBA), a wholly-owned subsidiary of ALICO Services Corporation (“the Company” or “ASC”). AEBA and the Company are parties in interest to the Plan, and a member of the Board of Directors of the Company serves as Trustee to the Plan. Plan service expenses represent amounts charged by AEBA for administrative services conducted on behalf of the Plan. The Plan paid \$1,023,313 and \$1,070,821 to AEBA during 2024 and 2023, respectively.

The other funds serviced by the Company are referred to as “related parties” in the accompanying financial statements.

The Plan maintains a banking relationship with Amalgamated Bank (the “Bank”). All decisions concerning the relationship are determined by the employer trustee of the Plan. The Plan paid \$20,252 and \$22,375 to the Bank during 2024 and 2023, respectively.

These transactions qualify as party-in-interest transactions under ERISA.

NOTE 6. ACTUARIAL INFORMATION

Actuarial present value of accumulated Plan benefits is the present value of expected future payments for benefits to Plan participants that have been accrued as of the termination date. Accumulated benefits include amounts expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of vested participants who have died and (c) present participants or their beneficiaries.

The actuarial present value of accumulated Plan benefits is determined by an actuary from the Segal Company and is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.
