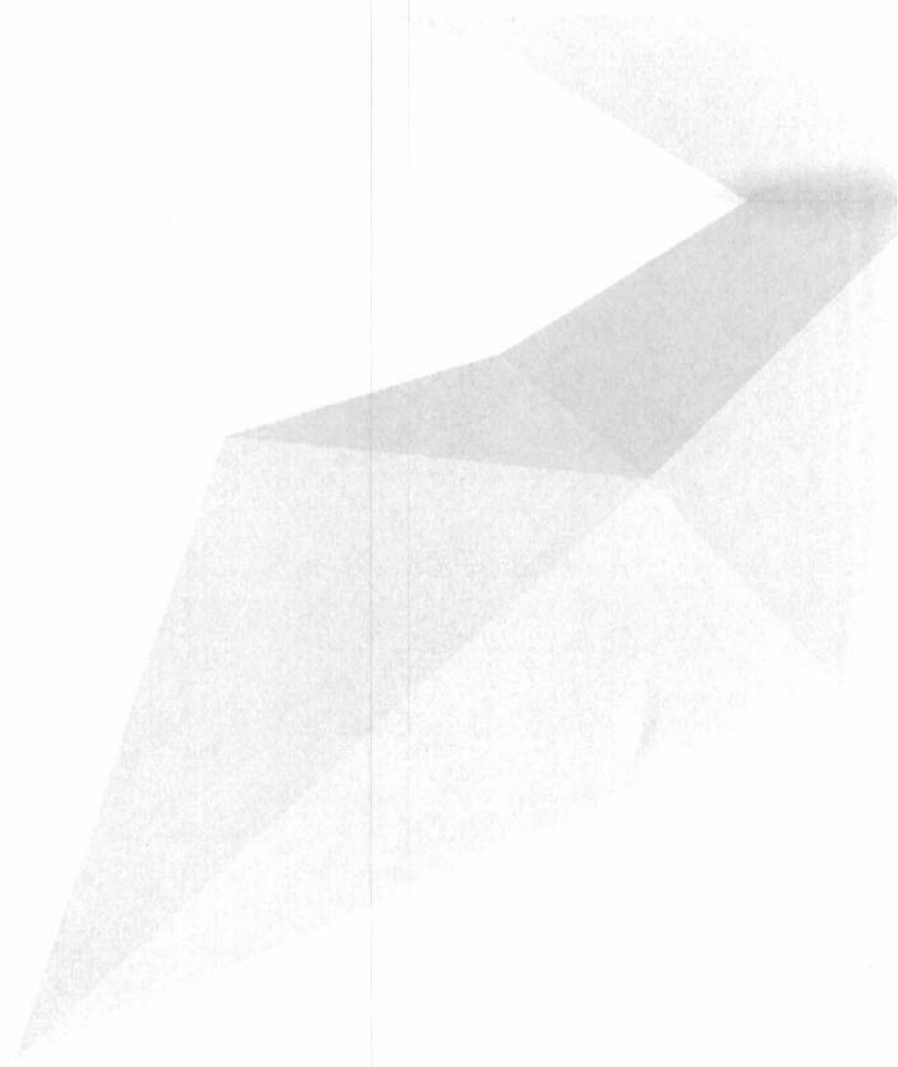

We have performed an audit of the financial statements of Onix Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of Plan

The following description of Onix Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Onix Group, LLC (the Plan Sponsor) and its participating affiliates (collectively the Employer) all of which are a part of the same controlled group. Each employee of the Employer who has reached age 21 and has completed the required service requirements, as defined by the plan, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), as amended.

Contributions

Participating employees are allowed to make contributions, through salary deferrals of 1% to 90% of compensation, as defined in the Plan. Participants may designate all or part of their elective contributions as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, participants may contribute funds from another qualified plan (rollover contributions) subject to certain requirements.

The Plan is a safe harbor plan whereby the employer shall make matching contributions in an amount equal to 100% of elective deferrals that do not exceed 3% of eligible compensation and an additional 50% of elective deferrals greater than 3% up to 5% of eligible compensation for the Plan year. The employer made safe harbor matching contributions of \$764,849 for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's deferrals, rollovers and employer safe harbor contributions, allocations of plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral, rollover contributions, employer contributions, and related earnings.

Notes Receivable From Participants

Participants may borrow from their Plan accounts. The minimum permitted note is \$1,000 and the maximum permitted note is the lesser of \$50,000 or 50% of their vested account balance, as defined. Notes must be repaid, with interest, over a period normally not to exceed five years. If the note is for the purchase of a principal residence, a longer repayment period may be permitted. Participants are only allowed one note outstanding from the Plan at any time. Notes are secured by participant balances and bear interest at 1% above the prime rate, as defined, determined at the time of borrowing. Interest rates ranged from 4.25% to 9.50% on notes outstanding as of December 31, 2024 and 2023. Principal and interest are paid ratably through regular payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive the value of the participant's vested interest in his or her account in the form of a lump-sum payment or non-recurring partial payments. The Plan also allows for in-service distributions upon attaining age 59½. Hardship distributions may also be made subject to certain requirements and Plan provisions. The Plan will also make mandatory distributions following severance from employment to participants with a vested balance under \$7,000 (\$5,000 before January 1, 2024).

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Security purchases and sales are accounted for on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Expenses

Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Note 3: Fair Value Measurements (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the NAV of shares of the trust held by the Plan at year end which is used as a practical expedient to measure fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities.

Note 4: Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus LLC, as agent for Ascensus Trust Company, the Trustee of the Plan.

Note 5: Party-in-Interest Transactions

Certain Plan investments include shares of mutual funds, which are managed by Vanguard. Vanguard is the recordkeeper, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are netted against net appreciation in fair value of investments and fees for administration of the plan are reported as administrative expenses. These transactions are deemed to be party-in-interest transactions. The Plan also has arrangements with various other service providers which qualify as party-in-interest transactions under ERISA. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7: Income Tax Status

The employer adopted a non-standardized pre-approved plan document with an Internal Revenue Service opinion letter which states the plan document is in compliance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended and restated since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Company is required to remit the participant contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Company's general assets. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan year ended December 31, 2024, totaling \$238, were not remitted at the earliest day reasonably segregated. These transactions constitute prohibited transactions as defined by ERISA.
