Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the ALLETE and Affiliated Companies Welfare Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the ALLETE and Affiliated Companies Welfare Benefits Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the ALLETE and Affiliated Companies Welfare Benefits Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of the Plan

The following description of the ALLETE and Affiliated Companies Welfare Benefits Plan (“Plan”) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan’s provisions.

General

Effective January 1, 2020, ALLETE, Inc. (“Company”) maintains the Plan for the exclusive benefit of its eligible employees, eligible retirees, and other persons made eligible by their relationship to the eligible employee. This Plan is comprised of different benefit programs that are subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Benefits

The Plan provides benefits through the following component benefit programs: Medical Insurance Plan, Retiree Health Plans, Dental Insurance Plan, Flexible Benefits Plan, Life and AD&D Insurance Plan, Disability Insurance Plan, Severance Benefit Plan, and Employee Assistance Plan. Some of these component benefit programs may be governed by an insurance contract or benefit plan description. Each component benefit program may also be summarized in a certificate of insurance coverage issued by the insurance company or a separate Summary Plan Description.

Contributions and Funding Policy

Medical Insurance Plan – Employee contributions are made biweekly. Employer contributions to the Plan are made monthly in amounts determined by negotiations between the Companies and the Medical Plan Negotiating Committee. The plan is substantially a self-insured welfare plan that is subject to ERISA.

Retiree Health Plans – Company contributions, as calculated by the actuary, are made in amounts necessary to fund the benefits provided by the Plan. Benefits are funded using a Voluntary Employee Benefit Association (VEBA) trust. The total maximum amount allowed as a tax deduction is contributed to the VEBA. Any excess funding is placed in an irrevocable grantor trust until it can be used to make tax-deductible contributions to the VEBA. Funds in the irrevocable grantor trust do not qualify as plan assets.

The plans are substantially self-insured welfare plans that are subject to the provisions of ERISA. The costs of the Plan’s postretirement benefits are shared by the Company and retirees. Retiree contributions to the Plan are made monthly in amounts determined by the Board of Governors and were approximately 25% of the estimated cost of the benefits.

Life and AD&D Insurance Plan – Employer contributions represent contributions made by the Company for core life insurance coverage for all eligible employees, as well as contributions made by the Company to a VEBA trust fund established under the Internal Revenue Code (IRC) Section 501(c)(9) for core life insurance coverage provided to retired employees.

Employee contributions represent contributions made by eligible employees through payroll deductions for supplemental life insurance, accidental death and dismemberment insurance, dependent life insurance and supplemental spouse insurance.

Contributions and Funding Policy (Continued)

Retiree contributions represent contributions made by retired employees on a monthly basis for additional dependent life insurance coverage.

Other plan benefits are fully insured and are paid out of general Company assets.

Administration

U.S. Bank, N.A, Principal Trust Company, and North Shore Bank of Commerce act as trustees (“Trustees”) for the Plan. The Plan is administered by the Employee Benefit Plans Committee (“Committee”) of the Company.

Expenses of the Plan

Administrative expenses, which include insurance premiums for major claims, computer services, federal and state taxes, audit, legal, trustee and certain Company expenses incurred in administering the Plan, are paid by the Plan from each trust fund. Employees who provide services to the Plan receive no compensation for their services with respect to the Plan.

Plan Termination

The Company reserves the right to reduce, suspend or discontinue their contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each trust estate will be used to provide benefits for eligible participants in accordance with the Plan.

2. Summary of Significant Accounting Principles

Basis of Accounting

The accounts of the Plan are maintained on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, the accounts of the Plan include only those claims and expenses approved and paid prior to December 31. Contributions, interest and dividend income from investments are recorded when received. Modifications to the cash basis of accounting include accruing insurance premiums.

Use of Estimates

The preparation of the Plan’s financial statements in conformity with the modified cash basis of accounting requires the Plan to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period. Actual results could differ from the estimates.

Investment Valuation and Income Recognition

The modified cash basis of accounting provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Valued at cost which approximates fair value.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the modified cash basis. Realized gains and losses and unrealized appreciation and depreciation of plan assets are reported in the statements of changes in net assets available for benefits – modified cash basis as net appreciation (depreciation) in fair value of investments.

Benefits

Benefits are recorded when paid, with the exception of life insurance premiums which are recorded when incurred.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks of loss such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

Subsequent Events

Management of the Plan has evaluated all subsequent events through October 14, 2025 for possible inclusion as a disclosure in the notes to the financial statements. The Plan has no subsequent events that require disclosure in the notes to the financial statements.

3. Accumulated Postretirement Benefit Obligation

The Accumulated Postretirement Benefit Obligation (APBO) is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims data to estimate future annual incurred claims per participant and to adjust such estimates for the time value of money and the probability of payment between the valuation date and the expected date of payment.

4. Information Certified by Outside Parties

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the Plan's independent public accountants, Reilly, Penner & Benton LLP, did not perform any auditing procedures generally accepted in the United States of America with respect to the Plan's investments, accrued income, realized and unrealized gains and losses, capital gain distributions, interest, dividends, or other investment income certified by the Trustees.

7. Federal Income Tax Status

The VEBA trusts funding certain benefits of the Plan received exemption letters from the Internal Revenue Service dated December 12, 1995 and February 9, 1999, in which the Internal Revenue Service stated that the Plan, as then designed, was tax-exempt under the provisions of Section 501(c)(9) of the IRC. The Plan has been amended since receiving the determination letter. However, as a result of the Plan's funding policy, from time to time the trusts may be subject to income taxes.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Department of Labor or Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

All transactions involving the Trustees, the Company, plan participants or other fiduciaries are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.
