INDEPENDENT AUDITOR'S REPORT

To the Ballad Health Retirement Plan Committee:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Wellmont Hawkins County Memorial Hospital Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

NOTE A--DESCRIPTION OF THE PLAN

The following description of the Wellmont Hawkins County Memorial Hospital Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was established as a defined contribution pension plan under Section 401(a) of the Internal Revenue Code (IRC). The Plan was available to all employees of Wellmont Hawkins County Memorial Hospital (the Hospital) that were at least 19 years of age. In order to receive matching contributions and have a plan year count toward the vesting schedule, participants must work at least 1,000 hours in that year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Wellmont Health System was the sole member of the Hospital. Mountain States Health Alliance and Wellmont Health System consummated a merger to form Ballad Health on February 1, 2018. Ballad Health became the sole member of both Mountain States Health Alliance and Wellmont Health System.

Contributions: Effective December 31, 2011, the Plan was frozen, with no future employer contributions permissible. No employee contributions were allowed in the Plan. Employees may participate in one of three retirement plans sponsored by Ballad Health.

Participant Accounts: Each participant's account is credited with an allocation of Plan earnings and charged with an allocation of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants became 100% vested in the Hospital's contributions as of December 31, 2011.

Forfeitures: During the year ended December 31, 2024 and 2023, nonvested forfeited accounts totaled approximately \$15,700 and \$16,990, respectively. Approximately \$730 of forfeitures were used to pay Plan expenses during the year ended December 31, 2024.

Payment of Benefits: Upon termination of employment due to death, disability, retirement or other reasons, a participant may elect to receive his or her vested amount under one or more of the optional forms available under the Plan. The amount of the payment(s) will depend on the vested amount in the participant's account, the participant's age or the age of the participant's survivor and the optional form chosen. The optional forms of benefit payment(s) include either a single lump-sum payment or single, joint and survivor, certain period life, installment refund, or fixed-period annuities.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Year Ended December 31, 2024

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments in pooled separate accounts are reported at estimated fair value based on the underlying investments. The insurance contract held by the Plan is reported at contract value. Contract value represents the value of deposits, plus accrued interest, less withdrawals. The custodian and Plan management have determined that the fixed income contract with the insurance company is fully benefit-responsive and that contract value is the relevant measurement for financial statement preparation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold during the year, as well as held at year end.

Benefit Payments: Benefit payments are recorded when paid.

Administrative Expenses: Administrative expenses related to accounting fees are paid by the Plan. Additional Plan expenses related to legal and accounting fees may be paid by the Plan or by Ballad Health.

NOTE C--INFORMATION CERTIFIED BY THE CUSTODIAN

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by American United Life Insurance Company (AUL), the custodian of the Plan, and was not subjected to any auditing procedures performed by the Plan's independent public accountants:

- The investments as shown in the accompanying Statements of Net Assets Available for Benefits of \$1,797,754 and \$1,713,650 as of December 31, 2024 and 2023, respectively.
- Net appreciation in fair value of investments of \$222,568 and interest, dividends and other income of \$22,788 as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- All investment-related information in the accompanying supplemental Schedule H, Line 4i – Schedule of Assets Held at Year End as of December 31, 2024.

NOTE D--CONTRACT WITH INSURANCE COMPANY

In 1993, the Plan entered into a group annuity contract with AUL. The contract offers fixed income investment options, which are held by AUL in a general account. The fixed interest investment options guarantee principal and a minimum guaranteed interest rate for the life of the contract. The interest rate credited to the accounts is guaranteed by AUL to exceed 4% for amounts in the fixed interest account attributable to contributions not transferred to this contract from another AUL group annuity contract and to amounts transferred from any other investment option. The crediting interest rates are generally reset monthly based upon formulas that may use market value, book value, duration, and yield. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Hospital or other Hospital events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. Management believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE E--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy based on valuation inputs. The three levels of the fair value hierarchy are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets;
 - Quoted prices for identical or similar assets and liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.
- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Year Ended December 31, 2024

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods described in Note B may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used on December 31, 2024 and 2023.

NOTE F--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by AUL. AUL is the custodian and recordkeeper as defined by the Plan, and therefore, any fees paid to AUL or others engaged by the Plan related to investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments.

NOTE G--PLAN TERMINATION

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE H--INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Hospital by a letter dated June 26, 2014, that the Plan was designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Amendments to the Plan occurring after receipt of the tax determination letter are not considered to affect the Plan's tax status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE J--SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued. During this period, management did not note any material recognizable subsequent events that required recognition or disclosure in the financial statements.
