## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of ATHENS ORTHOPEDIC CLINIC, P.A. 401(K) PROFIT SHARING PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of ATHENS ORTHOPEDIC CLINIC, P.A. 401(K) PROFIT SHARING PLAN'S financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Athens Orthopedic Clinic, P.A. (the Company) 401(K) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering substantially all eligible employees of the Company who have completed a Year of Service (1000 hours of service during a twelve-month period) and who have attained age 18. The Plan is subject to the provisions of ERISA.

*Contributions*

Participants may elect to defer a percentage or dollar amount of their compensation subject to annual Internal Revenue Service maximum deferral limits. Deferral contributions may be made on a pre-tax or a Roth (after-tax) basis. Employees may also make rollover contributions of amounts distributed from other qualified retirement plans.

The Plan makes a fully vested 3% safe harbor nonelective contribution to all eligible employees. During 2024 and 2023, safe harbor employer contributions totaled \$758,740 and \$710,772, respectively. Additionally, the Plan allows for discretionary nonelective (profit sharing) and discretionary matching contributions. During 2024 and 2023, discretionary nonelective contributions totaled \$977,025 and \$966,777, respectively. There were no discretionary matching contributions for 2024 or 2023.

*Participant Accounts*

Each participant's account is credited with the participant's deferral contributions, rollovers, and Company contributions along with a proportionate amount of investment earnings or losses of the funds in which the contributions are invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Expense allocations are based on participant account balance or a per-capita allocation to all participant accounts. Fees related to specific participant transactions (such as distribution fees) are deducted from the account of the participant requesting the transaction. Participants may direct the investment of their account balance to any of the Plan's investment alternatives and may transfer among investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are vested immediately in their deferral contributions plus actual earnings thereon. They are also immediately vested in Safe Harbor contributions made by the Company. Vesting in the profit sharing contribution portions of the participant's accounts is based on years of service. A participant is 100% vested after four years of credited service.

*Benefits*

On termination of service, death, disability, or retirement, the participant or their beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may request a withdrawal of a portion of their employee contribution account balance if they can demonstrate financial hardship as defined by the Plan.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,652 and \$14,339, respectively. These accounts have been used to reduce 2025 safe harbor employer contributions to the Plan and pay Plan expenses. During the year ended December 31, 2024 and 2023, \$0 and \$1,156 were used to reduce plan expenses. No forfeitures were used to reduce the employer profit sharing contributions for the years ended December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Morley Stable Value Fund is a collective trust and is reported at contract value. Brighthouse Variable Annuity Series L (previously named MetLife Annuity) is also valued at contract value.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes realized and unrealized changes in fair value of investments bought, sold, and held during the year.

*Benefit Payments*

Benefit payments are recorded when paid.

*Plan Expenses*

The Plan's administrative expenses are paid by either the Plan or the Company as provided by the Plan document. Investment advisory fees are deducted from participant accounts. Certain transaction-related charges such as distribution fees are deducted from the accounts of the participants that incurred the charge.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1                      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2                      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Self-Directed brokerage accounts:* Valued at the daily closing price of all the assets held in these accounts. Self-directed brokerage accounts allow experienced investors to choose their own investments, including those investments not normally offered in the Plan. Participants in these accounts are responsible for actively managing their accounts, such as selecting which stocks, bonds, etc. to invest in and which investments to sell. Because these accounts are entirely composed of actively traded investments, the value of self-directed brokerage accounts is readily determinable.

*Mutual Funds:* Valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus the liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

Beginning in 2013, the Plan has a fully benefit-responsive guaranteed investment contract with Morley Capital Management totaling \$1,818,754 and \$1,627,316 at December 31, 2024 and 2023, respectively. This fund invests primarily in a variety of high quality Stable Value Contracts (the performance of which may be predicated on underlying fixed income securities), as well as cash and cash equivalents. The underlying fixed income securities must be rated investment grade at the time of purchase and meet issuer diversification guidelines. Generally investment contracts include annuity contracts issued by insurance companies and agreements issued by banks that provide varying guaranteed interest or guaranteed book value liquidity, as well as certain other types of contracts, each of which provides book value accounting treatment for the fund.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Morley, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) plan investment reallocation directed by the plan sponsor, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, large layoffs or transfers of employees), that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) communications from the plan sponsor designed to encourage participants to redeem their Fund Units. Due to these restrictions, plan sponsor directed withdrawals from the Fund require twelve months advance written notice. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 5 - VARIABLE ANNUITY FUND

The Plan's investments include participation in a variable annuity fund, an annuity contract issued by Brighthouse Life Insurance Company. As permitted by generally accepted accounting principles for employee benefit plans (*FASB ASC 962*), the variable annuity contract is presented at contract value, which represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value represents the cash value of the contract (before any applicable surrender, contract or other termination charges, or any market value adjustments as of year-end). The contract does not guarantee a minimum interest rate; investment returns are based on the performance of the selected subaccounts. For the years ended December 31, 2024 and 2023, the contract value was \$177,617 and \$169,197, respectively.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE 7 - TAX STATUS

The Plan utilizes a pre-approved plan document. The Internal Revenue Service issued an opinion letter on June 30, 2020 that the plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not requested an individual determination letter and has been amended since receiving the IRS opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

The Plan document has been amended to change the employee deferral eligibility requirements. Effective April 1, 2025, employees who are not in an excluded class who have attained age 18 are eligible to start deferrals immediately upon date of hire or rehire.

The Plan has evaluated subsequent events through October 11, 2025, the date the financial statements were available to be issued.
