### 1. PLAN DESCRIPTION

The following is a brief description of the AVOX Systems Retirement Savings Plan (the Plan) provided for general informational purposes. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering all bargaining-unit employees of AVOX Systems Inc. (the Company or Plan Sponsor) who complete one year of eligible service prior to the beginning of the respective quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As of December 31, 2024 and 2023, the Plan's assets were maintained by Newport Trust Company (Newport).

**Contributions** – The Plan Sponsor contributes quarterly an aggregate percentage of eligible compensation for each participant, based on his or her years of service and age, as defined in the Plan document.

**Participant Accounts** – Individual accounts are maintained for each plan participant. Participant accounts are increased by the Plan Sponsor contributions and the participant's share of Plan earnings (allocated daily) thereon. Participant accounts are decreased by the participant's share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. Upon retirement or termination, a participant is entitled to the balance in his or her account.

**Vesting** – Participants are immediately vested in their portion of Plan Sponsor contributions and earnings thereon.

**Payment of Benefits** – A participant will be eligible for payment of benefits upon attaining normal retirement age, or death, prior to termination or severance date. Upon termination of service, a participant will receive a lump sum amount equal to the vested value of his or her account.

**Plan Termination** – Although it has not expressed any intent to do so, Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Company contributions and associated interest and earnings thereon.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes both realized and unrealized gains and losses incurred during the year.

**Contributions** – Contributions are recorded in the year in which the participants compensation is earned.

**Benefit Payments** – Benefits are recorded when paid.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates and assumptions.

**Subsequent Events** – The Plan has evaluated events and transactions that occurred between January 1, 2025 and October 6, 2025, which is the date these financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

### 3. FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- *Level 1* – Inputs to the valuation methodology that consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* – Inputs to the valuation methodology that include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived from or corroborated by observable market data by correlation or other means.
- *Level 3* – Inputs to the valuation methodology that are unobservable and are significant to the overall fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for Plan assets at December 31, 2024 and 2023:

- *Mutual funds* – Valued based on quoted market prices, which represent the net asset values (NAV) of the shares held by the Plan at year-end.
- *Collective investment trust* – The investment includes a stable value fund which holds guaranteed investment contracts, separate account guaranteed investment contracts, and synthetic guaranteed investment contracts. The collective investment trust is valued based on the NAV of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of the collective investment trust which is measured at fair value using the NAV practical expedient. The fair value for the collective investment trust is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

The Putnam stable value fund is measured at fair value using the NAV per share practical expedient. The investment can be redeemed daily and had no redemption notice period or unfunded commitments in 2024 and 2023. At December 31, 2024 and 2023, the fair value of the Putnam stable value fund was \$117,991 and \$106,083, respectively.

### 4. INCOME TAX STATUS

The Plan received a favorable determination letter from the Internal Revenue Service (IRS), dated April 27, 2016, stating that the Plan is qualified under the applicable sections of the Internal Revenue Code (IRC), and therefore, the related trust net investment income is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust net investment income is tax exempt.

### 4. INCOME TAX STATUS (*Continued*)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed tax positions taken by the Plan and concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

### 5. PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes a number of service providers which qualify as parties-in-interest. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
