Opinion

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the Clinical Pathology Associates Profit Sharing Plan and Trust (the “Plan”) is provided for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all regular employees of Hurt, Jacknow, Moore, Conner, Wells, Michels, Yurco, Listrom & Huang, Professional Association dba Oculus Pathology, formerly Clinical Pathology Associates (the “Company” or “Plan Sponsor”) who have completed one year of service and are at least 21 years of age. The Plan became effective April 1, 1969, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employee Contributions – Each year, participants may contribute the lesser of 100% or the maximum allowed by law (\$23,000 for 2024) of their pre-tax annual compensation, as defined in the Plan. The Plan also allows for catch-up contributions for participants at least 50 years of age (\$7,500 for 2024). Participants may also contribute amounts representing rollover distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions – The Plan Sponsor will make a safe harbor matching contribution equal to 100% of a participant’s elective deferrals up to 3% of the participant’s eligible earnings, as defined in the Plan document.

Additionally, the Plan allows the Plan Sponsor to make a discretionary profit-sharing contribution to the Plan. The total amount of profit-sharing contribution is determined as a percentage of participants’ total eligible compensation and is allocated to eligible participants as specified in the Plan document. During the year ended December 31, 2024, the Company made a discretionary profit-sharing contribution equal to 10.33% of eligible compensation in the amounts of \$2,036,455. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of: (a) the Company’s matching contribution and discretionary profit-sharing contributions, if any, and, (b) Plan earnings (losses), and charged with withdrawals and an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024, which are commensurate with local prevailing rates as determined by the Plan administrator. All notes must be repaid within a specified period of time, not to exceed 60 months, except those that are used for the purchase of a principal residence in which case the note can be extended for 20 years. Principal and interest is paid ratably through monthly payroll deductions.

Vesting – Participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company’s discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on a participant’s years of vesting service. A participant is 100% vested after six years of credited service as summarized as follows:

Note 1—Description of the Plan (continued)

Payment of Benefits – Benefits become available to participants on the earliest of four events: (1) termination of employment, (2) death of the participant (benefits are payable to the participant's spouse or beneficiary), (3) disability of the participant, or (4) the participant's retirement. Payments may generally be paid in a lump sum, a direct rollover, installments, various annuities, or partial payments.

Terminating participants with balances under \$1,000 are automatically paid as a lump sum unless they request a qualified rollover distribution. If the participant's account balance exceeds \$1,000, the participant may choose to keep the funds in the Plan, request a direct rollover to another qualified plan, or take partial, installment, or lump-sum distributions.

If a participant's benefits exceed \$5,000 when benefits begin, they will automatically be paid in an annuity form of payment unless the participant elects a different form of payment in accordance with the distribution election rules under the Plan. Additional information regarding the annuity and other forms of payment is provided in the Plan document.

Distributions During Employment – As a general rule, participant's contributions will remain in the Plan as long as the participant remains employed by the Company. The Plan does provide exceptions to this rule for withdrawals of the participant's contributions under certain circumstances that satisfy the criteria for a hardship withdrawal described in the Plan document.

Furthermore, participants who are at least age 59½ may elect an in-service distribution from their employee deferral contribution accounts and their safe harbor matching and profit-sharing contribution accounts, if 100% vested. Upon being credited with at least 10 years of vesting service, participants may withdraw all or any portion of their profit-sharing contribution account. Additionally, the participant is required to begin taking minimum distributions no later than April 1 of the calendar year following the calendar year the participant turns 72 or terminates employment, whichever is later.

Forfeitures – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$44,982 and \$46,353, respectively. Per the Plan document, these amounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, \$122,518 of forfeited nonvested accounts were used to reduce employer contributions and to pay for certain Plan expenses.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Income Recognition – The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments, which consists of realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Note 2—Summary of significant accounting policies (continued)

Investment Valuation – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. For the year ended December 31, 2024, \$15,199 was recorded as interest income on notes receivable from participants.

Contributions Receivable – Any participant-related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of year are reflected as participant contributions receivable in the accompanying financial statements. In addition, any contributions due and payable by the Company are reflected as employer contributions receivable in the accompanying financial statements.

Payment of Benefits – Benefits paid to participants are recorded when paid.

Administrative Expenses – Certain administrative expenses, including legal and accounting, are paid by the Plan Sponsor and, accordingly, are not reflected in the accompanying financial statements of the Plan. Certain transaction processing fees are charged to the participants and, therefore, are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment-related expenses are included in the net appreciation or net depreciation of the fair value of investments.

Note 3—Fair value measurements

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 3—Fair value measurements (continued)

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These public investment vehicles are valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

Self-Directed Brokerage Accounts – These investments are valued at current value based on published market quotations from individual investments composing the brokerage accounts. Such assets are classified as Level 1 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s financial instruments carried at fair value are classified by the following fair value hierarchy levels as of December 31:

Note 4—Party-in-interest transactions

Certain members of the Company’s management perform administrative and fiduciary duties for the Plan that qualify them as parties-in-interest and/or related parties of the Plan. Transactions between such members of management and the Plan were routine in nature and conducted pursuant to the Plan’s provisions as of and during the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions but are exempt from the prohibited transaction rules.

Note 5—Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

Note 6—Tax status

The Plan obtained its latest opinion letter on April 23, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through October 10, 2025, the date these financial statements were available to be issued.
