Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MVM, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. Description of the Plan

The following description of the MVM, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan with 401(k) salary deferral provisions covering substantially all full-time employees of MVM, Inc., a wholly owned subsidiary of KG&P Strategies, Inc. (KG&P) (the Company), and KG&P's wholly-owned subsidiaries: The Providencia Group, LLC, The KACE Company, LLC, and Sherpa LLC, DBA Evolve24.

The Plan does not include participation by leased employees, independent contractors, employees who are employed by the USMS 10th Circuit United Government Security Officers of America (UGSOA) collective bargaining agreement, or who are residents of Puerto Rico. There are no age or service requirements in order to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was restated, effective January 1, 2018, to allow for wage rate contributions equal to the fringe benefit amount determined according to the Prevailing Rate Schedule for each person reduced by contributions made to other plans that count towards satisfying the fringe rate stated in the Prevailing Rate Schedule.

Trustee, Custodian and Administration of the Plan

The trustee, custodian and recordkeeper of the Plan is Principal Trust Company and Principal Life Insurance Company (Principal). The administrator of the Plan is the Company. Principal holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary employer matching contribution to the Plan. During the year ended December 31, 2024, the Company did not make a discretionary employer matching contribution. The Company also makes qualified non-elective contributions to certain employees as defined by the Plan (health and welfare contributions). During the year ended December 31, 2024, the Company made health and welfare contributions of \$9,495,135 to the Plan. The Company may also make a profit sharing contribution as determined by the Company's Board of Directors. During the year ended December 31, 2024, the Company made \$1,299,288 in profit sharing contributions. Contributions are subject to certain Internal Revenue Service (the IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and allocations of the Company's matching, prevailing wage, and profit sharing contributions, if any, and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, non-elective employer contributions, and profit sharing contributions, plus actual earnings thereon. Participants vest ratably over four years of credited service in the discretionary employer matching contributions, or in the event of death or total and permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance of loans during the one-year period ending on the day before the new loan is made, or the greater of 50% of their account balance or \$10,000, reduced by any outstanding loan balance on the date the loan is made. Only one loan may be outstanding at any time and no more than three loans will be approved during the year. In general, loan repayment terms range from one to five years, unless used to purchase a principal residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates at the time the loan is made as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or any other reason, a participant or beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. Participants who are age 70½ or older are required to take certain required minimum distributions of their participant account balance each year as defined in the Plan. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

The Plan also provides for involuntary distribution of account balances for terminated participants with account balances of less than \$5,000. Participant accounts of terminated participants with balances which exceed \$5,000, may elect to receive a lump-sum amount, substantially equal payments for a specified term, elect to have all the distribution paid in a direct rollover to another qualified plan, maintain the balance in the Plan, or a combination of the above.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$157,647 and \$129,205, respectively. Forfeited accounts may be utilized to reduce administrative expenses or reduce employer contributions, other than qualified non-elective contributions. Remaining forfeitures are

allocated to participants in proportion to each participant's compensation for the year. In 2024, employer contributions were reduced by \$92,758 from forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

Investment Valuation and Income Recognition

Investments are reported at fair value, including the collective trust funds, which hold indirect investments in fully benefit-responsive investment contracts, and except for the Plan's direct investment in a fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to the fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance. See Note 4 for additional information related to fair value measurements.

The Plan's investments in mutual funds are valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Plan's investments in pooled separate accounts represent the NAV of shares held by the Plan at each year end. The Plan's investments in the collective trust funds are valued at NAV per unit, as determined by the trustee at year-end. The NAV is used as the practical expedient to estimate fair value for the Plan's investments in pooled separate accounts and common/collective trust funds. There are no unfunded commitments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in the methodologies used at December 31, 2024 or 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Upon termination of service due to death, disability, retirement or any other reason, a participant or beneficiary may elect to receive a lump sum amount, defer payment until retirement age established by the Plan, or receive an annuity equal to their vested account balance. In certain hardship situations, as described in the Plan, participants may withdraw all or part of their account balances while actively employed.

Upon termination of service, if the vested value of a participant's account is less than \$5,000, their account will be distributed in a single lump-sum payment. If the vested value of a participant's account exceeds \$5,000, the participant may elect to receive either a lump-sum amount, substantially equal payments for a specified term or elect to have all of the distribution paid in a direct rollover to another qualified plan, or a combination of the above.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended

December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

^(a) The purpose of the trust is to establish a stable value fund, which will be invested in one or more guaranteed separate account group annuity contracts issued by American Funds Service Company and Wilmington Trust to the Trustee (the Contract). The investment fund strategies seek to invest in securities which will provide competitive total returns relative to certain benchmarks as described in the fund's audited financial statements. If a withdrawal is made from the Contract as a result of an employer or plan sponsor-initiated event or if a withdrawal is requested due to a complete or partial termination of the Plan before the Contract ends, and the Contract's fair value equals or exceeds the Contract's guaranteed value, payment is made in an amount equal to the amount of the guaranteed value which is attributable to the Plan. If the Contract's fair value is less than its guaranteed value, the amount paid is equal to the guaranteed value reduced by the amount of fair value deficit allocable to the Plan.

5. Collective Investment Trust

The Plan holds investments in a series of funds under the Wilmington Trust Collective Investment Trust (the Trust). Wilmington Trust, N.A. (WTNA) serves as the Trustee. The Trust consists of separate funds with differing investment objectives. WTNA has engaged flexPATH Strategies, LLC (the "Sub-Advisor") to provide investment advice and recommendations with respect to investment of the Funds' assets. While the Trustee generally relies on the Sub-Advisor to manage the Funds'

assets, the Trustee maintains ultimate fiduciary authority over the management of and investments made in each Fund.

The fund is valued at NAV per unit. Units of each fee class of each Fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the Trustee. The NAV per unit is calculated as of the close of trading on the NYSE each day. The NAV per unit is computed by dividing the total fair value of the assets of a Fund, less its liabilities, by the total number of units outstanding at the time of such computation. The Funds sell new units and repurchase outstanding units on a daily basis. The Funds require the Company to provide a five-day written notice for withdrawals which will exceed \$1 million.

The Trust has investments in collective funds as well as other types of securities. Some funds may hold investments in units of other funds within the Trust or similar funds for which other unrelated entities are trustee. The Trustee or unrelated trustee estimates the fair value of investments in collective funds that have calculated NAV per unit in accordance with the specialized accounting guidance for investment companies. Accordingly, as a practical expedient, investments in other such funds are valued at their NAV as reported by the investee funds. The funds have the ability to redeem their investments in the collective funds at NAV without restrictions.

Securities, other than bonds, listed on a securities exchange, market or automated quotation system for which quotations are readily available are valued at the closing price on the primary exchange or market on which they are traded on the day of valuation or, if there is no such reported sale on the valuation date, at the most recent bid quotation on the principal exchange. If a market price is not readily available or if such price is deemed unreliable, it will be valued at fair value in accordance with valuation procedures established by the Trustee. The Trustee's determination of fair value involves consideration of a number of subjective factors, and therefore, no single standard for determining fair value will apply.

The investment contract issuers seek to preserve the principal investment and earnings but cannot guarantee that they will be able to do so. The collective trust is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There are no reserves against contract values for credit risk of the contract issuers or otherwise. There are no unfunded commitments.

6. Guaranteed Investment Contract With Principal Trust Company

In 2016, the Plan entered in a benefit-responsive guaranteed investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

7. Related Parties and Party-in-Interest Transactions

Certain Plan investments are managed by Principal. Principal is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. The Plan Sponsor pays any other fees related to the Plan's operations. Notes receivable from participants are also considered exempt party-in-interest transactions.

8. Income Tax Status

The Plan has adopted a prototype plan sponsored by Principal. The prototype plan has received an opinion letter dated June 30, 2020 from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

10. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

12. Delinquent Participant Contributions

During the Plan year ended December 31, 2021, participant contributions totaling \$324,271 were not remitted to the Plan within the period prescribed by DOL regulations. 13. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
