### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Murfin, Inc., Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF PLAN

The following description of the Murfin, Inc., Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The investment committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Eligibility - The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), covering all employees other than those classified as a member of a collective bargaining unit, leased, or temporary employee of Murfin, Inc. (Company) and its subsidiaries Kansas Tractor Parts Co., Inc.; Lift Truck Center, Inc.; Murfin Drilling Company, Inc.; Hurricane Services, Inc.; WKDC, LLC; Antimo LLC; Murphy Tractor & Equipment Co., Inc.; Mufin Media LLC; and My Town Media. Employees become participants in the Plan upon employment and when they have attained the age of 18. Employees are treated as participants on the first day following the date on which eligibility requirements are met.

Contributions - Under a qualified automatic contribution arrangement (QACA), participants may contribute on a pre-tax basis, after-tax basis, or a combination thereof to the Plan, between 1% and 100% of their compensation up to a maximum of \$23,000 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). The Company's QACA matching contribution is 100% of the first 1% of employee contributions and a 50% match on deferrals between 1% and 6% (3.5% maximum). Participants direct the investment of all contributions into various investment options offered by the Plan.

The Plan utilizes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their QACA deferral rate set at 6% of eligible compensation and their contribution invested in a designated balanced fund until changed by the participant.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants - Participants may borrow against their individual accounts, except for Roth deferrals, a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate as of the date of the note. Principal and interest is paid ratably through regular payroll deductions. Notes receivable may not exceed five years unless the note is for the purpose of purchasing a personal residence, in which case the term may be up to 30 years.

#### 1. DESCRIPTION OF PLAN (CONTINUED)

Forfeitures - Forfeitures are used to reduce the Company's contributions and pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$529,013 and \$309,067, respectively. In 2024, \$30,731 of forfeitures were used to reduce employer contributions.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participants' accounts is based on years of continuous service. A participant is fully vested after two years of credited service.

Payment of Benefits - Payment of the participant's account at retirement, death, disability or termination is in the form of either a lump-sum payment or periodic installments for required minimum distribution only. Distributions to participants whose vested accounts do not exceed \$1,000 shall be made upon termination of services in a lump-sum payment.

Normal Retirement - Normal retirement age is 65.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates - The accompanying financial statements of the Plan are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investment purchases and sold as well as held during the year.

Contributions - Contributions from Plan participants and the Company matching contributions from the employer are recorded in the year in which the participant contributions are withheld from compensation.

Payment of Benefits - Benefits are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance has been recorded as of December 31, 2024 and 2023 for these notes receivable. Delinquent loans are treated as distributions in the quarter following the

calendar quarter in which the participant missed the scheduled payment based upon the terms of the Plan document.

Administrative Expenses - Certain expenses of the Plan may be paid directly by the Company and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Some investment related expenses may be included in net change in fair value of investments.

Subsequent Events - These financial statements considered subsequent events through October 8, 2025 the date the financial statements were available to be issued.

#### 3. INFORMATION CERTIFIED BY ASCENSUS TRUST COMPANY (UNAUDITED)

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules that were prepared by or derived from information provided by Ascensus Trust Company (Ascensus), a qualified institution, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Ascensus that information provided to the Plan Administrator related to the following is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information below, the fair values in Note 4, and the values in the supplemental schedules related to the following assets:

The following describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds and Money Market Fund* - These investments are valued using a quoted price in an active market.

#### **5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are managed by The Vanguard Group, Inc. in connection with Ascensus (parties-in-interest), and therefore, these transactions qualify as party-in-interest transactions. The various funds' operating expense ratios ranged from 0.08% to 0.35% as of December 31, 2024. The Plan paid \$28,515 for administrative expenses for the year ended December 31, 2024.

#### **6. PLAN TERMINATION**

Although it has not expressed an intention to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination, and Ascensus shall liquidate all assets of the trust and continue to administer the trust in accordance with its provisions until all obligations have been satisfied.

#### **7. TAX STATUS**

The Plan has adopted the Ascensus LLC Non-Standardized Pre-Approved Profit-Sharing Plan. The Internal Revenue Service (IRS), in a letter dated June 30, 2020, has determined that this non-standardized pre-approved profit-sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The non-standardized pre-approved profit-sharing plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that it had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

#### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **9. PROHIBITED TRANSACTIONS**

For the period ended December 31, 2024, contributions of \$1,165 were not deposited within the required timeframe, as stated and interpreted by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The employer self-corrected the contributions and paid the applicable lost earnings subsequent to December 31, 2024. See also the supplemental Schedule of Delinquent Participant Contributions for more details.
