Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Ohio Shared Information Services, Inc. 401(k) Plan (the "Plan") have been prepared on the accrual basis using accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and those such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Related Party Transactions

Certain Plan investments are investments in funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the asset custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Ohio Shared Information Services, Inc. (the "Company") provides the Plan with certain accounting and administrative services for which no fees are charged.

Expenses

Fees related to the administration of payment of benefits, investment advisory and processing of other transactions are charged directly to the participant's account and are included in administrative expenses. Certain expenses of maintaining the plan are paid directly by the Company and excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Company. Eligible employees enter the Plan the first day of the month following attaining the age of 21. There is no service requirement to enter the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established by the Company effective February 1, 2003. The Plan was amended and restated in its entirety effective September 1, 2024 upon transfer of all plan assets from ADP Retirement Services to Fidelity Management Trust Company.

Contributions

Participants may elect to contribute between 1% and 90% of pretax or post-tax annual compensation, as defined in the Plan. These contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). Section 414(v) of the Internal Revenue Code of 1986 as amended allows a maximum catch-up contribution of \$7,500.

The Company makes safe harbor matching of 100% of the first 3% of compensation contributed to the Plan and 50% of the next 2% of compensation contributed to the Plan. During 2024, the Company made matching contributions totaling \$450,135.

Rollover Contributions

Participants can contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts

Each participant's account is credited with allocations of (a) the participant's contributions, (b) the Company's contributions, and (c) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their deferral contributions and employer safe harbor contributions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments.

In-service distributions are permissible for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested account balance.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits (continued)

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Forfeitures

The non-vested portion of terminated participant account balances can be used by the Company to pay administrative expenses under the Plan, and then to reduce future employer contributions. For the years ended December 31, 2024 and 2023, the balance of unallocated forfeitures was \$73 and \$34, respectively. For the year ended December 31, 2024, \$1 of forfeitures were used to reduce the amount of employer contributions.

NOTE 3 TAX STATUS

Effective for the period January 1, 2023 through September 30, 2024, the Company has adopted a prototype plan with ADP Retirement Services, which has received an opinion from the Internal Revenue Service ("IRS") dated October 6, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Effective for the period October 1, 2024 through December 31, 2024, the Company has adopted a prototype plan with Fidelity Management Trust Company, which has received an opinion from the IRS dated June 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. Both the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related Plan was tax exempt as of the financial statement date.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants will become fully vested in their account balances.

NOTE 6 FAIR VALUE MEASUREMENTS

Applicable GAAP for accounting for Fair Value Measurement and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 6 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation approaches used for assets measured at fair value.

Money market funds and mutual funds: Valued at the daily closing price as reported by the fund. These funds held by the Plan are an open-end fund that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued based on the NAV of units of a collective trust published by the trustee. The NAV is valued daily and is the basis for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
