Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed the audit of the financial statements of the 401(k) Plan for Secretarial Staff of Patterson Belknap Webb & Tyler LLP (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

NOTE 1: DESCRIPTION OF PLAN

The following description of the 401(k) Plan for Secretarial Staff of Patterson Belknap Webb & Tyler LLP (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was established to encourage savings on the part of secretarial staff members, certain non-secretarial staff members, associates and counsel of Patterson Belknap Webb & Tyler LLP (the "Firm") by affording them the opportunity to provide, through salary deductions, additional benefits at retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Firm's Employee Benefit Plans Committee has general responsibility for the administration and interpretation of the Plan. Vanguard Fiduciary Trust Company is the trustee and record keeper.

Contributions

Participants may elect to contribute from their before-tax annual includable compensation up to \$23,000 for 2024 and \$22,500 for 2023. Total annual contributions per participant to all plans of the Firm may not exceed the lesser of \$69,000 in 2024 (\$66,000 in 2023) or 100% of compensation, excluding catch-up contributions. Includable compensation is otherwise limited by the Internal Revenue Code (the "Code"). Certain rollovers to the Plan are also permitted and are included in the contribution amount. Additionally, in 2024 and 2023, participants aged fifty and over were permitted to contribute an additional \$7,500, as a catch-up contribution for a total of \$30,500 (\$30,000 in 2023) in employee before-tax contributions. All or a portion of those contributions could be made as "Roth" (after-tax) contributions. There are no employer contributions to the Plan.

Participant Accounts

Each participant's account is credited with (a) the participant's contributions, (b) allocations of Plan earnings and (c) certain fees and expenses. Allocations of earnings are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participation and Vesting

Secretarial staff members, associates and certain counsel to the Firm, as well as certain non-secretarial employees, who have attained age 21, are eligible to participate in the Plan beginning in the month after completing three months of service and are fully vested participants upon entry into the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A participant may borrow from his or her account an amount not to exceed \$50,000 and other limits based on the participant's account balances and outstanding loans, if any, from the Plan and other plans of the Firm. The terms of each loan are set in accordance with standards established by ERISA and the Plan agreement. The interest rate on participant loans is determined by the Plan's sponsor in a nondiscriminatory manner. The rate in 2024 and 2023 is a fixed rate equal to the prime rate plus 2%. Repayment of all loans under the Plan is secured by up to 50% of the participant's account balance in the Plan at the time of borrowing. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document and applicable law.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On termination of service for any reason a participant (or, following the death of a participant, their beneficiary) may elect to receive the value of the participant's interest in his or her account in the form of a lump sum.

Plan Termination

The Firm has the right to terminate, amend or modify the Plan at any time. In the event the Firm terminates the Plan, participants and beneficiaries would be entitled to receive the assets allocated to their respective accounts in the order provided for under applicable law.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Participants in the Plan are charged administrative expenses, distribution processing fees, and participants with outstanding notes receivable are charged loan fees.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE 3: INVESTMENTS – INFORMATION PREPARED AND CERTIFIED AS COMPLETE AND ACCURATE BY THE TRUSTEE

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard Fiduciary Trust Company, the trustee of the Plan, has certified the completeness and accuracy of all investments and related investment activity and notes receivable and related activity from participants in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4: INVESTMENTS AND FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, “Fair Value Measurements and Disclosures,” provides the framework for measuring fair value. That guidance provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual Funds (continued)

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

The Vanguard Cash Reserves Federal Money Market Fund may be subject to liquidating fees and temporary redemption suspensions to keep the fund value stable during market distress.

Collective Trust Fund

Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. The Plan invests in the Vanguard Retirement Savings Trust ("ST"), which invests solely in the Vanguard Retirement Savings Master Trust ("SMT"). The SMT invests primarily in a pool of investment contracts issued by insurance companies and commercial banks and in contracts that are backed by bond trusts. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of ST, the investment advisor reserves the right to temporarily delay withdrawal from the trust at times when the New York exchange is closed or during other emergency circumstances as defined by the trustee. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in ST at contract value, and the requests will be honored when received. ST contains several redemption restrictions to withdraw at contract value, including the right to require a 12-month advance notice period for fund withdrawals initiated by the Plan sponsor. As of December 31, 2024 and 2023, there were no unfunded commitments; the redemption frequency for participant transactions in ST is daily upon receipt of an authorized request on or prior to the valuation date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds and a common collective trust managed by an affiliate of Vanguard Fiduciary Trust Company, the trustee of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid by the Plan were \$25,315 for the year ended December 31, 2024.

NOTE 6: TAX STATUS

Effective January 1, 2022, the Plan adopted a Vanguard Fiduciary Trust Company Defined Contribution Volume Submitter Plan for which the Plan received a favorable determination letter dated September 9, 2022. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, credit, liquidity and market perception risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE 8: SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and determined that there were no subsequent events requiring disclosure or recognition in the financial statements.
