**Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Alliance Group Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As discussed in Note 1 to the financial statements, the Plan merged into NexCore 401(k) on January 15, 2025. As such, the Plan is no longer a going concern. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Notes to Financial Statements

For the Period January 1, 2025 to January 15, 2025 and the Year Ended December 31, 2024

#### (1) Description of Plan

The following description of the Alliance Group Services, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

- (a) General – The Plan was established March 29, 2010 as a defined contribution plan covering all eligible employees of Alliance Group, Inc. (the “Company”). Participants were eligible to enter the Plan and begin making salary deferrals on the first of the month after obtaining age 18 and completing three months of service. Nonresident aliens, members of a collective bargaining unit, and contracted and special project employees were not permitted to join the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Alliance Group, Inc was sold on February 28, 2023. The Company name was changed to Alliance Group Services, LLC, on March 1, 2023, and is a disregarded entity under the parent company, CHVAC Services Holding, LLC. The Plan name changed from Alliance Group, Inc. 401(k) Plan to Alliance Group Services, LLC 401(k) Plan on January 1, 2024.

The Plan was merged into NexCore 401(k) on January 15, 2025.

- (b) Employee Contributions – Participants could contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). Participants who had attained the age of 50 before the end of the year could contribute additional catch-up amounts as set by the IRS. Participants could also contribute amounts representing rollovers from other qualified plans.
- (c) Employer Contributions – The Company could make a safe harbor, matching and a profit sharing contribution. Employees were eligible to receive an employer contribution after obtaining age 18 and completing three months of service. The Company made a safe harbor contribution equal to 3% of the participant’s eligible compensation during 2025 and 2024.
- (d) Vesting – Participants were 100% vested in their salary deferrals and earnings thereon. Company matching, discretionary profit-sharing, and safe-harbor contributions were based on years of service. A participant earned a year of service for purposes of vesting if they are credited with 1,000 hours of service during the Plan year. A participant was 25% vested after 1 year of credited service, 50% vested after 2 years of credited service, 75% vested after 3 years of credited service, and 100% vested after 4 years of credited service.
- (e) Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant could elect to receive distributions equal to the value of the participant’s vested account balance in the form of a lump-sum. If a participant’s vested balance was less than \$5,000, excluding rollovers, it was mandatory that the benefits be distributed from the Plan as soon as administratively practical.

#### Description of Plan (continued)

Hardship distributions were permitted under the Plan. Participants could also take in-service distributions once they reached the age of 59 ½ and withdraw rollover contributions at any time.

- (f) Participant Accounts – Each participant's account was credited with the participant's contribution, allocations of the Company's contributions, and Plan earnings. Earnings were allocated to participant accounts based on account balances. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant determined the investment strategy of their account as provided by the Plan.
- (g) Forfeited Accounts – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures were used to reduce the Company's contributions or to reduce administrative plan expenses. Forfeitures of \$0 and \$57,346 were used to reduce Company contributions during 2025 and 2024, respectively. Available forfeitures at January 15, 2025 and December 31, 2024 were \$0.
- (h) Notes Receivable – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account and bear interest at the prime rate as specified in the Wall Street Journal, plus 1%. Principal and interest were paid ratably through payroll deductions.

#### (2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The financial statements of the Plan were prepared on the accrual basis of accounting.
- (b) Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (c) Investment Valuation and Income Recognition – The Plan's investments were stated at fair value while the fully benefit-responsive investment contracts were reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

#### Summary of Significant Accounting Policies (continued)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- (d) Benefit Payments – Benefits were recorded when paid.
- (e) Notes Receivable from Participants – Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.
- (f) Administrative Expenses – Certain investment and administrative expenses were charged to participant accounts. All other administrative expenses were generally paid by the Company.
- (g) Subsequent Events – The Plan has evaluated subsequent events through October 14, 2025, the date the Plan's financial statements were available to be issued.

#### (3) Information Certified by the Plan's Custodian

The Plan administrator had elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of the investments reflected on the accompanying statements of net assets available for plan benefits as of January 15, 2025 and December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the period January 1, 2025 to January 15, 2025 and for the year ended December 31, 2024.

#### (4) Investment Contract

The Plan had entered into a fully benefit-responsive guaranteed investment contract. The custodian maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

#### **Investment Contract (continued)**

Because the guaranteed investment income contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract was presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The Plan administrator did not believe that any events that would limit the Plan's ability to transact at contract value with plan participants were probable of occurring.

#### **(5) Fair Value Measurements**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds:* Valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds totaled \$0 and \$11,461,664 at January 15, 2025 and December 31, 2024, respectively, and were classified as Level 1.

The preceding method described may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

#### (6) Income Tax Status

The Plan was based on a prototype plan that received a favorable determination letter from the IRS dated March 31, 2014, indicating that the prototype plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC), and was, therefore, exempt from federal income taxes. Although the Plan had been amended since receiving the determination letter, the Plan administrator believed that the Plan was designed and currently being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

#### Income Tax Status (continued)

Accounting principles generally accepted in the United States of America required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator had analyzed the tax positions taken by the Plan, and had concluded that as of January 15, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan is no longer subject to income tax examinations for years before the year ended December 31, 2021.

#### (7) Related Parties

The Plan has a number of service providers. Such parties were considered parties-in-interest under ERISA.
