Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Genesis Healthcare, Inc. 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Genesis Healthcare, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

The following description of the Genesis Healthcare, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Genesis Healthcare, Inc. (the “Company”) who have three months of service and are at least 18 years old. Upon meeting the eligibility requirements, employees may begin participation quarterly. Starting in December 2024, Delaware Charter Guarantee & Trust Company doing business as Principal Trust Company (“Principal”) began serving as the Plan’s trustee and recordkeeper. Prior to December 2024, Ascensus LLC served as the Plan’s record keeper and Ascensus Trust Company served as the Plan’s custodian. The Board of Directors of the Company and the Plan Administrator have control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute a portion of their compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation. If an automatically enrolled participant does not choose to defer a different percentage, the percentage will automatically be increased the following January 1 by 1% up to a maximum of 3%.

The Company may elect to make a discretionary profit-sharing contribution based on a comparability formula. The comparability objective was to maximize the executive group, give the next highest percentage to the physicians and directors, and minimize all other participants to the same percentage. Participants must work 1,000 hours of service and be employed on the last day of the Plan year to receive the discretionary profit-sharing contribution. The Company also makes safe harbor contributions to the Plan. The safe harbor contribution is equal to 100% of a participant’s deferral contributions up to 3% of compensation and 50% of a participant’s deferral contributions greater than 3% but less than or equal to 5% of compensation. The Company also may make qualified nonelective contributions based on a pay formula (participant’s annual pay divided by the total annual pay of all participants receiving the contribution). In addition to being at least 18 years old and having three months of service, participants are eligible if they are an active participant on the last day of the year, have 1,000 or more hours of service during the year, and are a non-highly compensated employee. Contributions are subject to certain limitations.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds, a money market fund, and collective investment trusts as investment options for participants. Participants may change their investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions, and plan earnings (losses), and charged with benefit payments, transaction fees related to distributions, and an allocation of administrative expenses. Allocations are based on participant earnings or

account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion, if any, of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after six consecutive years of service with at least 1,000 hours of service each year or upon termination of employment due to death or disability.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or partial payment, as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5,600 and \$4,400. These accounts will be used to reduce the Company contributions and/or pay administrative expenses. During the year ended December 31, 2024, approximately \$4,500 in forfeitures were used to reduce Company contributions and none were used to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Change in Estimate

Due to the results of operations in 2024, the Company elected to make a \$250,000 discretionary profit-sharing contribution for 2023. As of December 31, 2023, the Plan recorded \$100,000 as employer contributions receivable in the statement of net assets available for benefits. The employer contributions on the statement of changes in net assets available for benefits for the year ended December 31, 2024 include an additional \$150,000 profit-sharing contribution as a result of this change.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and any matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses related to specific participant transactions are charged directly to the participant's account.

Note 3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds and money market fund

Mutual funds and the money market fund are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Collective investment trusts

These investments are valued at net asset value ("NAV") of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Note 5. Exempt Party-In-Interest Transactions

Certain Plan investments were managed by Ascensus Trust Company. Ascensus Trust Company was the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the custodian and third-party administrator by the Plan for administrative services were \$14,034 for the year ended December 31, 2024.

The Company serves as fiduciary to the Plan and all transactions between the Company and the Plan are considered exempt party-in-interest transactions. A total of \$22,521 of recordkeeping fees for the Plan were absorbed by the Company for the year ended December 31, 2024.

Note 6. Non-Exempt Party-In-Interest Transactions

There were unintentional delays by the Company in submitting participant contributions in the amount of \$64 to the custodian. These delinquent contributions constitute prohibited transactions. Subsequent to the year ended December 31, 2024, the late contributions and lost earnings were remitted.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 8. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the volume submitter plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
