**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The MD Group Retirement Plan and Trust an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The MD Group Retirement Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - DESCRIPTION OF THE PLAN**

**(a) General**

The following description of the The MD Group Retirement Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan became effective on March 1, 2003.

**(b) Plan Description**

The Plan is a defined contribution plan covering all employees of The MD Group (Company) and other affiliated companies who have six months of service and are age 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**(c) Contributions**

Participants may make salary reduction contributions on a pre-tax or post-tax basis up to the maximum allowable deferral that is set by law through payroll deductions to the Plan. The Company contributes 100% of first 3% and 50% of the second 2% of base compensation that a participant contributes to the Plan. The Company also has the option to make an elective profit sharing matching contribution to the Plan. Contributions are subject to certain limitations. At the discretion of the Plan administrator, a participant may make rollover contributions, transferring funds either directly or indirectly to the Plan from another qualified plan. Participants direct all contributions into the investment options of their choice.

The Plan currently offers various mutual funds and common/collective trusts as investment options for Plan participants.

**(d) Participant Accounts**

Each participant's account is credited with the participant contributions, an allocation of (1) the Company's contributions, (2) forfeitures of terminated participants' nonvested accounts, and (3) Plan earnings, and charged with an allocation of management expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations are based on participant earnings or account balances, as defined. The Plan allocates participant forfeitures of terminated participants' nonvested accounts as if the forfeitures were the Company's contribution. Before allocating forfeitures to participants, they will first be used to reduce any nonelective or matching contribution.

**(e) Vesting**

Participants are immediately vested in their voluntary contributions, rollover contributions, and earnings thereon. Vesting of the remainder of the participants' accounts is determined in accordance with the following schedules:

**(f) Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator.

**(g) Payment of Benefits**

Upon retirement or termination of employment, a participant may elect to receive their distribution in one of the following ways:

1. A lump-sum amount equal to the value of their account.
2. In periodic installments over the life expectancy of the participant or the joint life expectancies of the participant and the participant's designated beneficiary.

**(h) Forfeitures**

Forfeitures will be applied to reduce administrative expenses or reduce employer contributions. At December 31, 2024 and 2023, the Plan had \$0 and \$0, respectively, of forfeitures that had not been allocated. \$-0- of forfeitures were applied against administrative expenses during 2024. \$973 of forfeitures were applied against Company contributions during 2024.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**(a) Basis of Accounting**

The accompanying financial statements have been prepared under the accrual basis of accounting.

**(b) Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(c) Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**(d) Investment Valuation and Income Recognition**

Investments are reported at fair value, as reported to the Plan by Mid Atlantic Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value assessments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits are recorded when paid.

**NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

The 2024 and 2023, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Mid Atlantic Trust Company in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$22,661,739 and \$19,553,648 at December 31, 2024 and December 31, 2023, respectively and related net gains of \$2,987,876 for the year ended December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the period presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

**Level 1 Fair Value Measurements**

The Plan's valuation methodology used to measure the fair value of mutual funds was derived from quoted market prices of active markets.

Valued at the daily closing price as reported by the fund, mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Level 2 Fair Value Measurements**

The fair value of common/collective trusts are valued using the net asset value (NAV) of units held by the Plan at year-end as provided by Mid Atlantic Trust Company.

The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee. The investment management fee is deducted prior to setting the daily unit value.

The investment contracts are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in charges in net assets available for benefits for the year ended December 31, 2024 is reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Level 1 and 2 and no transfers into or out of Level 3.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated April 10, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 - ADMINISTRATIVE EXPENSE**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses of maintaining the Plan are paid by the Company and are therefore excluded from the financial statements.

**NOTE 9 - PARTY IN INTEREST**

The Plan's investments were managed by Mid Atlantic Trust Company. Mid Atlantic Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund.

Plan investments are shares of mutual funds and common/collect trusts managed by Mid Atlantic Trust Company. Purchases and sales of these funds are performed in the open market at fair value and qualify as party in interest transactions under ERISA regulations.

Record keeper and contract administration fees paid by the Plan to Mid Atlantic Trust Company and Paychex, Inc. amounted to \$20,564 for the year ended December 31, 2024.

Investment Advisor fees paid by the Plan to 401(k) Investment Professionals, Inc. amounted to \$74,397 for the year ended December 31, 2024.

Contract administration fees paid by the Plan to ERISA Fiduciary Services, Inc. amounted to \$5,675.

These transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

**NOTE 10 - DATE OF MANAGEMENT'S REVIEW**

Subsequent events were evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

On January 1, 2025 the Plan moved all investments to Vanguard Trust Company.
