Note 1—Description of the Plan

The following description of the Profile Extrusion Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – Profile Extrusion Company is a wholly owned subsidiary of GPI, Incorporated (the "Plan Sponsor"). The Plan was established on October 1, 1999 by the Plan Sponsor and was most recently amended and restated effective January 1, 2022. The Plan is a defined contribution plan covering all eligible employees of GPI, Incorporated and adopting subsidiaries (collectively, the "Company"), except leased employees, temporary employees or those covered by a collective bargaining agreement. Employees are eligible to participate in the Plan upon attainment of age eighteen and completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Participant Contributions – Each year, participants may elect to contribute up to 50% of their annual eligible compensation, as defined in the Plan document, not to exceed the maximum amount allowable by the Internal Revenue Code ("IRC"). Participants may defer on both a pre-tax and an after-tax Roth basis. The Plan provides for automatic enrollment of eligible employees at a deferral rate of 3% of eligible compensation, unless the participant affirmatively elects otherwise. The Plan also provides for a 1% annual increase in the deferral rate (up to a maximum of 6% of eligible compensation).

Employer Contributions – The Company contributes a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of eligible compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation. The Company may also make additional discretionary contributions to the Plan. There were no additional discretionary contributions for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Contributions are subject to certain limitations.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and employer safe harbor matching contributions, and an allocation of employer discretionary contributions (if any), and Plan earnings thereon. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, specifically participant transactions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – Upon enrollment in the Plan, participants may direct the investment of their accounts into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the Plan year.

Vesting – Participants are immediately vested in their voluntary contributions and Company safe harbor matching contributions, plus actual earnings thereon. Vesting in employer discretionary contributions is based on years of continuous service. A participant becomes 100% vested after three years of credited service.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. Generally, the term of the loan may not exceed five years. However, if the loan is for the purchase of a participant's principal residence, the Plan administrator may permit a longer term. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. At December 31, 2024, interest rates on the notes receivable from participants ranged from 5.25% to 10.50%. Principal and interest are repaid ratably through payroll deductions.

Benefits Paid to Participants – Upon termination of service or attaining normal retirement age, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments not exceeding the participant's life expectancy. In-service and hardship withdrawals are also allowed as defined in the Plan document.

In the event of a financial hardship, the Plan allows the withdrawal of elective deferrals. The Plan does not permit the withdrawal of any safe harbor matching or employer discretionary contributions. To provide a hardship withdrawal under current Internal Revenue Service ("IRS") rules, the employee must provide evidence of immediate financial hardship. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeitures – The non-vested portion of former participants' accounts may be used to pay administrative expenses of the Plan or to reduce the amount of future employer contributions. Forfeited accounts and related activity was inconsequential as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Administrative Expenses – Certain expenses of the Plan are paid by the Plan Sponsor and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Benefits Paid to Participants – Benefits paid to participants are recorded when paid.

Risk and Uncertainties – The Plan provides for various investment options in funds of stocks, bonds, and fixed-income securities. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Fair Value Measurement – U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three Levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds – These investments are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are therefore classified within Level 1 of the valuation hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fully Benefit-Responsive Investment Contract – The Plan holds a fully benefit-responsive investment contract with Standard Insurance Company ("Standard"). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract ("GIC") is included in the financial statements at contract value as reported to the Plan by Standard. Because the Standard GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the Standard GIC. Contract value represents contributions made under the contract, plus earnings thereon, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate is based on a formula established by Standard but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with Standard. Such events include the following: (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation, (6) partial or total Plan termination, (7) retirement incentive programs, and (8) the liberalization of Plan withdrawal or transfer rules. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) failure to abide by state or federal law, (2) failure to render performance necessary to comply with the terms of the contract, (3) failure to maintain assets of at least \$25,000, (4) Plan disqualification, and (5) failure to adopt the Plan in a reasonable period of time.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified to the completeness and accuracy of the following data included in the accompany financial statements and supplemental schedule.

Note 5—Parties-in-interest transactions

Certain Plan assets are invested in funds sponsored by the qualified institution. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL Regulations. For the year ended December 31, 2024, fees paid by the Plan to the qualified institution totaled \$11,883 and fees paid to investment advisors that would also qualify as party-in-interest transactions totaled \$3,884. These fees are included in administrative expenses on the accompanying statement of changes in net assets available for benefits. Notes receivables from participants also qualify as party-in-interest transactions.

Note 6—Income tax status

The Plan Sponsor utilizes a Pre-Approved Defined Contribution Plan which received a favorable opinion letter from IRS on June 30, 2020, which stated that the Pre-Approved Defined Contribution Plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Pre-Approved Defined Contribution Plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of IRC. Therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. The Plan Sponsor believes the Plan has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
